Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of DIAB Americas LP Employees Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (continued)

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) at December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of DIAB Americas LP Employees Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1987, as a defined contribution plan covering all employees of DIAB Americas LP (the "Company" or "Sponsor") who are age 19 or older, excluding collectively bargained employees and non-resident aliens. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Company is the Plan Sponsor and Plan Administrator. The Company is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance. On October 15, 2021, the Plan amended its plan document to reflect the current provisions and requirements.

Eligibility

Any employee who is nineteen (19) years of age is eligible to become a participant in the Plan on the first day of the Plan quarter coinciding with or the next following date he or she completes 6 (six) consecutive months of service.

Entry Dates

March 1, June 1, September 1 and December 1

Employee Salary Reduction Election

A participant may elect to defer up to 1% to 100% of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code ("IRC") Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

Contributions

Elective Contributions

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The Company must pay elective contributions to the Plan's trustee as soon as they can be segregated from its general assets, but no later than the fifteenth (15th) business day after the month of receipt of the voluntary contribution. There are two types of elective deferrals for the Plan: pre-tax deferrals and Roth deferrals.

Contributions (continued)

Employer Matching Contributions

The Company may make a discretionary matching contribution in an amount to be determined by the Company. The Employer may determine a separate discretionary matching contribution for participants working in different business units or locations. This matching contribution are not immediately fully vested and are subjected to a 6-year graded vesting schedule described below under Vesting section.

Profit Sharing Contributions

The Company may make a discretionary matching contribution in an amount to be determined by the Company. The Employer may determine a separate discretionary matching contribution for participants working in different business units or locations. The employer nonelective contributions are not immediately fully vested and are subjected to a 6-year graded vesting schedule described below under Vesting section.

Rollover Contributions

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless of whether such employee has met the age and service requirements of the Plan.

Catch-Up Contributions

You may defer up to an extra \$6,500 if you are age 50 or older before the end of the calendar year and once you meet certain Plan limits. The maximum catch-up amount will increase as the cost-of-living increases.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their elective contributions plus actual earnings thereon. Vesting in the employer nonelective contributions portion of their accounts plus earnings thereon is based on years of continuous services. The vesting for the Company account is as follows:

Contributions (continued)

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeiture balances available. During 2024, no forfeitures were used to offset employer contributions or reduce Plan expenses.

Distribution of Benefits

Upon Retirement

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Payment may be in the form of a lump-sum distribution or partial withdraw.

Upon Termination of Employment

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. If the value of the vested account balance does not exceed \$1,000, then a distribution will be made in cash. However, if the value of the vested account balance is more than \$1,000 but less than \$5,000, he or she may elect to receive distribution in cash or to roll over to an IRA or a qualified plan of his or her new employer.

Hardship Distributions

A participant may withdraw pre-tax deferrals, including any earnings, in the event of a financial hardship, provided certain conditions are met. The minimum withdrawal amount is \$1,000. Hardship distributions can only be made from the vested portion of the matching contribution and profit-sharing contribution accounts.

Upon Disability

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

Upon Death

Upon the death of a participant, a distribution of the remaining balance be made to his or her designated beneficiary. The beneficiary will generally have the same options regarding the form of the distribution that is available to as a Participant.

Administrative Fees

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for the purpose of determining the earnings or losses on their investment options.

Notes Receivable from Participants

Participants may borrow from his or her account with a maximum loan amount not to exceed the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period or (b) one-half ($\frac{1}{2}$) of a participant's vested account balance. A participant may only have two (2) loans outstanding at any time. Principal and interest are repaid by payroll deductions from each regular paycheck. Loans are secured by the balance in the participant's account and bear an interest rate currently being charged on similar commercial loans by persons in the business of lending money.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value with the exception of the group annuity contract, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

Benefit payments to participants are recorded upon paid.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds

Share Prices/Net Asset Values (NAVs) reported on the financial statements for NAV mutual funds are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source, such as Interactive Data Corporation (IDC).

4. Information Prepared and Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company and Newport Trust Company, LLC (“Ascensus”), a qualified institution, has certified the following investments and notes receivable information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and participant loans information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Investment Contract

This guaranteed investment contract (GIC) is considered a fully benefit-responsive investment contract (FBRIC) and should be reflected at contract value within net assets available for benefits (see ASC 962-10, "Plan Accounting - Defined Contribution Pension Plans" on what defines a FBRIC). ASU 2015-12 states that FBRICs should be measured, presented, and disclosed only at contract value and fair value information is not required. All GICs that are deemed benefit-responsive investment contracts should no longer be included in ASC 820 fair value disclosures. Investment contract balances at December 31, 2024 and 2023 were \$533,548 and \$525,182, respectively.

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Goldman Sachs Trust Company ("Goldman Sachs"). Goldman Sachs maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. Crediting rates for contracts are influenced by a number of factors including: (1) the current yield of the underlying assets in the contract, which may not reflect prevailing interest rates, (2) the duration of the underlying assets covered by the contract, (3) whether the market value of the underlying assets increases or decreases, through investment performance, market conditions or otherwise, (4) the existing difference between the market value of the underlying assets and contract value and (5) the contract fees and certain other expenses incurred that are paid from the underlying assets. The average crediting rate was 3.10% for 2024 and 2.52% for 2023, respectively. The crediting rate is reviewed on a monthly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related-Party Transactions and Party in Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$18,200 of recordkeeping fees to Ascensus, and \$21,927 of advisory fees to Merrill Lynch & Co., Inc. during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

10. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Subsequent Events

During 2025, the Plan Sponsor identified errors in the deferral contributions withheld from payroll for the years 2024 and 2023. As a result, the Plan is expected to receive additional participant and employer contributions to correct the miscalculations. The amount of these corrective contributions represents a contingent gain, which cannot be reasonably estimated as of the date of this report.

12. Date of Management's Review

The Plan has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.




