Opinion

Note 1 - Plan Description

The following description of EssilorLuxottica Puerto Rico Retirement Savings Plan 3 (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, qualified under Section 1165(e) of the Puerto Rico Internal Revenue Code. The Plan is sponsored by EssilorLuxottica USA, Inc. (the "Company"). The Plan was established effective July 30, 1995 and amended effective January 1, 2006 to provide a retirement savings opportunity for the Puerto Rico-based employees of LensCrafters International, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The EssilorLuxottica ERISA committee controls and manages the operation and administration of the Plan.

Eligibility

Employees are eligible to participate in the Plan for the purpose of making salary deferral contributions as soon as administratively practical. Employees are eligible to participate in the Plan for the purpose of receiving company matching contributions after reaching age 21, meeting certain hours of service, and other requirements, as defined.

Contributions

Participants may contribute a percentage of their compensation annually, subject to certain limitations, as defined by the Plan and Puerto Rican law.

The Company makes matching contributions on a quarterly basis. During 2024, the Company matched 100 percent of the first 6 percent of eligible compensation.

Participants may also contribute amounts representing qualified rollover distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of plan earnings (losses). Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds, common collective trust funds, and a money market fund as investment options for participants.

Fidelity Workplace Services, LLC (Fidelity), the recordkeeper, receives the contributions detail from Banco Popular de Puerto Rico (the "Trustee"), invests the contributions, and distributes the funds in accordance with the trust agreement and the participants' authorization.

Vesting

Participants are immediately vested in their salary deferral contributions and the earnings thereon. Vesting in employer matching contributions is based on years of service. For employer matching contributions made before January 1, 2023, participants vest 25 percent after two years of vesting service and gain an incremental 25 percent each subsequent year, reaching full vesting at the end of five years of vested service. Participants are immediately vested in any employer matching contributions made on or after January 1, 2023.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants are eligible to borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the vested value of their accounts. Participants cannot have more than two notes outstanding at the same time. The notes are secured by the balance in the participant's account and bear interest based on local prevailing rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed 5 years, with the exception of mortgage loans, which may be repaid over 15 years.

Subject to approval by the plan administrator and after applying for a participant note, participants may apply for hardship withdrawals, as defined. No hardship withdrawals may be made from company contributions.

Benefit Payments

Upon termination of service for any reason, a participant may elect a lump-sum distribution or direct rollover to another qualified benefit plan or individual retirement account, equal to the value of the participant's vested interest in his or her account, less applicable withholding tax if paid to the individual.

Forfeitures

Company contributions forfeited by participants may be used by the Company to satisfy plan administrative expenses or to reduce future company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,885 and \$2,972, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment securities, including mutual funds, common collective trust funds, and a money market fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan and the Company, as provided in the plan document.

Administrative expenses of approximately \$68,000 for the year ended December 31, 2024 were paid by the Company.

Benefit Payments

Benefits to participants are recorded when paid.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 3 - Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Interest-bearing Cash

The fair value is based on the outstanding balance, as reported by the Trustee.

The proceeding methods described may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Exempt Party-in-interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity or its affiliates. Fidelity is the recordkeeper, as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Note 5 - Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100 percent vested in their accounts.

Note 6 - Tax Status

The Plan is exempt from Puerto Rico income taxes under the provisions of Section 165(a) of the Puerto Rico Income Tax Act of 1954 (the "Code"), as amended. The Plan is also a qualified employees' trust under Section 401(a) of the Internal Revenue Code (IRC) and, as such, is exempt from federal income taxes under Section 501(a). A determination letter was received from the Puerto Rico Department of Treasury dated April 18, 2016 stating that the Plan is designed in accordance with applicable sections of the Code.
