## INDEPENDENT AUDITORS' REPORT

To the Trustees of  
Link Homecare, LLC Retirement Plan and Trust

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Link Homecare, LLC Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Link Homecare, LLC Retirement Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

1. **DESCRIPTION OF PLAN:** The following description of the Link Homecare, LLC Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a noncontributory defined contribution profit-sharing plan that was established on January 1, 2021, to provide benefits to eligible employees of Link Homecare, LLC (the Company) except for union employees or highly compensated employees. Employees enter the Plan immediately upon being hired. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

### ***Employer Contributions***

From time to time, the Company contributes a discretionary profit-sharing contribution to the Plan using the grouping method. Under this method, an employee is assigned to a group based on compensation and hours worked for that period. The Company assigns a profit-sharing amount to each group, which is then divided equally amongst all of the group's participants. Employee contributions are not permitted under the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is allocated a portion of: (a) the Company's profit-sharing employer contributions, (b) investment earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are vested immediately on all contributions plus actual earnings thereon.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or other reasons, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount directly to them or, at their election, the amount can be rolled over to another qualified retirement plan or an individual retirement plan. Participants may receive an in-service withdrawal of their vested account balance subject to IRS tax withholdings.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Expenses***

Substantially all of the administrative expenses are paid by the Plan and allocated to each participant. Expenses paid by the Company are excluded from these financial statements.

### ***Subsequent Events***

The Plan has evaluated subsequent events through September 26, 2025, the date which the financial statements were available to be issued.

## 3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Registered Investment Companies* are held and administered by Nationwide Trust Company (Nationwide), and consist of publicly traded mutual funds or money market accounts, which are valued daily based on the publicly available market price using a unit of value method. Transactions are recorded as purchased or sold based on that day's market price. Values are adjusted as of the date the underlying publicly traded investment adjusts its value for dividends, interest, gains and losses, etc. The unit of account concept allows fees to be allocated to the individual accounts. This unit value is Nationwide's method for valuing accounts and is not the same as the net asset value reported by the fund house; however, the financial trend should be the same.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.  The Fixed Select Account is credited with declared rates of interest and is subject to a minimum interest rate described in the contract. The credit rate is communicated to the Plan and credited daily. Amounts allocated to the Fixed Select Account are held in the Nationwide general account, which supports insurance and annuity obligations. Nationwide's general account is managed on an aggregate basis and supports their financial commitments. No portion or ownership of assets of the general account is attributable to a particular plan.  The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. **6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:**

Certain plan investments are shares of mutual funds managed by the trustee of the Plan, Nationwide, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

**7. PLAN TERMINATION:**

Effective August 28, 2025, the plan trustees, as permitted by the plan document, made the decisions to terminate the Plan subject to the provisions of ERISA. The remaining assets will be applied in full to the Plan's benefit obligations and subsequent professional and administrative fees related to the termination of the Plan. The Plan is intended to be liquidated on October 23, 2025.

**8. TAX STATUS:**

The Plan is structured and follows a non-standardized profit-sharing 401(k) plan, pre-approved by the IRS. The IRS issued an opinion letter dated June 30, 2020, that the non-standardized pre-approved plan is acceptable in accordance with applicable sections of the Internal Revenue Code. Although the Plan may be amended subsequent to receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan was designed and will be operated in compliance with the applicable requirements of the Internal Revenue Code, and

therefore believe that the Plan is qualified, and the related trust will continue to be tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND  
UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
