Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Teradyne, Inc. Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the Teradyne, Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Teradyne, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (the “Code”) and is administered by a fiduciary committee appointed by the Company’s Board of Directors.

Eligibility

Employees working 20 or more hours weekly become eligible to participate upon employment, except for leased employees, employees covered by a collective bargaining agreement, employees employed outside the United States, non-resident aliens, interns, co-op students, and temporary workers.

Participant Contributions

Each year, participants may contribute between 1% and 50% of compensation, as defined in the Plan, subject to certain limitations. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants may direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Plan provides for all company contributions to be discretionary and to be determined annually. For 2024 and 2023, the match was as follows:

- Participants accruing a benefit in the Retirement Plan for Employees of Teradyne, Inc. were not eligible to receive a discretionary matching contribution.
- Participants no longer accruing a benefit in the Retirement Plan for Employees of Teradyne, Inc. or who were hired on or after November 1, 1999, were eligible to receive a dollar-for-dollar discretionary matching contribution. In 2024 and 2023, the Company matched eligible employee contributions up to 4% of eligible pay.

For years when a matching contribution is available, the Company will match employee contributions to the Plan at the end of the year, provided the participant is employed by the Company on that date. If the participant leaves the Company before the last day of the plan year due to retirement, disability, lay off, or death, the participant will receive the discretionary matching contributions, if any, on any contributions the participant made during the year.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Participants become 100% vested in the balance of their accounts upon attainment of age 65, death, or disability, as defined in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and allocation of plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his/her account in a lump-sum amount or in equal periodic payments over a period of up to 15 years. For termination of service for other reasons, a participant may receive the value of the vested interest in his/her account as a lump-sum distribution.

Distributions may also be made for in-service distributions and hardship. An in-service distribution is allowed if an active participant has reached the age of 59½ and submits a written application to withdraw all or a portion of their account. Hardship withdrawals are allowed if certain criteria are met, as defined in the Plan.

Benefits are recorded when paid.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with the prime rate of interest at the time the loan is issued. Principal and interest must be repaid over a period of up to five years by means of payroll deduction. In certain cases, the repayment period may be extended up to 15 years if the loan is for the purchase of a primary residence.

Participant notes receivable are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

The Plan is responsible for paying all expenses incurred in the administration of the Plan, except to the extent such expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Forfeitures

Forfeitures (unvested portion of terminated employees' shares of the Company's contribution) serve to reduce the Company's future contributions and to pay plan expenses. At December 31, 2024, forfeiture account totaled \$ 262,336, \$ 250,000 of which was used in 2025 to reduce the 2024 employer match contribution. At December 31, 2023, forfeited accounts totaled \$214,113, \$200,000 of which was used in 2024 to reduce the 2023 employer match contribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

The Plan evaluated all events and transactions that occurred after December 31, 2024, through October 1, 2025, the date these financial statements were available to be issued.

3. Certified Investments

The plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and

2023, the supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2024 and 2023.

Common/collective trusts ("CCTs") are valued at the net asset value ("NAV") of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV.

The self-directed brokerage accounts consist primarily of common stocks, mutual funds, and money market funds, which are stated at fair value, based on quoted market prices.

Shares held in the mutual fund are traded on national securities exchanges and valued at NAV as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

While the Company has not expressed any intent to discontinue its contributions or terminate the Plan, it is free to do so at any time, subject to the restrictions set forth in ERISA. In the event such discontinuance results in the termination of the Plan, participants will become 100% vested in their accounts, and the net assets of the Plan will be distributed or allocated among the participants and beneficiaries of the Plan as provided for in the plan agreement.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 3, 2016, that the Plan is designed in accordance with applicable sections of the Code. The Plan's administrator believes that the Plan is currently designed and being operated in compliance with the Code and that the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

8. Related Party and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Investments. Fidelity Investments is a related party to the trustee, Fidelity Management Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Company who participate in the Plan, perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants also qualify as party-in-interest transactions.
