Notes to Financial Statements
As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

1. Description of Plan

The following brief description of the ILC Dover 401(k) Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established on April 1, 2011 and covers all eligible employees of New ILC Dover, Inc. (the "Company") and related participating employers. The Company is wholly owned by Astronaut Guarantor, LP. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Executive Committee is responsible for oversight of the Plan. The Investment Advisory Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Executive Committee. The Plan was most recently amended and restated effective June 30, 2021. Vanguard Fiduciary Trust Company is the trustee of the Plan.

In March 2024, Ingersoll Rand announced a deal to acquire ILC Dover in a transaction that closed on June 3, 2024. Effective December 31, 2024, the Plan was amended to freeze further participation and contributions (see Note 9). Upon the Plan freeze, no further deferrals or contributions will be made to the Plan on behalf of any Plan participants attributable to any period after December 31, 2024.

Eligibility

Collectively bargained employees, non-resident aliens who receive no compensation from the Company which constitutes U.S. source income, leased employees, and temporary employees are not eligible to participate in the Plan. Eligible employees may enter the Plan immediately. Salary deferral eligibility requirements have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement ("SECURE") Act of 2019 and the SECURE 2.0 Act of 2022.

Contributions

Each year, participants may contribute up to 75% of annual eligible compensation, as defined in the Plan document. Participants may designate contributions as pre-tax, Roth or after-tax contributions (which are limited to 25% of annual eligible compensation). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The Plan also provides for an annual automatic escalation provision of 1% up to 15% of eligible compensation for all participants who enter the Plan after the automatic deferral provisions were effective, unless they elect otherwise.

The Company may elect to make a discretionary employer matching contribution to the Plan based on a discretionary percentage of compensation that a participant contributes to the Plan, excluding catch up contributions and after-tax contributions. For the year ended December 31, 2024, the discretionary employer matching contribution was 50% up to 6% of the participant's elective deferral contributions on a per payroll basis for New ILC Dover, Inc. For the year ended December 31, 2024, the discretionary employer matching contribution was 100% on the first 3% of the participant's elective deferral contributions and an additional 50% on the next 2% of elective deferrals on a per payroll basis for Flexan, LLC.

Contributions are subject to certain Internal Revenue Code ("IRC") limits. Participants direct the investment of their deferral contributions and employer contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and discretionary employer matching contributions, if any, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their own contributions plus actual earnings thereon. Effective January 1, 2018, participants are immediately vested in discretionary employer matching contributions. This amendment is applied prospectively and would not impact participants who were terminated prior to January 1, 2018. Prior to January 1, 2018, vesting in the discretionary employer matching contribution portion of their accounts was based on years of continuous service and a participant was 100% vested after two years of credited service.

Notes Receivable from Participants

Eligible participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The repayment of the loan generally shall not exceed 5 years. If the loan is for a primary residence, the repayment of the loan shall not exceed 30 years. The loan interest rate is set at a rate that is commensurate with local prevailing rates. Interest rates on loans outstanding as of December 31, 2024 range from 4.25% to 9.50%. Repayments of principal and interest are made through payroll deductions. A participant may have only two loans outstanding at any given time.

Benefit Payments

Upon termination of service due to death, disability, retirement (age 65), or for other reasons, a participant may receive a lump sum amount equal to the value of the participant's vested interest. Installment distributions and partial lump sums are also permitted. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022) upon termination, the Plan administrator may authorize the benefit payment without the participant's consent. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In circumstances when a terminated participant has a vested account balance greater than \$1,000 but less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

Under terms of the Plan, participants are eligible for in-service benefit payments upon reaching age 59.5. Hardship distributions are also permitted from participant accounts, based on the terms of the Plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the discretionary matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds (registered investment companies), common collective trusts, pooled separate account, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV or equivalent based on units of the common collective trusts. The NAV, as provided by the trustee of the common collective trusts, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common collective trusts less its liabilities. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV.

Pooled separate account: The Plan invests in the New York Life Insurance Company Anchor Account (“NYL AA”), which is a pooled separate account issued by New York Life Insurance Company. The NYL AA has been valued at the net asset value or equivalent based on units of the pooled separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its common collective trusts and pooled separate account.

The Plan's investment options include common collective trusts whose investment strategies are similar to equity style funds. The objectives of the common collective trusts invested in equity investments is to approximate the risk and return characterized by various indices; to seek long term capital appreciation; provide diversified exposure representative of various segments of the U.S. or foreign equity market; and/or to seek income.

These common collective trusts are redeemable at NAV under agreements with the underlying common collective trusts. However, it is possible that these redemption rights may be restricted by the common collective trusts in the future in accordance with underlying common collective trust agreements. Due to the nature of the investments held by the common collective trusts, changes in market conditions and the economic environment may significantly impact the NAV of the common collective trusts, and consequently, the fair value of the Plan's

interest in the common collective trusts. Furthermore, changes in the liquidity provisions of the common collective trusts may significantly impact the fair value of the Plan's interest in the common collective trusts.

The Plan, through a participating group annuity contract, invests in the NYL AA, which is a pooled separate account sponsored by New York Life Insurance Company. The NYL AA seeks to provide a low-risk stable investment option. Participants may ordinarily deposit and withdraw on a daily basis. No direct transfers from the NYL AA to a competing fund are allowed. The NYL AA is generally redeemable at net asset value. However, it is possible that these redemption rights may be restricted in the future in accordance with underlying agreements. Due to the nature of the investments held by the NYL AA, changes in market conditions and the economic environment may significantly impact the net asset value of the NYL AA, and consequently, the fair value of the Plan's interest in the NYL AA. Furthermore, changes in the liquidity provisions of the NYL AA may significantly impact the fair value of the Plan's interest in the NYL AA. If the Plan does not provide twelve months written notice of an intent to exit the NYL AA, the Plan's balance in the NYL AA may be subject to a market value adjustment.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions for which they were not already fully vested.

6. Tax Status

Effective June 30, 2021, through the adoption of a Vanguard Group non-standardized defined contribution pre-approved plan, the Plan was amended and restated. The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related-Party and Party-In-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by affiliates of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the recordkeeper and trustee of the Plan's investments, and administrative fees charged by Vanguard Fiduciary Trust Company that are paid from Plan assets qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. The Plan paid \$122,463 in fees in 2024 to Vanguard Fiduciary Trust Company for services provided to the Plan. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

During 2023, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling \$473,502 within the period prescribed by the Department of Labor regulations. During 2024, the Company made contributions to the affected participants' accounts to make the participants whole and compensate those participants for potential lost income due to the 2023 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and has taken action prescribed by the regulations to remedy such errors.

During 2024, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling \$166,897 within the period prescribed by the Department of Labor regulations. During 2025, the Company made contributions to the affected participants' accounts to make the participants whole and compensate those participants for potential lost income due to the 2024 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and has taken action prescribed by the regulations to remedy such errors.

9. Plan Amendments

Effective January 1, 2024, the Plan was amended to include ILC Astrospace, LLC as a participating employer and to make general administrative changes.

Effective December 31, 2024, the Plan was amended to freeze further participation and contributions. Upon the Plan freeze, no further deferrals or contributions will be made to the Plan on behalf of any Plan participants attributable to any period after December 31, 2024.

10. Subsequent Events

During 2025, the Plan merged with and into the Ingersoll Rand Retirement Savings Plan. In connection with the merger, effective April 9, 2025, the Vanguard service agreement was terminated.

The merger into Ingersoll Rand Retirement Savings Plan initiated a "Black Out" period beginning April 4, 2025 and continued through the week of April 14, 2025. During this period, participants' plan accounts were not available for investment fund exchanges, loan requests, and distribution requests. During the Black Out period, funds were transferred to the Ingersoll Rand Retirement Savings Plan and were invested in a target date fund based on the age of the respective participant.

Management evaluated subsequent events for the Plan through October 2, 2025, the date the financial statements were available to be issued.
