### **Note 1: Description of Plan**

#### ***General***

The following description of First Dakota Financial Corporation 401(k) Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by First Dakota Financial Corporation and its related employers (Company) for the benefit of its employees who are eligible to join the Plan. Employees are eligible when they are a covered employee and are age 20 or older. Covered employee is defined as a common law employee of the Company who are not an independent contractor, are not a leased employee, are not a resident of Puerto Rico and are not a contract employee or have intern employment status.

Employees may make contributions to the Plan and receive Employer Contributions beginning on the applicable entry date coinciding with or immediately following the date they meet the applicable eligibility requirements. The applicable entry dates are: daily for your contributions to the Plan, the first day of the month and six months of service for Nonelective Contributions the Employer makes to the Plan and Matching Contributions the Employer makes to the Plan. Related employers who also participate in the Plan include First Dakota National Bank, First Dakota Brokerage Services, Inc., and First Dakota Insurance Agency, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). T. Rowe Price Trust Company is the trustee of the Plan.

#### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual pre-tax, Roth, and after-tax contributions of up to 75% of eligible compensation and 100% of bonuses. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Company matching and profit sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations. Forfeitures are used to reduce Company contributions.

#### ***Participant Investment Account Options***

Each participant has the option of directing his contributions into any of the various investment options offered by the Plan and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after 5 years of credited service.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### ***Forfeited Accounts***

Forfeited nonvested accounts are used to reduce Company contributions. Employer contributions were reduced by \$80,400 and \$5,332, from forfeited nonvested accounts in 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, there were no remaining forfeited nonvested accounts.

## **Note 2: Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Plan Tax Status***

The Plan operates under a volume submitter adoption agreement sponsored by T. Rowe Price. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained a requested determination letter. However, the Plan Administration believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing securities and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. There were no securities classified within Level 2 or Level 3 of the hierarchy.

### Note 5: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan Sponsor directly pays any other fees related to the Plan's operations.

The Company provided certain administrative services at no cost to the Plan during 2024 and 2023.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 7: Risks and Uncertainties**

#### ***Investments***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8: Subsequent Events**

Effective January 1, 2025, the Plan has been amended and restated to eliminate the six-month waiting period for participants to become eligible for matching and nonelective contributions. Additionally, as of January 1, 2025, the Plan requires that covered employees must be employed on the final day of the plan year in order to qualify for the employer true-up match and the nonelective contribution.

Subsequent events have been evaluated through September 30th, 2025, which is the date the financial statements were available to be issued.
