### *NOTE 1 - PLAN DESCRIPTION*

The following description of the LECS, Ltd. 401(k) Plan (“the Plan”) provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **GENERAL**

The Plan was adopted effective January 1, 2018, to establish a savings and investment plan for the exclusive benefit of the employees of LECS, Ltd. (the “Employer”, “Company”, or “Plan administrator”). The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Matrix Trust Company serves as the Plan’s asset custodian and trustee. Employee Fiduciary LLC serves as recordkeeper of the Plan. TFO-TDC, LLC is the investment advisor for the Plan.

#### **ELIGIBILITY**

Employees aged 21 or older who have completed 3 months of service are eligible to contribute to the Plan, as allowed under Section 401(k) of the Internal Revenue Code (“IRC”). Entry dates for the plan is the first day of the first and seventh month of the plan year.

#### **CONTRIBUTIONS**

Participants may elect to have a portion of their annual compensation contributed to the Plan as a pre-tax deferral, as defined by the Plan. A participant’s combined elective deferrals are limited by federal income tax laws to \$23,000 and \$22,500 (\$30,500 and \$30,000 for participants who have attained age 50 by the end of the calendar year) in 2024 and 2023, subject to certain non-discrimination tests for excess deferral contributions. These limitations are adjusted periodically to reflect cost-of-living increases.

The Company makes safe harbor matching contributions on behalf of each participant for 100% of the participant’s contributions up to 3% and 50% of the amount of participant’s contribution that exceeds 3% of the participant’s compensation but that does not exceed 5% of the participant’s compensation. For the years ended December 31, 2024 and 2023 the Company accrued matching contributions totaling \$266,960 and \$260,716, respectively.

#### **VESTING**

Participants are immediately vested in their elective contributions plus earnings thereon. Employer safe harbor matching contributions (plus earnings thereon) are also immediately vested.

### **PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's elective contributions and allocations of (a) the employer's safe harbor matching contribution and (b) earnings and losses of the participant's investment selections. Allocations are based on participant earnings or account balances, as defined. Each participant directs the investment of his or her account into any of the investment options designated by the Plan administrator. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **PAYMENT OF BENEFITS**

Upon termination of service, distributions will be made to eligible participants from their vested interest in their account as soon as reasonably practicable following the date the participant's application for distributions is received by the administrator.

### **ADMINISTRATION EXPENSES**

The Plan is administered by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and withdrawals are charged directly to the participant's account and are included in administrative expenses.

### **PLAN TERMINATION**

Although the Employer has not expressed any intent to do so, it may terminate the Plan at any time, subject to the terms of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

## *NOTE 2 – BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES*

### **BASIS OF PRESENTATION**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### PAYMENT OF BENEFITS

Benefits are recorded when paid.

### USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### RISKS AND UNCERTAINTIES

The Plan provides for several investment options which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

### UNCERTAIN TAX POSITIONS

The provisions of Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 740 *Income Taxes* requires the use of a two-step approach for recognizing and measuring tax benefits taken or expected to be taken in a tax return and disclosures regarding uncertainties in income tax positions. Only tax positions that meet the more likely than not recognition threshold at the effective date may be recognized.

The Plan administrator does not believe that the Plan has any material uncertain tax positions at December 31, 2024; however, the Plan's tax returns for the years ending December 31, 2023, 2022 and 2021 are still subject to examination by relevant taxing authorities.

### NOTE 4 – FAIR VALUE DISCLOSURES

ASC Topic 820-10, *Fair Value Measurements and Disclosures* ("ASC 820-10") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities and the lowest priority to unobservable inputs.

The three levels of the fair value hierarchy under ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Other significant observable inputs (including quoted prices in active markets for similar assets or liabilities), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### NOTE 5 – TAX STATUS

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and tax-exempt.

### NOTE 6 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others.

Plan investments are managed and held by Matrix Trust Company, who is both the custodian and trustee of the Plan. Employee Fiduciary, LLC is the recordkeeper of the Plan. Each of these service providers are a party-in-interest to the Plan.

TFO-TDC, LLC is the investment advisor for the Plan. Miller Grossbard Advisors, LLP is the independent auditor of the Plan.
