1) Description of plan and summary of significant accounting policies -

- A) **Description of Plan** - The following description of the Subs Island Development Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a profit-sharing and defined contribution plan covering all full-time employees of Subs Island Development Inc. or its affiliates, S.W. Management Services, Inc., Caribbean Franchise, Inc., and Sub-technologies Puerto Rico, LLP (the Companies). Each employee who has attained 21 years of age and has completed at least 1,000 hours of service during a one-year period is eligible to participate in the Plan on the first entry date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 2023 the Plan administrator approved the change of custodian of the Plan's assets to Oriental Bank and Trust and the recordkeeper to National Professional Planning Group, Inc. Accordingly, the participants investment account balances were transferred and invested into fund options offered.

Contributions - For the year 2024, participants may contribute up to \$15,000 of their eligible pay. Participants may also contribute eligible rollovers from other qualified defined benefit or contribution plans and individual retirement accounts. The Plan sponsors may make a matching contribution of 100% of employees' contribution up to 3% of his/her compensation, as defined. Discretionary matching and/or profit-sharing contributions may be contributed at the option of the Company's board of directors. Participants may elect to have their contributions allocated among various investment options offered by the Plan. Investment options consist of pooled separate accounts. Participants may redirect the investment options any time throughout the year.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan's contribution portion of their accounts is based on years of continuous service (2 years 20%, 3 years 40%, 4 years 60%, 5 years 80% and 6 years 100%).

Participant loans - Are not allowed.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Plan termination - Although it has not expressed any intent to do so, the Plan's Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Forfeitures - As established by Plan document, forfeitures may be used to reduce Plan's administrative expenses or future Companies' contributions. As of December 31, 2024, forfeitures amounted to approximately \$12,800 (certified by trustee). As of December 31, 2023, there were no forfeitures.

Party-in-interest - During the years ended December 31 2024 and 2023, there were no party-in-interest transactions that the Plan's management is aware of.

- B) Summary of significant accounting policies** - The accounting and financial reporting policies of the Plan conform with accounting principles generally accepted in the United States of America and to prevailing practices within its industry. The following is a description of the most significant of these policies:

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

Use of estimates - Preparing the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Operating expenses - The majority of expenses of maintaining the Plan are paid by the Companies.

Subsequent events - The Plan has evaluated subsequent events through September 16, 2025, the date these financial statements were available to be issued. On February 18, 2025, the Plan administrator approved the change of the custodian of the Plan's assets to Empower Trust, LLC., changed the Plan's service provider and its Third Party Administrator.

Except for the subsequent referred above, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 fair value measurements - Separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets for identical assets. Level 2 fair value measurements - Separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

The Plan evaluated the significance of the transfers between levels based upon the nature of the financial information and size of the transfer relative to total net assets available for benefits. There were no transfers in or out levels 1, 2 or 3 during the year ended December 31, 2024 and 2023.

Plan's fiduciary of the Subs Island Development Inc. Retirement Savings Plan set investment policies and strategies for trust. Long-term strategic investment objectives include preserving the funded status of the trust and balancing risk and return. Plan's fiduciary oversees the investment allocation process, which includes selecting investment managers, commissioning periodic asset-liability studies, setting long-term strategic targets and monitoring asset allocations. Target allocation ranges are guidelines, not limitations, and occasionally Plan's fiduciary will approve allocations above or below a target range.

3) Tax status -

The Puerto Rico Treasury Department (the Department) has determined and informed the Plan Sponsors by letter dated July 1, 2015, that the Plan and the related trust, as designed, qualified for tax-exempt status under the provisions of the “Código de Rentas Internas para un Nuevo Puerto Rico”, as amended, and the Circular Letter No. 11-10 of December 16, 2011 issued by the Department. On October 1, 2015, the Plan was amended to provide that Automatic Enrollment shall not apply and that Participants may make contributions pursuant to the Contribution Agreement of the Plan.

Accounting principles generally accepted in the United States of America require Plan’s management to evaluate tax positions taken by the Plan and recognize tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department. The Plan administrator has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

4) Risk and uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statement of net assets available for benefits.
