INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of Life Time and its Affiliates 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Life Time and its Affiliates 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the Life Time and its Affiliates 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General — The Plan is a defined contribution plan covering substantially all employees of Life Time, Inc. (the “Company”) that are age 21 or older. Employees may enter the Plan monthly, upon completing the above requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. In March 2020, the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”) was enacted. Plan management adopted and implemented certain provisions of the CARES Act and as a result, participants impacted by Coronavirus were able to:

- Withdraw, penalty free, up to \$100,000 of vested account balances as of December 31, 2020.
- Defer current active loan payments for the 2020 plan year.
- Suspend 2020 required minimum distributions (“RMD”) altogether or for RMD distributions made prior to the enactment of the CARES Act, roll them over to another eligible retirement plan within the prescribed timeframe according to Internal Revenue Service (IRS) notice 2020-23.

The Plan was amended in December 2022 to reflect the changes made by the CARES Act.

Plan Operations — The Company is the sponsor and administrator of the Plan. Fidelity Management Trust Company (Fidelity), the Trustee and Custodian of the Plan, is responsible for holding the assets of the Plan, executing investment transactions, and making disbursements. Fidelity Workplace Services, LLC is the Recordkeeper of the Plan.

Contributions — Participants may defer compensation subject to the limits established by the Internal Revenue Code (IRC). The Plan also allows participants, who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan, to make additional catch-up contributions of up to \$7,500 per year. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Company may make a discretionary matching contribution at the option of the Life Time, Inc. Retirement Committee. During the year ended December 31, 2024, the Company did not make a discretionary matching contribution to the Plan. As of December 31, 2024, the Company agreed to make a \$5,318,212 discretionary matching contribution to the Plan related to 2024 compensation, consisting of cash payments totaling \$5,184,981 and plan forfeiture account payments totaling \$133,231. Accordingly, an employer contribution receivable balance of \$5,184,981 was recognized on the Plan’s statements of net assets available for benefits at December 31, 2024.

Participant Accounts — Individual accounts are maintained for each participant in the Plan. Each participant’s account is credited with the participant’s contributions and the Company’s discretionary matching contributions and an allocation of investment earnings. Participant accounts are also charged with withdrawals, allocation of investment losses, and administrative expenses. The benefit to which a participant is entitled to is the benefit that can be provided from the participant’s vested account.

Vesting — Participants are vested immediately in their pretax salary deferrals, plus actual earnings thereon. Vesting in the Company’s discretionary matching contributions is based on years of service. Participants vest 25% in the Company’s discretionary matching contributions during each of the first four years of service. After four years of service, a participant becomes 100% vested in all of the Company’s discretionary matching contributions made during their service period.

Distribution of Benefits — On termination of service with the Company (including termination of service due to death, retirement, or voluntary or involuntary termination of employment), participants' vested account balances become distributable. In addition, as allowed under IRS rules, participants may withdraw funds from their vested accounts while employed to satisfy an immediate and heavy financial need, which is considered a hardship withdrawal. Benefits are distributed either in a lump-sum payment or through an installment plan.

Administrative Expenses — Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other administrative expenses, including investment management and recordkeeping expenses, incurred on behalf of the Plan are deducted from participant accounts.

Certain investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants — A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance, with a minimum note amount of \$1,000. Notes are repayable through payroll deductions over periods ranging up to 60 months, unless the proceeds are used to acquire a principal residence, in which case the loan must be repaid within 10 years. The interest rate is determined by the Plan administrator based on prevailing market conditions and is fixed over the life of the note. The interest rates on notes outstanding at December 31, 2024, with maturities through 2034, ranged from 5.25% to 10.50%.

Forfeitures — At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$131,630 and \$81,903, respectively. Forfeitures of unvested amounts are used to reduce the Company discretionary matching contributions and/or administrative expenses incurred on behalf of the Plan. During 2024, forfeitures in the amount of \$14,503 were used to pay administrative expenses.

Investment Options — Participants direct both their own and Company contributions into any of several investment alternatives offered by the Plan. At any time, participants may also elect to reallocate existing account balances between investment alternatives or to change their investment elections for future contributions. In addition to, or in lieu of, these various investment alternatives, participants may direct their own and employer contributions into a self-directed brokerage account, which includes options through which participants are allowed to develop a portfolio of individual stocks, bonds, and mutual funds.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan provides for investment in a variety of investment funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term, that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Investment Valuation and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4, Fair Value Measurements, for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Excess Contribution Payable — Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable as of December 31, 2024 or 2023.

Payment of Benefits — Benefits are recorded when paid. At December 31, 2024 and 2023, there were no amounts allocated to accounts of participants who elected to withdraw from the Plan but had not been paid.

Subsequent Events — Subsequent events were evaluated through September 29, 2025, the date financial statements were available to be issued. The Company paid the Plan discretionary matching contribution related to 2024 compensation during April 2025. For more information regarding the discretionary matching contribution the Company paid, see Note 1, Description of the Plan. No other such subsequent events occurred that require additional disclosure or adjustments to the Plan’s financial statements.

3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA for 2024 and 2023. A summary of the certified investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by the Fidelity, trustee/custodian and furnished to the Plan administrator is as follows. The Plan administrator has obtained certifications from the trustee/custodian that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-Directed Brokerage Accounts — Accounts primarily consist of cash, mutual funds, and common stocks.

Cash — Such amounts are recorded at cost, plus accrued interest, which approximates fair value.

Mutual Funds — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Stock — Valued at the closing price reported on the active market on which the individual securities are traded.

Stable Return Collective Trust Fund — A collective trust fund that is composed of indirect investments in fully benefit-responsive contracts that are valued at the net asset value ("NAV") of units of the bank collective trust. The NAV per unit is determined by subtracting all trust liabilities from the fair value of the trust assets, and dividing by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The use of NAV as fair value is deemed appropriate as the collective trust fund does not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the

right to require 12 months' notification in order to confirm that securities liquidations will be carried out in an orderly business manner. This investment is not classified within the fair value hierarchy below, but presented for reconciliation purposes only.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain transactions resulting in Plan assets being transferred to or used by a party-in-interest entity are prohibited, unless a specific exemption applies. Fidelity is a party-in-interest entity as a result of its providing trustee/custodian and recordkeeping services to and for the Plan, respectively, as well as the investment of Plan assets in certain of its investment funds. However, such transactions are specifically exempted and are not prohibited as Fidelity is reasonably compensated for its services and the benefits are in accordance with the Plan document as applied to all participants and beneficiaries.

The Plan also allows participants to take loans against their account balances, which also qualifies as an exempt party in-interest transaction.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100 percent vested in their accounts and the assets of the Plan would be distributed in accordance with Plan provision.

7. TAX STATUS

The Plan uses a pre-approved Plan document sponsored by Fidelity Management and Research Company (FMRC). FMRC has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed in compliance with the applicable requirements of the IRC. The Plan sponsor believes the Plan has maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.
