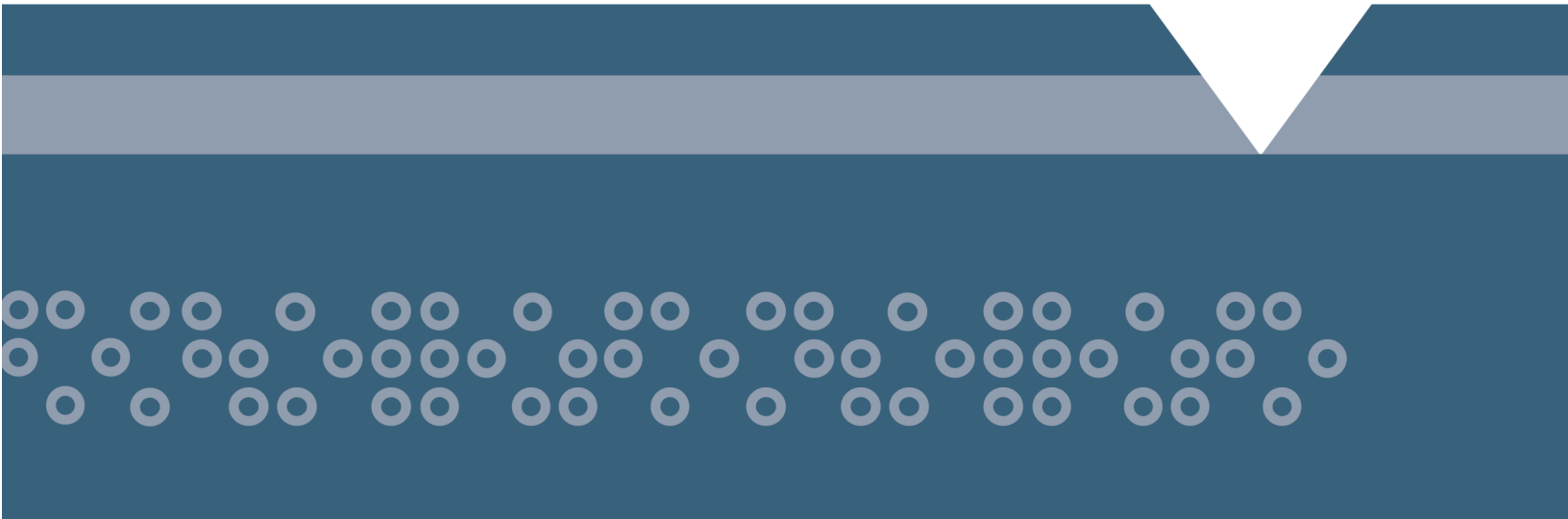

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the Yokem Motors, LLC (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is a tax-qualified defined contribution plan under Section 401(a) of the Internal Revenue Code of 1986, as amended, which provides retirement, disability, or death benefits for eligible employees of the Company. The Plan is subject to various provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.104-50 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

- (a) *Participant accounts.* Each participant’s account is credited with the participant’s voluntary contribution, the Company’s profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund.
- (b) *Employee contributions.* Participants are permitted to contribute up to the maximum deferral amount indicated by the Internal Revenue Service (IRS), to the Plan on a tax-deferred basis. Transfers from qualified plans are allowed under the provisions of the Plan. The Plan has an automatic escalation feature which provides for a 2% increase to a participant’s deferral rate annually up to 12%, unless the participant opts out.
- (c) *Employer contributions.* The Company may contribute annually a discretionary profit-sharing contribution based on the Company’s profits in an amount equal to a specified percentage of the participant’s base salary. The Company may also contribute a discretionary match contribution. The Company matched 2% of eligible compensation for participating employees for the year ended December 31, 2024 and 2023. The Company also made profit sharing contributions in the amount of \$46,500 and \$66,500 for the year ended December 31, 2024 and 2023, respectively.
- (d) *Vesting.* Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in non-elective and profit-sharing contributions and earnings thereon, is based on years of service and is determined as follows:

- (e) *Forfeitures.* Forfeitures of non-vested Company contributions are used first to reduce Plan expenses and then Company contributions. As of December 31, 2024 and 2023, the balance in the forfeitures account was \$15,633 and \$29,281, respectively.
 - (f) *Payment of benefits.* On termination of service due to death, disability, retirement, or upon reaching normal retirement age, a participant may elect to receive either a lump-sum amount

equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than his or her life expectancy. If the value of the distribution exceeds \$5,000, the Plan allows participants to elect to receive distributions as follows: lump sum, substantially equal installments or partial withdrawals or installments. If the value of the distribution does not exceed \$5,000, the Plan will distribute the participant's value of the vested interest in his or her account as a lump-sum distribution.

In-service distributions are also available to participants who have attained the age 59 ½.

- (g) *Plan expenses.* Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.
- (h) *Excess contributions payable.* The liability for excess contributions payable as of December 31, 2023 was distributed to the applicable participants in 2024. There were no excess contributions payable as of December 31, 2024.

2. Summary of Significant Accounting Policies

- (a) *Basis of accounting.* The financial statements of the Plan are prepared under the accrual method of accounting, except for the cash basis recording of benefits paid.
- (b) *Investment valuation and income recognition.* The Plan's investments are stated at fair value, (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

- (c) *Use of estimates.* The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

3. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Transamerica Life Insurance Company, the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and net change in fair market value for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's trustee.

4. Fair Value Measurements

FASB ASC #820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC #820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at, December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: Valued at the NAV of units of a bank collective trust. The interest credited to the balances in the fund will reflect both current market conditions and performance of the underlying investments in the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan or reduce or cease contributions at the discretion of the Board of Trustees, or to amend the Plan at any time and in any respect. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

6. Plan's Tax Status

The Company adopted a Prototype Non-Standardized Profit-Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since then, however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is not subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party and Parties-in-interest Transaction

Certain Plan investments are shares of mutual funds managed by Transamerica Retirement. Transamerica Retirement is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

8. Risks and Uncertainties

The majority of the Plan's assets are invested in mutual funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transaction and events that affect the financial statements. Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
