Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SE&M Constructors, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

General - SE&M Constructors, Inc. 401(k) Plan (the "Plan") became effective as of April 1, 1993. SE&M Constructors, Inc. and SE&M of the Triangle, Inc. are the Plan's sponsors. The Plan is a defined contribution plan covering all employees of SE&M Constructors, Inc. and SE&M of the Triangle, Inc who have at least one year of service and are at least age 21. Effective July 1, 2024 the minimum participant age was decreased to 18. In addition, part-time employees who meet the age requirements and perform at least 500 hours of service for three consecutive years are also eligible to contribute to the plan; however, part-time employees are not eligible for employer contributions. SE&M Constructors, Inc. and SE&M of the Triangle, Inc. are commonly held corporations and are treated as one employer for pension plan purposes. Collectively these corporations are referenced as the "Company". Entry dates of the Plan are January 1 and July 1. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA").

Contributions - Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. However, the total amount contributed may not exceed a limit set annually by law (\$23,000 for 2024). Participants who are age 50 or older may contribute an additional \$7,500 "catch-up" contribution. Participants direct the investment of their contribution into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target fund nearest the participant's 65th birthday. Participants have the option of changing their default deferral rate and investment election. Unless elected otherwise, under auto-enrollment a participants deferral rate will increase by 1% each year until it reaches a maximum of 6%. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may contribute a discretionary matching percentage of qualifying participants' contributions. To be eligible for a matching contribution, a participant must have completed at least one year of service and be employed at year end. Certain exceptions apply for disability, death and participants who have attained age 65. The discretionary matching percentage amount and the eligible qualifying participant amount will be determined annually by the Plan's sponsor. The Company makes its matching contributions annually. For the year ended December 31, 2024 the Company made a matching contribution of \$125,000. In addition, the Company may contribute a discretionary profit-sharing contribution to the plan. To be eligible for the profit-sharing contribution a participant must be age 21 and have at least one year of service among other eligibility requirements. No profit-sharing contribution was made for the 2024 plan year.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with expenses that are paid by the Plan. Certain direct participant expenses such as distribution fees and participant account fees are charged directly to a participant account. General administrative expenses are allocated to participants based on account balances.

Vesting - Vesting is determined as follows:

Less than 2 years	0%

Payment of Benefits – A participant's vested benefits is paid in a lump sum. Benefits are paid due to termination of service, death, disability and, if qualifying conditions are met, hardships and in-service withdrawals.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in any percentage in any of the available investment options. Participants may change their investment options at any time. Participants are given more information on the choices and the procedures to be followed at the time of their election

Forfeited Accounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. However, \$7,909 of forfeited amounts during 2024, including earnings was used to pay plan expenses.

Note 2 – Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting. Investments held are reported at fair value.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments in these financial statements are reported at fair market values at December 31, 2024 and 2023 as certified by Ascensus, LLC, an agent of the Plan's trustee, Ascensus Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividend income is recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable – Amount payable to participants totaling \$19,061 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable with a corresponding reduction to 2024 contributions. The Plan distributed the 2024 excess contributions in the first quarter after year end. For the year ended December 31, 2023, there was \$16,871 in excess contributions recorded as accounts payable which were timely distributed.

Payment of Benefits -- Benefits are recorded when paid.

Administrative Expenses -- Administrative and distribution fees are included in administrative expenses and charged directly to the participant's account. Investment advisory expenses are paid by the plan sponsor.

Date of Management's Review -Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Certain information related to investments in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, an agent for the Plan's trustee Ascensus Trust Company.

Note 4 - Tax Status

The Plan is adopted from a prototype document prepared by Ascensus, LLC. The prototype document received a favorable tax determination letter dated June 30, 2020 from the Internal Revenue Service. However, the Plan sponsor has not applied for a separate determination letter specifically for the adopted Plan, but believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no taxes have been provided for in the accompanying statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for tax periods in progress.

Note 5 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. FASB ASC 820 Fair Value Measurements and Disclosures establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market, Mutual funds: Valued at the daily closing prices reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provision of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Delinquent Participant Contribution

The Plan administrator discovered one omitted deposit in the amount of \$54 for a participant contribution for the 2023 plan year. Utilizing the Self-Correction Program, the Plan sponsor made a correcting deposit, including applicable lost earnings, in August 2024 to correct the omission.

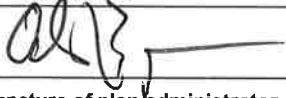
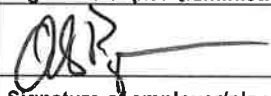
