Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Hideaway Sponsor 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of The Hideaway Sponsor 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

General

The Plan is a defined contribution plan covering all eligible employees of The Hideaway Sponsor Staffing, LLC (the "Sponsor"), as defined in the Plan agreement. The Plan provides for retirement benefits for its participants. The Plan is designed to qualify under Section 401(k) of the Internal Revenue Code (the "Code"), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participation and Eligibility

Participation in the Plan is voluntary. However, the Sponsor automatically enrolls participants in the Plan. An employee is eligible to participate in the Plan after the completion of a minimum hours of service as described in the Plan. An eligible employee may elect to participate following satisfaction of the Plan's service requirements. A participant must attain the minimum age to participate in the Plan.

Contributions

Participants may contribute a percentage of pretax annual compensation, as defined by the Plan. The Plan offers various mutual funds and a stable value bond fund as investment options for the participants. The Sponsor may contribute to the Plan out of its current operating cash flow at the discretion of the Sponsor's Board of Directors. Participants may contribute distributions from other qualified defined benefit or defined contribution plans as a "rollover" distribution into the Plan. The Sponsor may make discretionary contributions as authorized by its Board of Directors.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's contribution, (b) Plan earnings, and (c) forfeitures of terminated participant's nonvested accounts, if any, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balance, as defined. The benefit which the participant is entitled is the benefit that can be provided from the participant's accumulated vested account.

Vesting

Participants are immediately fully vested in their contributions, rollover contributions and the related net investment earnings or losses. Participants become vested in the Sponsor's matching contributions and the Sponsor's discretionary contributions, if any, in accordance with the Plan agreement based on a 4-year graded vesting schedule.

Forfeitures

A participant's non-vested balance is forfeited at the time of termination of employment. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, the forfeiture account was \$993 and \$2,312, respectively. Forfeitures of \$7,509 were used during the year ended December 31, 2024. No forfeitures were used for the year ended December 31, 2023.

Payment of Benefits

On termination of employment, participants with a vested Plan account may elect to receive a lump sum amount equal to the value of their account, or may defer distribution until retirement, as defined by the Plan agreement. Employees electing to defer their distribution continue to participate in the Plan's net investment earnings or losses.

Withdrawals of Contributions

A participant demonstrating a financial hardship may withdraw any amount of their account value consisting of the participant's contributions.

Notes Receivable from Participants

The Plan allows loans to participants. The loan cannot exceed the lesser of 50% of the participant's vested account or the amount established by the Plan or the Internal Revenue Code limitation. All loans must be repaid over a period not to exceed five years and at termination of employment. The loans are secured by the balance in the participant's account. Interest on plan loans is recorded upon receipt and is required to be paid with each principal payment.

Investment Options

The Plan maintains the retirement assets with a Trust company that provides a selection of mutual funds and bond funds. This company serves as custodian and Trustee of the Plan. Assets in the separate investment allocation account are held by the Trustee on behalf of the Plan in one or more of the Trustee's separate investment accounts.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants, and net appreciation in fair value of investments, interest and dividends was obtained or derived from information supplied to the plan administrator and certified as complete and accurate the trustee of the Plan

The participants direct their account balances between stock funds and bond funds and may change their account distribution in accordance with the terms of the Trust agreement.

2. Summary of Accounting Policies

A. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

B. Investment Valuation and Income Recognition

Investment contracts held by a defined contribution plan are required to be reported at fair value. The value of investments held as of each accounting date is determined based on the fair value of each underlying fund's investments principally using quoted market values from national exchanges. Purchases and sales of investments are reflected on a trade-date basis. The statement of changes

B. Investment Valuation and Income Recognition, continued

in net assets available for Plan benefits includes the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Mutual funds reported at the closing net asset value per unit of participation as determined by the Plan's Trustee based upon the respective fund/portfolio as of the last business day of the Plan year. The purchase or redemption price of the units is determined based on the current net asset value per unit of participation. The value per unit is determined by the Trustee using the market values of the underlying assets or the fair values as determined by the Trustee in the absence of an available market price.

C. Payment of benefits.

Benefits are recorded as paid.

D. Contributions

Participant contributions are recorded in the period in which the Sponsor makes payroll deductions from Plan participants.

E. Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Expenses related to the administration of the pooled separate accounts are paid by the respective accounts and are reflected in the overall investment return of such funds or reimbursed from the non-vested fund balance. Any expenses resulting from fund transfers or from withdrawals or loan origination may be deducted from participants' account balances.

F. Estimates

The preparation of financial statements requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes can materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2023 excess contributions to the applicable participants prior to March 15, 2024.

I. Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued, September 15, 2025. Due to various conditions within the United States of America and globally, the Plan's various investment securities may have incurred volatility in fair value since December 31, 2024. It is reasonably possible that these conditions have materially affected participants' account balances and may continue to impact the accounts into the future.

3. Information Prepared and Certified by the Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan management instructed the plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust, the trustee of the plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the plan's financial statements and supplemental schedules:

4. Fair Value Measurements

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, entitled level 1 measurements, and the lowest priority to unobservable inputs, entitled level 3 inputs. Level 2 inputs include quoted prices for similar assets or liabilities in active markets and inputs other than quoted prices that are derived or observable for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value end.

Mutual funds: Valued at fair value using the fair value hierarchy.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Internal Revenue Service has determined and informed the Trustee of the Plan that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code ("the Code"). The prototype plan may be amended to comply with regulations or laws as issued. The Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the Code. The Plan is subject to routine tax audits by taxing jurisdictions. There are currently no Plan audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

7. Loans

The Plan allows the participant to borrow a specified percentage of their account balance. Loans bear interest and are repayable in accordance with the terms specified by the Plan. The Plan reserves the right to change the ability to borrow or the loan terms. Interest income is recognized on a monthly basis based upon the annual interest rate.

8. Related Party Transactions

Certain plan investments are shares of mutual funds managed by T. Rowe Price. T. Rowe Price is a related party to the Trustee of the Plan assets and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investment, as they are paid through revenue sharing, rather than a direct payment.
