Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Universal Technical Institute, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

General

The following description of Universal Technical Institute, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Universal Technical Institute, Inc. (Company). Eligible employees who are age 18 or older may make salary deferrals into the Plan immediately or as soon as administratively feasible. Employees who have completed 90 days of continuous service are eligible to receive matching and/or discretionary profit-sharing contributions on the first payroll period following the date these requirements are satisfied. The Plan was established on August 1, 1991 and is subject to provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Each year, participants may make pre-tax or Roth salary deferral contributions in any percentage from 1% to 75% of eligible earnings, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. All participant contributions are subject to Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. During 2024 and 2023, the Company made a matching contribution of 37.50% of the first 6% of eligible earnings contributed to the Plan on a per paycheck basis. Additionally, the Company may make an employer discretionary profit-sharing contribution. There were no employer discretionary profit-sharing contributions in 2024 and 2023.

Participant Investment Account Options

Each participant has the option of directing their contributions into a variety of investment fund options maintained by Fidelity Management Trust Company (Fidelity). Participants can direct all contributions made on their behalf. Additionally, participants may choose to invest in any stock listed on a major U.S. exchange, mutual funds, bonds, other fixed-income investments, and money market funds through the use of a Self-Directed Brokerage Account.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate is then increased by 1% annually up to 10%.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of discretionary profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their pre-tax salary deferral contributions, Roth contributions, rollovers, and earnings thereon. Vesting in the Company's matching contributions and discretionary profit-sharing contributions is based on years of service: a participant becomes 33% vested after one year of service; 67% vested after two years of service; and 100% vested after three years of credited service.

If a participant reaches normal retirement age (age 65), dies, or becomes totally disabled, the participant becomes fully vested in employer matching and discretionary contributions, irrespective of years of service. Early retirement is not permitted.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years, or longer for the purchase of a primary residence. The notes are secured by the balance in the participants account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan is designed to provide benefits at the time of retirement. However, if employment is terminated because of death, disability, or for any other reason, participants may request a distribution of their vested account balance from the plan administrator. Furthermore, upon approval of the plan administrator, participants may be entitled to take distributions of salary deferral contributions to satisfy certain immediate and heavy financial needs. Participants may elect to withdraw all, or a portion of their account, while still employed or upon reaching normal retirement age, as defined by the Plan. After termination, if a participant's vested account balance is greater than \$5,000, the participant may elect to have their vested account balance distributed to them in a lump sum, in installments over a period of time, or the participant may take partial withdrawals. If a participant's vested account balance is between \$1,000 and \$5,000, the participant may elect to receive a lump-sum distribution; or if no affirmative election is made, the Plan will automatically distribute the amount to the participant by rolling their vested balance to an IRA. If the balance is less than \$1,000, the Plan will automatically distribute the amount in a lump sum payment to the participant.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,124 and \$217,967, respectively. These accounts may be used to reduce future employer contributions or to pay administrative expenses, which would otherwise be paid by the Plan. During the years ended December 31, 2024 and 2023, \$369,648 and \$0, respectively, of forfeited non-vested accounts were used to reduce employer contributions. Additionally, during the years ended December 31, 2024 and 2023, \$71,811 and \$60,600, respectively, of forfeited non-vested accounts were used to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amount of net assets and the reported amounts of additions and deductions from net assets. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses and fees relating to specific participant transactions (*i.e.*, loan setup, distribution request, etc.) are charged directly to the participants' account and are included in administrative expenses.

Note 3. Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments include funds managed by Fidelity, the trustee of the Plan. Investment and administrative fees paid to Fidelity qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for these services were \$299,113 and \$236,431 for the years ended December 31, 2024 and 2023, respectively. Additionally, in 2024 and 2023, \$69,386 and \$60,600, respectively, was paid for other professional services. Total fees paid by the Plan for these services were \$368,500 and \$297,031 for the years ended December 31, 2024 and 2023, respectively.

Note 5. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of and for the year ended December 31, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Services. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
