INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Cammeby's International Ltd. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Cammeby's International Ltd. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF PLAN

General

Cammeby's Management Company, LLC established the Cammeby's International Ltd. 401(k) Plan (the "Plan") in 2014, as a defined contribution plan for employees of Cammeby's Management Company, LLC and its participating employers (collectively, the "Company"). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility

All employees who are 21 years of age or older are eligible to join the Plan on January 1st or July 1st of each Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Plan contributions consist of pre-tax compensation (up to 95%) reduction elections of participants (the "401(k) contributions"), rollovers and employer discretionary matching contributions. Under the terms of the Plan, the Company may determine to make discretionary matching contributions. For the year ended December 31, 2024, certain participating employers elected to match 50 percent of the participant's contributions, up to a maximum of \$2,000. Contributions are subject to certain Internal Revenue Code (the "IRC" or "Code") limitations (\$23,000 for 2024 and \$22,500 for 2023).

Catch-up contributions are also permitted for participants who have attained age 50 in accordance with Section 414(v) of the Code by an amount up to \$7,500 for both 2024 and 2023, bringing those participants' statutory limitations to \$30,500 and \$30,000 for 2024 and 2023, respectively.

All contributions to the Plan are invested by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, as directed by the participants. Participants can make changes to their investment allocations and the changes will be processed by the beginning of the next payroll period.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Forfeited Amounts

As of December 31, 2024 and 2023, forfeited non-vested amounts totaled \$90 and \$11,304, respectively. These amounts can be used to reduce future employer contributions and towards administrative and other Plan expenses. Forfeitures were used to offset Company expenses in the years ended December 31, 2024 and 2023 in the amounts of \$30,342 and \$29,218, respectively.

Participant Accounts

Contribution selections are designated by the participants. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary matching contributions and (b) Plan earnings (losses). Allocations of earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants of the Plan are eligible for loans from their fund accounts. The maximum amount that can be obtained is 50 percent of each participant's vested account balance, with a loan amount of at least \$1,000, but not to exceed \$50,000. The loans are secured by the participant's vested account balance, will bear a reasonable rate of interest and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years). Principal and interest are paid ratably through weekly and bi-weekly payroll deductions. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.

Vesting

Participants are immediately vested in their elective contributions and rollover contributions, if any, and the earnings thereon. Participants become vested in the Company's discretionary matching contributions, plus earnings thereon, according to a vesting schedule of 20 percent per year, beginning after the second full year of service, with an additional 20 percent vesting for each additional year of service. A participant is 100 percent vested in the employer discretionary matching contributions and earnings after six years of service or upon attaining normal retirement (age 65) or earlier, in the event of termination of employment due to disability or death.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant whose vested balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, or have the value applied to the purchase of an annuity, other than a life annuity. Participants whose vested interest does not exceed \$5,000 will receive a single lump-sum payment.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments, Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded, which may be a taxable event for the participant.

Benefits Paid

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE AND CUSTODIAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information as of December 31, 2024 and 2023 and for the years then ended, and the information contained in the supplemental schedule of assets (held at end of year), was certified as complete and accurate by Fidelity, the Trustee of the Plan, and was not subjected to any auditing procedures performed by the independent auditors, except for comparing such information with the related information included in the financial statements.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Money Market Mutual Fund

Shares held in the money market fund invests in a variety of money market instruments to seek current income which are comprised of high-quality dollar-denominated money market instruments that consist of U.S. Treasury obligations. The composition of securities is structured to maintain a value of \$1 per share and are classified as Level 1 since it is in the active market.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value at December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. As of December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers in or out of Level 3.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investment options are money market mutual funds, mutual funds and common collective trusts managed by Fidelity. Fidelity is the third-party administrator, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$50,594 and \$32,700, respectively.

Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7 – TAX STATUS

The Plan is a prototype non-standardized volume submitter profit sharing plan approved on October 6, 2020, which the Internal Revenue Service (“IRS”) ruled in an opinion letter, as then designed, qualifies under Section 401 of the IRC. The Plan administrators (and the Plan’s tax counsel) believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS, or applicable state authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – DELINQUENT PARTICIPANT CONTRIBUTIONS – REPORTABLE CONDITION

In accordance with the Department of Labor's Regulation 2510.3-102, employers are required to segregate participants' contributions from its general assets as soon as practical, but in no event more than the 15th business day following the end of the month in which amounts are contributed by participants or withheld from their wages for a benefit plan such as the Plan. The employer failed to timely remit participants' contributions related to December 2024, totaling \$15,136. The employer has agreed to absorb any costs incurred by the Plan as a result of the untimely remittance of the participants' accounts. This amount was remitted in January 2025. The amount of delinquent participant contributions has been reported on Form 5500 and in the supplemental schedule of the audit report.

NOTE 11 – SUBSEQUENT EVENTS

On February 1, 2025, the Plan was amended to include Rosera Wesmont Payroll LLC as a participating employer in the Plan. In addition, on May 9, 2025, the Plan was amended to include Volair Wesmont Payroll LLC as a participating employer in the Plan. As a participating employer, Rosera Wesmont Payroll LLC and Volair Wesmont Payroll LLC and its eligible employees may make contributions and receive benefits under the Plan in accordance with the Plan's provisions.

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.
