***Independent Auditor's Report***

To the Plan Administrator, Management, and Those Charged with Governance  
403(b) Thrift Plan for Nexus Recovery Center, Inc.:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of the 403(b) Thrift Plan for Nexus Recovery Center, Inc. ### NOTE A - DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan of Nexus Recovery Center, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

#### General

The Plan is a defined contribution 403(b) plan covering all employees of Nexus Recovery Center, Inc. (the "Sponsor", "Plan Administrator", "Employer"), as defined below. The Plan is designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code, as amended ("IRC"). In addition, the Plan's financial statements have been prepared in compliance with accounting principles generally accepted in the United States of America ("US GAAP") and with ERISA.

#### Plan Administration

The Plan Sponsor is responsible for the administration and operation of the Plan. Mutual of America Life Insurance Company ("Custodian") serves as the Plan's asset custodian and is responsible for custody and management of the Plan's assets and for executing transactions. In addition, the Custodian provides recordkeeping services for the Plan which includes the responsibility for maintaining participant account records and transactions.

#### Eligibility

All full-time employees of the Company are eligible to participate in the Plan immediately upon hire, except leased employees or non-resident aliens, as defined by the Plan. All employees of the Company who have attained age 21 and nine months of continuous service are eligible to receive employer matching contributions.

#### Contributions

Plan participants may elect to defer a portion of their includable compensation, as defined, subject to certain IRC limitations (\$23,000 in 2024) with the contributions and earnings thereon being nontaxable until withdrawn from the Plan. Participants who have attained age 50 or older before the end of the Plan year are eligible to make catch-up contributions subject to IRC limits (\$7,500 in 2024). These catch-up contributions are not eligible for a matching contribution. Participants may also contribute eligible rollovers from other qualified retirement plans into the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant may elect to change the percentage of their compensation deferred and their investment options at their discretion.

The Employer makes matching contributions to the Plan equal to 100% of an eligible participant's deferrals up to 3% of the participant's compensation, subject to IRC limitations.

Eligible employees are automatically enrolled in the Plan at 1% of their compensation the first year (2% second year and 3% third and subsequent years) unless they actively opt-out of participation in the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer's contributions, and allocations of investment earnings/losses and charged with administrative expenses. Allocations related to investments are based on the participant's account balance as a percentage of the total participants' account balances in each investment or the change in unit or share value of the individual investments.

### NOTE A - DESCRIPTION OF PLAN – CONTINUED

#### **Vesting**

Participants are immediately vested in their contributions, rollover contributions, and related earnings. Participants are 100% vested in Employer matching contributions after three years of continuous service or upon attainment of age 65, total and permanent disability, or death.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is lower. Participants are allowed more than one loan outstanding at any time providing the total loans outstanding do not exceed 50% of the participant's vested account balance at the time of origination. The interest rate for loans was 4% which is commensurate with the prevailing market rates for similar loans. Loan terms may not exceed five years, except when the loan is used for the purchase of a principal residence, in which case they may not exceed ten years. Loans are secured by a portion of the participant's accrued benefit in the Interest Accumulation Account of the General Account available under the Plan's group annuity contract. If the participant does not have funds invested in the Interest Accumulation Account, amounts equal to the amount required to secure the loan are transferred from the participant's other investments to the Interest Accumulation Account. Delinquent notes receivable from participants are reclassified as distributions based upon terms of the plan document. Repayment of the notes are through after-tax payroll deductions.

#### **Benefit Payments**

Benefits are payable upon retirement, termination of service, disability (as defined), or death. A participant may elect to receive their balance with a lump-sum, annuity, or installment amount. Participants may also elect to rollover their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions.

In addition to the foregoing, participants are permitted to request in-service distributions from their vested Plan accounts at any time after having attained age 59 ½. Participants may also request distributions of their vested account balance upon incurring financial hardship, as defined by the Plan and subject to certain penalties and limitations.

If a terminated participant's balance is \$1,000 or less, the balance will be automatically distributed from the Plan to the participant.

#### **Forfeitures**

Forfeitures of terminated participants' non-vested account balances are used to pay Plan expenses then to reduce the Employer's future matching contributions. As of December 31, 2024 and 2023, the Plan had no forfeiture balances. During the 2024 and 2023 Plan years, \$9,054 and \$4,712 of forfeitures were used to reduce Employer matching contributions, respectively.

#### **Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with US GAAP and present the Plan's net assets available for benefits and changes therein. Investments are presented at fair value or contract value in accordance with GAAP as prescribed for defined contribution plans.

#### **Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant estimates include the calculation of fair value of investments.

#### **Investment Valuation and Income Recognition**

The Plan invests in pooled separate accounts ("PSAs") and a guaranteed interest general account ("GIA"). Investments in PSAs are valued at net asset value ("NAV") as a practical expedient to fair value as determined by the issuer. The net investment income of PSAs represents the change in NAV per unit of the individual PSA times the number of units held by the Plan in each individual PSA. The Plan's investment in the GIA is valued at contract value as determined by the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **Contributions and Contributions Receivable**

Contributions from participants are recorded based on the date the contributions have been separated from participants' pay by the Employer, which is the pay date. The Plan records receivables for participants' contributions, if any, based upon contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Employer matching contributions are recorded in the year they are earned to coincide with the year which the Employer records the contributions to the general ledger as an expense and reported on the Employer's tax return. The Plan records receivables for Employer matching contributions, if any, based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

### NOTE C – INVESTMENT CERTIFICATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

### NOTE D - FAIR VALUE MEASUREMENTS

GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants. Such fair value is a market-based measurement, not an entity specific measurement. GAAP also establishes a fair value hierarchy which requires classification based on observable and unobservable inputs when measuring fair value. The fair value hierarchy distinguishes between assumptions based on market data (observable inputs) and an entity's own assumptions (unobservable inputs).

The hierarchy consists of three levels:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In instances where the determination of fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lower level input that is significant to the fair value measurement in its entirety.

As a practical expedient, units of PSAs are valued at NAV as determined by the issuer based on the fair value of the underlying investments less fund expenses. The Plan's investment in the fully benefit responsive GIA is valued at contract value (see Note E). Investments valued at NAV as a practical expedient and at contract value are not disclosed within the fair value hierarchy.

As of December 31, 2024 and 2023, there were no restrictions on redemption or unfunded commitments for any of the major types of assets.

### NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan has entered into a guaranteed interest account (“GIA”), a fully benefit-responsive investment contract with the Custodian. The Custodian maintains the Plan’s contributions in the GIA within its general account. The GIA is included in the financial statements at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan’s failure to qualify under Section 401(a) of the Internal Revenue Code (“IRC”) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC; (2) premature termination of the contracts; (3) Plan termination or merger; (4) changes to the Plan’s prohibition on competing investment options; or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan’s investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

### NOTE F - NONPARTICIPANT-DIRECTED INVESTMENTS

The Plan’s participants direct all investments. There are no non-participant directed investments as of December 31, 2024 and 2023.

### NOTE G – RELATED PARTY TRANSACTIONS

Plan assets include investment in funds managed by the Custodian, and as such, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Custodian receives fees from administration and investment management. The investments of the Plan are maintained in the general accounts and separate accounts of the Custodian. During the year ended December 31, 2024, the Plan Sponsor paid approximately \$11,000 in Plan expenses.

### NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### NOTE I - TAX STATUS

The Plan has adopted a Prototype Non-Standardized 403(b) Plan sponsored by Mutual of America Life Insurance Company. On March 31, 2017, the Internal Revenue Service (“IRS”) stated in an advisory letter that the Prototype Non-Standardized 403(b) Plan, as then designed, was in compliance with the applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE J - FIDELITY BOND

The Plan is covered by a \$1,000,000 fidelity bond.
