### 1. Description of the Plan

Effective January 1, 2023, the name of the Plan was changed from Glasfloss Industries, L.P. 401(k) Retirement Plan to Glasfloss Industries, Inc. 401(K) Retirement Plan. The following description of the Glasfloss Industries, Inc. 401(K) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 1996, by Glasfloss Industries L.P., now known as Glasfloss Industries, Inc. (the Company or Employer), the sponsor of the Plan. The Plan is a contributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Custodian and Administration of the Plan*

The custodian and recordkeeper of the Plan is VOYA Retirement Insurance and Annuity Company (VOYA or the Custodian). The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Participants must be 21 years of age and must complete three months of service to participate in the Plan. All employees are eligible to participate unless they are unionized employees and/or non-resident aliens. The entry date is 30 days after the date coinciding with the date the eligibility requirements are met.

#### *Contributions*

Participants may contribute up to the maximum percentage allowable under the Internal Revenue Code (IRC) and may also contribute amounts representing rollover distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation until changed by the participant.

The Plan provides that the Company may contribute, for its active participants who have elected to make salary deferrals, a matching contribution not to exceed a percentage of the employee's compensation, as determined by the Company. Effective September 27, 2021, the Company matched \$0.30 for every \$1 contributed by the participant, up to 10% of the participant's eligible compensation for the period.

The Plan also provides for additional discretionary and qualified non-elective contributions, which includes profit-sharing contributions, all of which are at the option of the Company's Board of Directors. The amount of the profit-sharing contribution is determined by an allocation formula that is generally based on participant earnings, while annual contributions are generally based on the Company's profits. Profit-sharing contributions may be modified during times of business hardship.

Participants must have performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, total and permanent disability or retirement during the year, to be eligible for the profit-sharing contribution. The Company did not make a profit-sharing contribution during 2024.

### *Participant Accounts and Allocations*

Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocation of any other discretionary Company contributions, and an allocation of net Plan earnings or losses. Allocations of the Company's contributions are based on each participant's compensation compared to the total compensation of all participants, as defined by the Plan agreement. Earnings are allocated to individual participant fund accounts based on the earnings of the individual investment options selected by the participant. Terminated participants do not share in allocations of discretionary and qualified non-elective contributions.

### *Vesting*

Participants are immediately vested in their own contributions, the Company's matching contributions and any other Company discretionary or qualified, non-elective contributions from which the participants are entitled to receive an allocation, plus actual earnings thereon.

### *Payment of Benefits*

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance. Distributions may also be made for hardship withdrawals, which are authorized by the Plan Administrator and conform to the "deemed hardship" standards set forth in Treasury Regulation Section 1.401(k)(d)(2). Such hardship distributions are subject to certain limitations.

### *Administrative Expenses*

Certain administrative fees are generally charged to each participant's account on a pro rata basis. Likewise, loan fees are charged to the participant's account requesting the loan. As such, these expenses are a component of the statement of changes in net assets available for benefits. In 2024, the Plan paid administrative expenses of \$76,689. All other expenses incurred in administering the Plan, other than the administrative fees paid from the Plan's assets, are paid by the Company which are not a component of the statement of changes in net assets available for benefits.

### *Notes Receivable from Participants*

Participants may borrow from their individual accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's account and bear an interest rate at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to five years unless the loan is for the purchase of a primary residence. Any loan balance owed by a participant upon termination of employment with the Company is treated as a distribution to the participant. Also, each participant may not have more than five loans outstanding at any time.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value with the exception of the fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and Custodian. See Note 5 for a discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (see Note 4) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions and Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is de minimis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

### *Forfeitures*

The Plan may elect to use forfeited non-vested accounts, if any, to reduce administrative expenses or for future employer contributions. Investments as of December 31, 2024 and 2023, respectively, include \$22,303 and \$11,922 of forfeited funds available for future use. Forfeitures during the years ended December 31, 2024 and 2023 totaled \$9,401 and \$4,061, respectively.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VOYA, a qualified institution.

Notes receivable from participants in the amount of \$1,300,938 and \$1,019,021, as of December 31, 2024 and 2023, respectively, and related interest income on notes receivable from participants of \$91,663 for the year ended December 31, 2024 are not certified.

### **4. Fully Benefit-Responsive Guaranteed Investment Contracts**

As of December 31, 2024, the Plan invests in a fully benefit-responsive fixed interest account, the VOYA Fixed Account (Fixed Account), which is available through a group funding contract issued by VOYA. The Fixed Account is an obligation of VOYA's general account which supports all of the company's insurance and annuity commitments. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a stable value fund. As of December 31, 2024 and 2023, the value of the Fixed Account was \$2,686,112 and \$2,716,938, respectively.

The value of the Fixed Account is determined by the daily crediting of interest which is subject to minimum contractual guarantees. The Fixed Account does not have a maturity date. Investment transfers to and from the Fixed Account, and withdrawals to pay participant benefits (as defined in the contract) are made at book (i.e., contract) value. Non-benefit surrenders from the Fixed Account would either be subject to a market value adjustment or paid in installments as elected by the contract holder. A contract surrender charge may also be applicable, depending on the terms of the contract.

The guaranteed investment contract earned a fixed rate of return of 1.00% and 1.00% in 2024 and 2023, respectively.

### **5. Investments Measured Using the NAV Per Share Practical Expedient**

#### *Pooled Separate Accounts*

As of December 31, 2024 and 2023, the Plan held investments in pooled separate accounts. The variable funds are pooled separate accounts that invest directly in designated mutual funds or, in some cases, collective investment trusts. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset values (NAV). Plans

and participants hold “units of participation” in the separate account. The NAV, as provided by Voya Institutional Trust Company, is used as a practical expedient to estimate fair value.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by VOYA. Participant loan and distribution processing fees are paid to VOYA by participants. The Plan paid for third party administrator fees, investment advisory, and plan audit fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants’ accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

### 8. Income Tax Status

The Plan uses a pre-approved plan document sponsored by VOYA. VOYA received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions under the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.
