### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of the BayFirst National Bank 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Supplemental Schedule Required by ERISA***

The supplemental schedule as of December 31, 2024 listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statement

### 1. Description of Plan

The following description of the BayFirst National Bank 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all full-time employees of BayFirst Financial Corp. (the “Company”) who have two months of credited service and are age eighteen or older. The Plan Administrator controls and manages the operation and administration of the Plan. Principal Life Insurance Company (“Principal”) and Delaware Charter Guarantee and Trust Company dba Principal Trust Company (“Principal Trust Company”) serves as the custodian of the Plan (the “Custodian”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *Contributions*

Each year, participants may contribute up to 100% of compensation, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes a safe harbor nonelective contribution to each participant each pay period equal to 3% of eligible compensation. Additional discretionary matching or profit-sharing contributions may be made at the election of the Company’s board of directors. Contributions are subject to certain limitations. There were no discretionary or profit-sharing contributions made during the year ended December 31, 2024.

#### *Investment options*

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, and fixed annuity contracts as options for participants.

#### *Participant accounts*

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions, and plan earnings (losses), and is charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting and forfeitures*

Participants are immediately vested in their contributions, the Company’s safe harbor nonelective contributions, and actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions is based on years of continuous service. Participants in the Plan are fully vested in discretionary contributions after four years of credited service. Additionally, participants become fully vested in their accounts upon death, disability, retirement or termination of the Plan.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$24,794 and \$6,700, respectively. Forfeitures may be used to reduce employer contributions and pay administrative expenses. Forfeitures for the year ended December 31, 2024 were \$25,000.

***Payment of benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Notes receivable from participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates ranging from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

**2. Summary of Significant Accounting Policies**

***Basis of accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts, changes therein and disclosures. Accordingly, actual results may differ from those estimates and assumptions.

***Investment valuation and income recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Principal Trust Company, as described in Notes 3 and 4.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of benefits***

Benefits are recorded upon distribution.

***Administrative expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Subsequent events***

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

**3. Fair Value Measurement**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1: Observable inputs such as quoted prices in active markets.
- Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurements. The Plan's assessment of the significance of a particular input to fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. The following is a description of valuation methodologies used for assets measured at fair value:

***Mutual funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Pooled separate accounts***

Pooled separate accounts are non-publicly traded investments and are valued daily based on the market value of the underlying net assets in each separate account. The underlying net assets have an observable Level 1 quoted pricing input used in determining the value of the pooled separate accounts which is not publicly quoted.

**4. Fully Benefit-Responsive Investment Contracts**

Effective October 11, 2021, the Plan invested in a fully benefit-responsive guaranteed investment contract issued by Principal. Contract value is the relevant measure for fully benefit-responsive investment contracts as it reflects the amount that would be received by participants initiating permitted transactions under the terms of the Plan as of the measurement date. Contract value represents contributions made under the contract plus earnings, less participant withdrawals and administrative expense. The guaranteed investment contracts totaled \$3,971,318 and \$3,604,670 at December 31, 2024 and 2023, respectively, at contract value.

Principal maintains contributions under the contract in its general account and is obligated to repay the principal and a specified rate of interest that is guaranteed to the Plan. The interest rate is declared monthly with interest credited on a daily basis at an annual effective rate. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the contract issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the issuer or otherwise.

Certain events could limit the ability of the Plan to transact at contract value or allow the issuer to terminate the contract and settle at an amount different than contract value. Plan management does not believe that any such events are probable of occurrence.

## **5. Unaudited Information Certified by Qualified Institution**

## **6. Exempt Party-In-Interest Transactions**

Certain Plan investments are investment contracts issued by Principal or their affiliates. Principal provided certain administrative services for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to Principal by the Plan for administrative services were approximately \$32,330 for the year ended December 31, 2024

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## **8. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval dated June 30, 2020 stating that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the prototype plan determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. At December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.
