INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Teamsters Local Union No. 1149
Health and Welfare Fund

Opinion

We have audited the financial statements of the Teamsters Local Union No. 1149 Health and Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Teamsters Local Union No. 1149 Health and Welfare Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Teamsters Local Union No. 1149 Health and Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Teamsters Local Union No. 1149 Health and Welfare Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Report on Supplemental Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets Held at End of Year, Schedules of Administrative Expenses, and Schedule of Nonexempt Transactions referred to as “supplemental information,” is presented for the purpose of additional analysis and is not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year and Schedule of Nonexempt Transactions represents supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan’s management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Contributions Receivable - Employer contributions due but not paid prior to the year-end are recorded as contributions receivable. Allowance for credit losses is considered unnecessary and is not provided.

Cash and Cash Equivalents - All highly liquid investments with maturities of six months or less at time of purchase are considered cash equivalents.

Deferred Contributions - Employer contributions received prior to the year-end but applicable to future periods are recorded as deferred contributions.

Payment of Benefits - Claim payments are recorded when paid. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the Statements of Benefit Obligations.

Benefit Obligations - Claims incurred but not reported were estimated by the Plan's consultant.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 2. DESCRIPTION OF PLAN

The following brief description of Teamsters Local Union No. 1149 Health and Welfare Fund (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

The Plan is a multiemployer welfare benefit plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on October 1, 1968 by an Agreement and Declaration of Trust. The Plan is maintained pursuant to collective bargaining agreements between Teamsters Local Union No. 1149 and its members' employers.

NOTE 2. DESCRIPTION OF PLAN (continued)

The Plan is funded by employer contributions as specified in the collective bargaining agreements and/or participation agreements. Unemployed participants along with their dependents are allowed to continue coverage by purchasing benefits through Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA).

The Plan provides hospital, surgical, major medical, vision, dental, prescription, legal and life insurance benefits. The type and level of benefits vary and are determined by the criteria outlined in the collective bargaining agreements and/or participation agreements.

Participants are eligible for benefits on the first day that they meet the eligibility requirements set by the Participating Employers.

NOTE 3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such a manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 4. TAX STATUS

In the Plan's latest determination letter, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 501(c)(9) of the Internal Revenue Code and was, therefore, not subject to tax under present Federal income tax laws. The Plan has been amended since receiving the determination letter. The Plan's Trustees and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, Plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 5. FUNDING POLICY

The Plan is funded by employer contributions as specified in the collective bargaining agreements and/or participation agreements. Employer contributions are considered exchange transactions.

NOTE 5. FUNDING POLICY (continued)

Under certain circumstances participants may contribute on their own behalf to maintain coverage.

At times, an employer may pay a special assessment to help defray the cost of high claims utilization for their organization.

NOTE 6. RELATED PARTY TRANSACTIONS

The Plan's related entities include Teamsters Local Union No. 1149 (the Local) and 7272 Van Buren Road, Inc (the Building Fund). The Plan has common Trustees and staff with the related entities. The Plan shares office personnel and office expenses with the Local. During the years ended December 31, 2024 and 2023, the Plan reimbursed the Local \$4,292 and \$10,243 respectively, for these expenses. The Plan rents office space from the Building Fund. Rent expense totaled \$5,550 for the years ended December 31, 2024 and 2023. The above transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rules of ERISA.

NOTE 7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

NOTE 8. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 8. FAIR VALUE MEASUREMENTS (continued)

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

NOTE 9. PROHIBITED TRANSACTIONS

During the annual audit of the Plan for the year ended December 31, 2022, it was discovered that the Plan transferred fund assets to an old contributing employer of the Plan. These non-exempt parties-in-interest transactions including, but not limited to, prohibited transactions were fully known as of the date of the December 31, 2022, financial statements. As of December 31, 2023, the Plan was owed \$225,891, related to these transactions, from this employer. This amount has not been paid by the employer through the date of the audit report. The amount is included in other receivables on the statements of net assets available for benefits.

During the 2023 audit, it was noted that the employer is in disagreement with the prohibited transaction noted in the previous year audit. The legal counsel for the employer does not believe that there was a prohibited transaction and does not plan on reimbursing the Plan. The Plan's legal counsel believes that the Plan and the employer will not be able to make an agreement at this point. Due to this information, the Plan booked a credit loss during 2023 to write-off these monies that they don't believe will be received. The estimate for expected credit losses considered historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was \$225,891 and \$225,891, respectively.

NOTE 10. SUBSEQUENT EVENTS

The Board of Trustees and management have evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
