**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE 1 - PLAN DESCRIPTION**

The following brief description of the TIS Insurance Services, Inc. 401(k) Profit Sharing Plan ("Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established by TIS Insurance Services, Inc. ("Company") to provide retirement benefits to officers and employees of the Company who are age twenty or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for the oversight of the Plan.

**Contributions** - The Plan is funded by both participant and employer contributions. As defined by the Plan, participants may contribute a percentage of their salary not to exceed the IRS Code Section 402(g) limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain IRAs (rollovers) and are also allowed to make Roth 401(k) contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer makes matching contributions at a discretionary percentage of the participants' compensation for the Plan year. Additional profit sharing and/or qualified non-elective amounts may be contributed at the option of the Board of Directors. There were no profit sharing and/or qualified non-elective contributions for the year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant wages, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests in the employer contributions at 20% per year after completing two years of service and is 100% vested after six years of credited service. In addition, a participant will become 100% vested in the employer contributions in the event of death or permanent disability.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms shall not exceed five years, except in the case of a loan for the purpose of acquiring a principal residence. Participants may have a maximum of two loans outstanding at any one time. The loans are secured by the balance in the participant's account. The loans will bear a commercially reasonable rate of interest established by the Administrator. The loan interest rate, determined when the loan is drawn, will require a rate commensurate with the prevailing interest rate charged on similar loans. Principal and interest are paid ratably through semimonthly payroll deductions.

**Payment of Benefits** - On retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) may receive the vested portion of the participant's account. The Plan also permits distributions prior to termination of employment (in-service and hardship) upon meeting certain requirements. Distributions of vested balances less than \$1,000 must be made in a single lump sum payment. For vested balances exceeding \$1,000, a participant may elect to receive either a single lump-sum payment or monthly, quarterly, or annual installments over a period of not more than the participant's (or participant's beneficiary in the event of death) assumed life expectancy.

## NOTE 1 - PLAN DESCRIPTION (Continued)

**Forfeited Accounts** - Forfeited nonvested accounts totaled \$5,087 and \$1,995 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions and administrative expenses. In 2024, \$2,957 of forfeitures were allocated to participants.

**Partial Plan Termination** - On March 5, 2020, the shareholders entered into an agreement to reorganize the Company. The reorganization resulted in a partial plan termination. Distributions are offered to impacted participants under the normal plan rules. Due to the reorganization, Plan management voted to permit immediate vesting of the impacted participants. Approximately \$375,000 remains payable to 8 terminated participants at December 31, 2024.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are stated at their estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 3.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value includes the Plan's realized gains and losses on investments that were both purchased and sold during the period as well as unrealized appreciation or depreciation of the investments held at year end.

**Contributions** - Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Notes receivable from participants are considered to be party-in-interest transactions for which a statutory exemption from the prohibited transaction regulation exists.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant loans are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - The Plan's management has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure.

### NOTE 3 - FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* The Plan is invested in a stable value fund, Federated Capital Preservation Fund (the "Fund"). The Fund is a collective trust valued at the NAV of the units owned and the NAV is used as a practical expedient to estimate fair value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. The Fund seeks to provide investors stable principal and high current income, and invests in fully benefit responsive investment contracts ("FBRICs"). The Fund includes FBRICs at contract value, which approximates fair value, in determining NAV. The Fund's investments are comprised of guaranteed investment contracts ("GICs"), separate account guaranteed investment contracts ("SGICs"), synthetic guaranteed investment contracts ("SICs"), money market mutual funds, and other stable value products.

*Self-Directed Accounts* consist of:

- *Bank Deposit Accounts:* Valued at cost which approximates fair value due to the short-term nature of the account.
- *Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common Stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.
- *Common Stock - InsCorp, Inc.:* Value based on recent sales and purchases obtained from InsCorp, Inc.
- *Precious Metals:* Value based on the daily closing price of the asset.
- *Limited Partnerships:* Valued at purchase price, which approximates fair value.

Accordingly, as permitted under such election, the plan administrator has obtained certifications from Capital Bank and Trust, the investment custodian of the Plan, that the information in the accompanying financial statements and supplementary schedule (excluding investments held in self-directed accounts), with respect to investments and related investment activity and notes receivable from participants and related interest income, is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The investment information certified by Capital Bank and Trust is presented based on their certifications.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan participants will become 100% vested in their employer contributions.

**NOTE 6 - TAX STATUS**

The Plan sponsor adopted a standardized pre-approved profit sharing plan sponsored by Tennessee Pension Administrators. Effective July 1, 2022, the Plan was restated to include amendment cycle 3 changes as well as other required changes. Tennessee Pension Administrators received a determination letter dated June 30, 2020, for the restated plan.

Although the Plan has not applied for its own opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As of December 31, 2024 and 2023, outstanding notes receivable from participants were \$102,168 and \$161,169, respectively, which qualify as party-in-interest transactions.

The Plan invests in certain investments that are managed by American Funds. These transactions qualify as party-in-interest transactions, as defined by the Internal Revenue Code. The amount of investments managed by American Funds as of December 31, 2024 and 2023 was \$11,087,711 and \$10,104,846 respectively.

The Plan Sponsor provides the Plan with certain accounting, auditing, and administrative services for which no fees are charged to the Plan.
