Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Cambridge Information Group, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan

The following description of the Cambridge Information Group, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established for the benefit of the employees of Cambridge Information Group, Inc. and its affiliates through substantially common ownership (the “Company”). The Plan qualifies under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company’s management is responsible for the oversight of the Plan and for determining the appropriateness of the Plan’s investment offerings, including monitoring investment performance.

The Plan includes employees of the following companies (collectively, the “Companies”): Cambridge Information Group, Inc. (“CIG”), R.R. Bowker, LLC (“Bowker”), Institute of Art Holdings LLC (“Institute”), Music Makers Holdings LLC (“Music Makers”), Institute of Media and Communications LLC (“IMC”), CIG Education Group, LLC (“CEG”), CIG Professional Services (“CPS”), BrandEd Holdings LLC (“BrandEd”), Emerald Group Publishing, Inc. (“Emerald”) and Mindtools LLC (“Mindtools”).

Eligibility

The Plan covers all employees who are age 21 or older, excluding leased employees, self-employed individuals, collectively-bargained employees, non-resident aliens who do not have United States source income, employees who are residents of Puerto Rico, summer interns, and temporary workers hired for a specific job of limited duration.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (“IRC”). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Description of Plan (Continued)

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% percent on the anniversary of their enrollment date until their deferral rate reaches 15% percent. The Company matches the greater of 50% of the first \$12,000 that a participant defers to the plan, or 50% of the first 6% that a participant defers to the plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations. Highly paid employees are not eligible for qualified non-elective contributions. Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the process of withholding employee contributions from compensation is complete.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company matching contributions and an allocation of the Plan’s earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 33% percent vested after one year of credited service and continues to vest in increments of 33% percent until 100 percent vested after three years of credited service.

Investment Options

Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers common trust funds, mutual funds, and a self-directed brokerage account as investment options for participants. Participants have purchased shares of mutual funds, common stock and interest-bearing cash through the self-directed brokerage account. In the event a participant fails to make an investment election with respect to all or any portion of their account subject to their investment election, the trustee shall invest all or such portion of their account in the investment fund designated by the Plan administrator, which is the appropriate age-based target fund provided by the trustee as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may only have 1 outstanding plan loan at any time. The loans are secured by the balance in the participant's account. Participant repayment terms are generally for a period of up to five years, with exceptions permitted for purchase of a principal residence. The loan interest rate is set at a reasonable rate similar to the rate charged for a loan made under similar circumstances by persons in the business of lending money.

The loan interest rate ranged from 4.25% to 9.50% for loans outstanding as of December 31, 2024 and from 4.25% to 9.25% for loans outstanding as of December 31, 2023.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$40,101 and \$34,891, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, plan administrative expenses were reduced by \$14,560, from forfeited nonvested accounts, in accordance with plan provisions. During 2023, employer contributions were reduced by \$24,934 and plan administrative expenses were reduced by \$18,460 from forfeited nonvested accounts, in accordance with plan provisions.

Payment of Benefits

On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the vested interest in their account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 59 1/2, in certain hardship situations, and other situations as detailed by the Plan Document. The Plan, in line with the IRS rules, also requires the participants to receive Required Minimum Distributions once they reach the age stipulated by law. A participant may elect to receive a lump sum payment or may roll over the value of their account into another qualified plan. In the event a participant terminates or retires and the participant's vested balance is less than \$5,000, the balance will be rolled into an IRA if in excess of \$1,000 or paid in the form of a lump sum distribution if less than \$1,000.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 1, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are actively traded.

Investments measured at net asset value: Consisting of common-collective trusts, valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

the underlying fund by investing in substantially all of the securities and in approximately the same proportions as the S&P 500 Index.

(d) The fund invests in stable value investment contracts and in fixed income instruments which underlie stable value contracts as well as in money market instruments. The fund seeks to earn current income and preserve capital and stability of principal.

4. Transfers Into or Out of the Plan

Effective October 1, 2024, the Plan was amended to include employees of Emerald and Mindtools. The Plan Sponsor remains unchanged. Employees of the newly added entities became eligible to participate in the Plan in accordance with its terms and provisions. This amendment does not affect the rights or obligations of existing participants. Transfers into the Plan totaled \$1,176,487 representing the movement of participant assets from qualified plans due to the addition of new participating companies. All transfers were made at fair value in accordance with the provisions of the Plan and applicable U.S. GAAP. These transactions did not affect the net assets available for benefits beyond the reported amounts and were executed in compliance with ERISA and relevant regulatory requirements.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, T. Rowe Price Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

6. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Tax Status

The Plan adopted a pre-approved plan offered by T. Rowe Price Retirement Plan Services, Inc. The pre-approved plan received an IRS Opinion Letter dated August 19, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
