## Independent Auditors' Report

To the Administrative Committee of  
CompTech 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of CompTech 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

## **Basis for Opinion**

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the CompTech 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan sponsored by CompTech Computer Technologies, Inc. and its affiliated company StaffTech, Inc. (referred to collectively as the Company or Plan Sponsor) and covers all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Under the terms of the Plan, there are three separate eligibility provisions:

- Each employee who has been credited with at least one hour of service, which constitutes as covered employment under the Davis-Bacon Act or any state or municipal "prevailing wage" law, is eligible for prevailing wage contributions.
- Covered employees are eligible to become participants and participate in salary deferrals when they have attained age 21 and have completed 30 days of service with the Plan Sponsor. An eligible employee becomes a participant on the first day of the month coinciding with, or next following, the date on which the eligibility requirements were met.
- In order to share in any discretionary non-elective profit sharing contributions or qualified employer matching contributions, a participant must earn at least 1,000 hours of service during the Plan Year and be employed as of the last day of the Plan Year.

Contributions

- (a) *Participant's voluntary salary reductions.* Participants may elect to contribute up to 100% of their compensation. Each participant's contribution may not exceed the federal maximum amount pursuant to section 402(g)(5) of the Internal Revenue Code. The Plan provides for catch-up contributions for participants over the age of fifty (50); however, catch-up contributions are not considered when determining employer-matching contributions. The Plan contains an automatic deferral feature (3% default rate) with an opt-out provision. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plan (rollover).

Contributions (Continued)

- (b) *A discretionary employer-matching contribution.* The matching contribution, if any, will be determined each year by the Board of Directors of the Company at its sole discretion. The Plan provides that deferrals of up to 6% of gross wages are eligible to be matched at 50%. Matching contributions of \$299,246 were contributed to the Plan by the Company for the year ended December 31, 2024.
  
- (c) *A discretionary non-elective profit sharing contribution.* The non-elective profit sharing contribution, if any, will be determined each year by the Board of Directors of the Company at its sole discretion. This amount will be allocated based on compensation of all participants eligible to share in the discretionary amount. To qualify for the discretionary profit sharing contribution, a participant must have completed 1,000 hours of service during the Plan Year and be employed as of the last day of the Plan Year. For the year ended December 31, 2024, the Company made no non-elective profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's own contributions, employer contributions, rollover contributions, and a share of the Plan's investment income and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee deferrals, employer contributions, and direct rollovers in any of several different mutual funds, common collective trust funds, or a group variable annuity guaranteed income option.

Notes Receivable from Participants

The Plan allows participants to apply for and obtain loans in an amount as defined in the Plan Agreement. Generally, loans must be for at least \$1,000 and may not be for more than the lesser of 50% of the participant's vested account balance or \$50,000 (reduced by outstanding loans in the previous year). All loans must be repaid within five years unless the loan is used to acquire or construct the participant's primary residence. Interest is charged at the prime rate plus one percent at the time the loan is issued. Principal and interest is paid ratably through payroll deductions.

Vesting

Participant vesting is based on service years. Participants are 100% vested in the voluntary salary deferrals and rollover contributions. In addition, a participant will become fully vested upon attainment of normal retirement age or upon death or disability while an employee of the Plan Sponsor. All other employer contributions vest according to the following schedule:

Years of Service	Non-Forfeitable Percentage
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 or more	100%

Forfeited Accounts

Forfeitures of non-vested contributions will be used to first pay administrative expenses. The remaining forfeitures will be used to reduce future employer contributions payable under the Plan. During the year ended December 31, 2024, forfeitures of \$3,938 were used to pay administrative expenses and \$37,751 were applied against employer contributions. Unallocated forfeitures at December 31, 2024 and 2023, were \$19,873 and \$41,422, respectively.

Payment of Benefits

Participants become eligible for benefit payments upon retirement, termination of employment, disability, or death. Additionally, the Plan provides for in-service distributions after a participant has reached age 59 ½ up to their fully vested account balance. Participants may also receive distributions from the employee deferral or rollover balance for qualified financial hardships. Distributions may be made as a single lump-sum payment, partial withdrawals, or installments over a period of not more than the participants' assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary). Vested account balances that do not exceed \$5,000 may only be distributed in a single lump-sum payment. If a participant has terminated employment, he or she must begin receiving benefits no later than April 1, of the calendar year following the year in which he or she reaches age 72. Benefit distributions are recorded when paid.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan a distribution, the note balance is reduced and a withdrawal is recorded.

Administrative fees

Administrative fees are paid for by both the Plan and the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value, investments at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the Trustee of the Plan.

**NOTE D - FAIR VALUE MEASUREMENTS**

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

*Level 1* - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no change in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the closing price of the shares held by the Plan at year-end reported on the active market on which the individual securities are traded.

*Common Collective Trust Funds* - Valued based on the NAV of units of the common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Plan had no unfunded commitments and no redemption restrictions related to common collective trust funds at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\*Investments measured at fair value using net asset value (NAV) per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

**NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Financial Group which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Financial Group as of December 31, 2024 and 2023, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is reset semi-annually by the issuer but may not be less than 0.00%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer or might result in surrender charges. Such events include the following: (1) amendment to the Plan Document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs or a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

The average yields for the fund as of December 31, 2024, are as follows: (1) average yield based on actual earnings is 4.75%; (2) average yield based on interest rate credited to participants is 4.75%.

**NOTE F - INCOME TAX STATUS**

Effective February 1, 2018, the Plan Sponsor restated the Plan and adopted a Principal Financial Group prototype plan dated January 26, 2014. Principal Financial Group obtained an Advisory Letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees paid by the Plan to the trustee, Principal Trust Company, qualify as party-in-interest transactions. Certain investments offered by the Plan are managed by Principal Financial Group. Principal Financial Group is a Plan Trustee; therefore, these transactions qualify as party-in-interest transactions.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J - NONEXEMPT TRANSACTIONS**

During 2024 and 2023, the Company inadvertently failed to deposit \$83,305 and \$3,800 of participant deferral contributions, respectively, to the Plan within the required time period described in 29 CFR 2510.3-102, as stated by the United States Department of Labor regulations.

**NOTE K - SUBSEQUENT EVENTS**

Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
