## INDEPENDENT AUDITOR'S REPORT

To the Trustees & Plan Administrator of  
Bituminous Paving Employee's Profit Sharing Plan & Trust  
Ortonville, Minnesota

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bituminous Paving Employee's Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Bituminous Paving Employee's Profit Sharing Plan & Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1: Description of Plan**

The following description of the Bituminous Paving Employee's Profit Sharing Plan & Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The plan is a defined contribution plan established by Bituminous Paving, Inc. (the Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), as well as certain provisions of the federal income tax laws.

Participation in the plan is entirely voluntary. An eligible employee is any person employed by the Company, who has completed six months of service and has attained age 18 or older. The entry date for participant deferrals is the date that the eligibility requirements are satisfied. The entry date for discretionary profit sharing contributions is the first day of the Plan year during which the eligibility requirement for profit sharing contributions as discussed below is met, if this requirement is met in the first six months of the year. If the requirement as discussed below is met in the second six months of the year, the entry date for profit sharing contributions will be the first day of the Plan year following the date on which eligibility requirement is satisfied. Employees covered by a collective bargaining agreement, leased employees, and non-resident aliens are excluded from eligibility.

**Contributions**

Participants may elect to contribute a percentage of their compensation to the plan each year, subject to limitations, as defined in the Plan documents. Participants have the option to make pre-tax contributions or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, in its sole discretion, make a profit sharing contribution to the Plan on behalf of eligible employees who have completed at least one year of service and are employed on the last day of the Plan year. The Company made a discretionary profit sharing contribution of \$1,900,000 for the year ended December 31, 2024. Additionally, the Company may make qualified nonelective contributions for the benefit of all participants eligible to make elective deferrals. All contributions are subject to certain statutory limits.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's profit sharing contribution, and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Elections**

The participant contributions and the company profit sharing contributions are allocated to the various investment options offered by the Plan as directed by the participant. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her accounts balances.

**Vesting**

Participants are immediately 100 percent vested in their contributions, rollover contributions, and actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime Rate on the first business day of the month the loan is originated. At December 31, 2024, interest rates ranged from 3.25 percent to 8.50 percent. Principal and interest are paid ratably through weekly payroll deductions.

**Payment of Benefits**

Benefits may be paid to the participant or beneficiary upon death, retirement, total and permanent disability, voluntary or involuntary termination of employment as defined in the Plan. The Plan provides for normal retirement at age 65. Participants may withdraw a portion of their account balance as an in-service distribution if they have attained age 59 ½ or for a hardship, as defined in the Plan. Benefits are distributed in the form of a lump sum amount, rollovers, transfers to annuities, or in installments over varying periods, as allowed by the Plan.

If a participant terminates employment and their vested balance is \$7,000 or less, the Plan Administrator will direct the trustee that any amount exceeding \$1,000 be distributed to an IRA. Account balances less than or equal to \$1,000 will be distributed to the participant in a lump sum as soon as administratively feasible after termination of employment. The distribution may be made directly to the participant or rolled over to another qualified retirement plan or to an IRA at the participant's direction.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant, as defined by the Plan. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment-related expenses are included in net appreciation in fair value of investments.

**Forfeited Accounts**

Generally, when a participant terminates participation in the plan, the nonvested portion of the participant's account, as defined by the plan, represents a forfeiture. Forfeitures are utilized to reduce the company profit sharing contributions or for payment of plan expenses. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan, the participant's account will be reinstated.

Forfeited non-vested accounts totaled \$14,859 and \$44,452 at December 31, 2024 and 2023, respectively. During 2024, \$41,709 of forfeitures were used to pay plan expenses. Any remaining forfeitures will be allocated to participants in any year when there is a discretionary employer contribution.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 4 for discussion of the fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed as incurred.

**Subsequent Events**

Subsequent events were evaluated through September 25, 2025, the date the financial statements were available to be issued.

**Note 3: Information Certified by Trustees**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value fair of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the trustees of the plan).

**Note 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data, by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Pooled separate accounts are valued based upon the unit values of such pooled separate accounts held by the plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation and other means, although they are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled separate accounts, there are no unfunded commitments or redemption restrictions. Participant directed redemptions can be made on any business day and do not have a redemption notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5: Investment Contract with Insurance Company**

The Plan's guaranteed income fund is a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America, an affiliate of the Plan trustee. Empower Annuity Insurance Company of America maintains the contributions to the investment contract in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events initiated at the Plan-level (including but not limited to spin-offs, sales, mergers, and full or partial plan termination) could limit the ability of the Plan to transact at contract value with the contract issuer. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer that have been established. Empower is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is calculated by Empower and is reset at least quarterly and will never be less than 0%.

**Note 6: Related Party Transactions and Transactions with Parties-In-Interest**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, services providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$43,947 to certain parties-in-interest for administration and advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Investments include shares of pooled separate accounts managed by the trustees as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid using investment earnings rather than a direct payment.

**Note 7: Income Tax Status**

The Plan sponsor has adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan and the prototype plan have been amended since receiving the opinion letter. The Plan is required to continue to operate in conformity with the IRC to maintain its qualification. Plan management believes that the Plan is designed and is currently being operating in compliance with the applicable sections of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a Plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

**Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment funds. Investment funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment funds will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10: SECURE Act 2.0**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

During the year ended December 31, 2024, the plan implemented the following optional provision set forth by the SECURE 2.0 Act on an operational basis:

- Increase in Cash-Out Limit – Effective January 1, 2024, the Plan increased the threshold for involuntary cashouts from \$5,000 to \$7,000 in accordance with Section 304.

Formal amendments reflecting these provisions have not been executed as of the date the financial statements were available to be issued. However, the Plan sponsor intends to make all necessary amendments by the applicable deadline with IRS Notice 2024-2.
