### Note 1 - Description of plan:

The following description of The Integral Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor is The Integral Group, LLC (Integral). The Plan is a defined contribution plan covering substantially all employees of Integral, Integral Development, LLC, Integral Youth and Family Project, LLC, Primary Code, and Integral Property Management, LLC (collectively the Company, Plan Sponsor, or Plan Administrator).

The Plan's eligibility requirements are as follows: eligible employees must be at least 20 years of age and complete one month of service to participate in the Plan. Eligible employees may participate in the Plan on the first day of the month following attainment of eligibility requirements. The Plan Sponsor provides for safe-harbor matching contributions which are available to all participating employees. All employees of the Plan Sponsor are eligible to participate in the Plan with the exception of employees subject to collective bargaining, leased employees, and non-resident alien employees with no U.S. source income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Employees are automatically enrolled in the Plan after attaining eligibility unless they elect otherwise. Automatically enrolled employees are enrolled at a 3% deferral rate unless they elect another deferral rate. Participants may elect to contribute amounts up to current Internal Revenue Service (IRS) limitations through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch up contributions. The Company provides safe-harbor employer matching contributions equal to 100% of each participant's contribution up to the first 3% of eligible compensation and 50% of participant's contributions on the next 2% of eligible compensation, as defined. The Company also has the option to provide a discretionary employer profit-sharing contribution, which is allocated to all eligible participants in accordance with the Plan document. The Company did not make a discretionary profit-sharing contribution for the 2024 Plan year.

The Company is required to make an annual match true-up contribution. For the 2024 and 2023 Plan years, the Company calculated a match true-up contribution of \$8,451 and \$7,408, respectively. These amount are included in employer receivables on the statements of net assets available for benefits and in employer contributions on the statement of changes in net assets available for benefits.

#### Contributions - continued

The Plan also has a Roth contribution provision which gives participants the option of also contributing amounts to their individual Roth accounts which are maintained separately from pre-tax contributions. Roth contributions are matched at the same rate as pre-tax contributions, as noted above.

Participants may direct both employee and employer contributions to any of the Plan's fund options. Participants may change their investment options daily and their contribution elections monthly.

#### Participant accounts

Each participant's account is credited with the participant's contributions, the Company's safe-harbor matching contributions, an allocation of the Company's profit-sharing contribution, if any, Plan expenses, and Plan earnings.

Allocations of profit-sharing contributions are based on eligible compensation as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,876 and \$12,245, respectively, and are included in the stable value fund investment. Forfeited non-vested accounts may be used to pay Plan expenses or reduce employer matching contributions. However, a portion of the forfeitures balance relates to uncashed participant distribution checks, which cannot be used to pay Plan expenses or to reduce employer matching contributions. The portion of the forfeitures balance that is not available for use totaled \$12,418 and \$12,245 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or to pay Plan expenses.

#### Vesting

Participants are immediately vested in their voluntary contributions and Company safe-harbor matching contributions, plus actual earnings thereon. Participants vest in employer profit-sharing contributions in accordance with the following schedule:

1	33%
2	66%
3	100%

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company.

#### Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, or retirement. Participants are required to take distributions as lump-sum payments, with the exception of required minimum distributions. In-service withdrawals of a participant's account are permitted at age 59 1/2 and in cases of proven financial hardship. As noted in the above amendment, if a participant's account balance is over \$1,000, but less than \$7,000, excluding rollover contributions, upon termination of service, an Individual Retirement Account will be setup in the name of the participant into which their account balance will be deposited. Participants with a balance of \$1,000 or less will be distributed directly to the participant in a single lump-sum cash distribution. Participants with a balance of \$7,000 or more, excluding rollover contributions, may leave their balance in the Plan after termination.

#### Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are for a maximum of five years. Participants may have two notes outstanding at any given time. Notes are secured by the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may prepay their notes at any time.

Notes receivable from participants - continued

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan Sponsor. The Company pays a portion of administrative expenses of the Plan. Fees charged for processing notes receivable from participants, as well as other account transaction fees, are charged directly to the accounts of applicable participants. Total administrative fees paid by the Plan during the year ended December 31, 2024 totaled \$105,646.

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Stable value fund

The Plan has a guaranteed investment contract with Empower Trust Company, LLC (Empower Trust) that invests contributions in the Great-West Key Guaranteed Portfolio Fund. The Great-West Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest rate may not be less than 0%. The interest crediting rate is reset quarterly. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Empower Trust may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. Generally, a 90 day notice is required by either party to discontinue the contract. Empower Trust may elect to defer payment of the contract for up to 12 months after the contract is discontinued.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options, 3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or 4) failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### Investment valuation and income recognition

The Plan's mutual fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Investment valuation and income recognition - continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment company funds (mutual funds) are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges. These investments are actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, Empower Trust Company, LLC.

#### Note 4 - Party-in-interest transactions:

The custodian and its affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan also has a third party administrator. The Plan pays a portion of administrative expenses while the Plan Sponsor pays the remainder of administrative expense. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts will become fully vested.

Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

Note 7 - Correction of operational issues:

For the 2020 Plan year, multiple delinquent contributions were identified that require corrective action. The Plan Sponsor calculated lost earnings associated with the delinquent contributions and deposited those monies into the Plan in August 2024.

For the 2021 Plan year, multiple delinquent contributions were identified that require corrective action. The Plan Sponsor calculated lost earnings associated with the delinquent contributions and deposited those monies into the Plan in August 2024.

For the 2022 Plan year, multiple delinquent contributions were identified that require corrective action. The Plan Sponsor calculated lost earnings associated with the delinquent contributions. These monies will be deposited into the Plan as soon as administratively feasible to make the affected participants whole.

For the 2024 Plan year, multiple delinquent contributions were identified that require corrective action. The Plan Sponsor has indicated they will work with the Plan's third-party administrator to calculate lost earnings on these contributions so that they can be remitted to the Plan to make the affected participants whole.

Delinquent contributions are presented chronologically, by year, in the supplemental Schedule 4a - Schedule of Delinquent Participant Contributions, which accompany these financial statements.
