**NOTE 1 DESCRIPTION OF PLAN**

The Ballet Makers Inc. Salary Reduction 401(k) Plan (Plan) is administered by Ballet Makers, Inc. (Company, Plan administrator, or Plan Sponsor). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document that are available from the Company.

**General**

The Plan is a voluntary, participant-directed, defined contribution savings plan that became effective June 1, 1988. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees, excluding employees covered by a collective bargaining agreement, nonresident aliens and employees under the age of 21, are eligible to participate in the Plan. Effective July 2, 2018, part-time, seasonal, and temporary employees are not eligible to participate in the Plan, until they complete 1,000 hours of service. An employee is automatically enrolled in the Plan on the first day of the following month after meeting the eligibility requirements, unless the employee elects to opt out of the Plan.

**Contributions**

Participants can make voluntary contributions up to 75% of their eligible compensation, up to the annual Internal Revenue Service (IRS) dollar limit. The participant may elect to roll over contributions, subject to approval by the Plan Sponsor, that were received from another qualified plan. Participants, age 50 or older, may make an additional contribution subject to IRS limitations. The Company may make matching contributions on participants' behalf in an amount determined by the Board of Directors. The Company may also make additional discretionary contributions to all eligible participants who are enrolled in the Plan on the last day of the Plan year, which is December 31, in such amount as the Company determines. The discretionary contributions, if made, are allocated in the ratio that the sum of each eligible participant's total compensation bears to the sum of all eligible participants' compensation. No discretionary contributions were made for the years ended December 31, 2024 and 2023. Eligible employees receive an employer match of 50% of the employee contribution, up to a maximum of 4% of the participant's eligible compensation.

**Investment Options**

Upon enrollment in the Plan, participants may direct their employee and Company contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's matching and discretionary contributions; (b) Plan earnings, gains or losses; and (c) charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balances, as defined in the Plan Document.

**Vesting**

Participants are immediately 100% vested in their voluntary employee contributions, rollover contributions, plus earnings thereon. Vesting of the Company's discretionary matching contributions are based on years of vesting service. A participant with less than two years of credited service is 0% vested. Vesting increases 20% per year from year two through year six. Participants become 100% vested upon attainment of age 65, or completion of six years of service in the Plan, or upon death or disability of the participant.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months), whichever is less. Participants may only have one loan outstanding at any given time. Loans bear a rate of interest, as determined by the Plan administrator, based on the prevailing interest rates charged by persons in the business of lending money for notes that would be made under similar circumstances. The interest rate will remain fixed throughout the duration of the loan. Terms depend on the type of note; a general note must be repaid within 5 years, while notes used to acquire a primary residence shall be repaid over a 10-year period. Notes must be repaid through payroll deductions and are secured by the balances in the participants' accounts. If a participant is terminated prior to repayment of the loan balance, the remaining balance on the loan is considered to be a deemed distribution to the participant.

**Payment of Benefits**

After retirement, death, or disability, participants are entitled to receive a lump-sum distribution, monthly installments, or annual installments. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as the later of April 1 following the calendar year of attaining the age of 72 or age at retirement. If participants are still employed by the age 72, the mandatory distribution date generally is April 1 following the termination date of employment. Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA), or distributed in a lump-sum payment or partial withdrawals. If the participant's vested balance is \$1,000 or less, the participant will receive a lump-sum distribution without consent.

Hardship withdrawals are subject to approval by the Plan administrator and also subject to income tax withholding and penalties.

**In-Service Withdrawals**

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

**Retirement**

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

**Forfeitures**

Forfeitures are used to pay administrative expenses and, if any, the remaining amount will be used to offset employer contributions. The balance in the forfeiture account at December 31, 2024 and 2023 was \$6,416 and \$5,999, respectively. During the years ending December 31, 2024 and 2023, the Plan used \$7,350 and \$14,700, respectively, to offset administrative expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in March 2025 and 2024, respectively.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expense and Participant Transaction Fees**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Mutual Fund Fees**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

**Subsequent Events**

The Plan has evaluated its subsequent events through August 26, 2025, the date that the financial statements were available to be issued.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management and Trust Company, the trustee of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 input)

*Common/Collective Trusts* – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. (Level 2 input)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are held by Fidelity Management and Trust Company, the trustee, as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions.

Notes receivable from Plan participants qualify as party-in-interest transactions.

**NOTE 6 PLAN TERMINATION**

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions, as of the termination date.

**NOTE 7 TAX STATUS**

The prototype Plan Sponsor obtained an opinion letter from the IRS in June 2020, in which the IRS stated that the prototype Plan Document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended; however, the Plan administrator believes the Plan is being designed and operated in compliance with the Plan Document and applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

**NOTE 8 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 CONCENTRATION**

As of December 31, 2024 the Plan held two investments that represented 27% of net assets available for benefits. As of December 31, 2023, the Plan held two investments that represented 27% of net assets available for benefits.
