### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Fabick 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **Note 1. Description of the Plan**

### ***General***

The following description of the Fabick 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by John Fabick Tractor Company (the “Company”) for the benefit of its employees who are not covered by a collective bargaining agreement. Employees are eligible to participate in the Plan immediately upon hire. Related employers who also participate in the Plan include John Fabick Tractor Company, JFTCO, Inc., Fabick Mining, Inc., Fabick Tractor Company, Fabick Bros. Equipment Company, Fabick Machinery Co., Fabick and Company, Rental Equipment Company, Gateway Machinery Co., Fabick Power Systems, Inc., and Fabick Southwest Co. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). T. Rowe Price Trust Company is the trustee of the Plan (“trustee”).

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides for a discretionary employer matching contribution of 50% of the first 6% of compensation deferred, as defined in the Plan Document. The Plan also provides for discretionary profit-sharing contributions. Participants must be employed on the last day of the Plan’s year to be eligible for an allocation of the employer’s discretionary profit-sharing contribution. The employer’s discretionary profit-sharing contribution shall be allocated to eligible participants based upon the ratio of the participant’s eligible compensation as compared to the eligible compensation of all eligible participants, as defined.

The Plan provides for both pre-tax and after-tax contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). For eligible participants, the Plan allows for in Plan Roth rollover contributions and in Plan Roth transfers for certain portions of participant accounts.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant. Participants may choose not to contribute or to contribute a higher percentage. The Plan provides for a 1% automatic deferral increase in March of each year, provided the participant has a deferral rate of at least 1% and less than 15%, unless a contrary opt out election is made.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the Company’s contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and the participating employer's contributions and profit sharing contributions plus earnings thereon.

***Payment of Benefits***

Benefits may be paid to the participant or beneficiary upon termination of service, including death, disability, or retirement. For terminated participants the Plan automatically distributes the vested value of an account balance, as defined, if less than \$1,000, in a lump-sum amount. If the vested value of an account balance is greater than \$1,000 but does not exceed \$5,000, and if no timely election information is received from the terminated participant, the balance will be transferred in a lump sum to an IRA established by T. Rowe Price Trust Company in the participant's name. Vested account balances with a value greater than \$5,000 shall be distributed in a lump sum upon the terminated participants' request. The Plan also provides for in-service distributions to participants who have attained the age of 59 1/2.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$113,159 and \$90,458, respectively. Forfeited nonvested amounts may be used to reduce employer contributions or may be used for administrative expenses of the Plan. Forfeitures used to reduce employer contributions or to reduce administrative expenses of the Plan amounted to \$94,081 and \$1,480 during the years ended December 31, 2024 and 2023, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Mutual funds and the self-directed brokerage account are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan also holds interest in common collective trust funds, which are valued daily utilizing the values of the underlying assets which are based on information reported by the investment advisor using the audited financial statements of the collective trust funds at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by T. Rowe Price Trust Company as of December 31, 2024 and 2023. T. Rowe Price Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$69,520 and \$65,015 of recordkeeping fees to the trustee during the years ended December 31, 2024 and 2023, respectively. The Company pays certain expenses and accounting and auditing fees related to the Plan. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets

**Investments**

Such investments are classified in Level 2 of the valuation hierarchy. There were no Level 2 or 3 investments identified.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 7. Tax Status**

The plan operates under a non-standardized adoption agreement in connection with a pre-approved profit-sharing plan and trust sponsored by T. Rowe Price Retirement Plan Services, Inc. This prototype Plan Document has been filed with the appropriate agency and has obtained a determination letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 9. Subsequent Events**

### ***Plan Amendment***

Effective January 1, 2025, the Plan was amended to implement a two-year cliff vesting schedule for discretionary employer matching contributions, meaning participants will become fully vested in these contributions after completing two years of service. Additionally, the Plan was amended to allow participant loans, which will be administered in accordance with ERISA guidelines and the Plan's loan policy. These amendments do not impact the financial statements as of December 31, 2024, but will be reflected in future reporting periods.

Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued.
