NOTE A -- Description of plan and significant accounting policies

The following brief description of Prairie State Legal Services, Inc. 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Prairie State Legal Services, Inc., (employer) has adopted, with subsequent amendments, the OneAmerica Financial Partners, Inc. 403(b) Volume Submitter Plan, under the name, Prairie State Legal Services, Inc. 403(b) Retirement Plan, with the most recent restatement effective June 1, 2019.

The original effective date of the Plan was January 1, 1998.

General

The Plan is a defined contribution profit sharing plan with elective deferral 403(b) features covering all employees with no service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 37-1030764, and the Plan's number is 002.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the limits set by the Internal Revenue Code (IRC). The Plan allows for Roth deferrals in addition to pretax deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

The employer may make a matching contribution at a discretionary matching percentage. To qualify for the matching amounts, the participants must have one year of service, which is defined as completing 1,000 hours of service during the relevant eligibility computation period. In applying this matching percentage, only elective deferrals up to the discretionary amount of compensation per year will be considered. For 2024, the employer's matching contribution was 100% of participant's deferrals up to \$2,000.

Additional amounts may be contributed at the discretion of the employer and are allocated based on annual compensation and years of service. The participant must complete 1,000 hours of service during the plan year and be employed by the organization on the last day of the plan year to be eligible for any additional discretionary contributions. The employer made additional discretionary contributions of \$862,906 for the year ended December 31, 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the employer.

Participant accounts and "rollovers"

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's matching and nonelective contribution, (b) Plan earnings, (c) forfeitures of terminated participants' nonvested accounts in excess of reasonable plan expenses, and (d) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocations of employer contributions are based on participants' compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a participant's rollover account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants, who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Participant loans

Participants may not borrow from their fund accounts.

Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect a lump-sum payment in an amount equal to the value of the participant's vested interest in his or her account. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at age 59½. A participant with an account valued at \$5,000 or less shall receive a lump sum distribution. For accounts exceeding \$5,000 the participant may elect a lump sum distribution or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to rollover the distribution to another qualified plan.

Forfeited accounts

Forfeited nonvested accounts totaled \$0 at December 31, 2024 and 2023. Forfeited nonvested accounts of a participant (forfeiture) are used to pay reasonable Plan expenses first and then allocated to participants in the same manner as employer's discretionary contributions. For the year ended December 31, 2024, \$0 of forfeited nonvested accounts were used to pay Plan expenses and \$72,905 was used to reduce employer contributions.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

Income, gains and losses from the assets in each account are credited or charged against that account without regard to other income, gains or losses of American United Life Insurance Company (AUL) or any other separate account. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The earnings and losses of the Plan, including unrealized investment appreciation, are allocated daily on the basis of individual participant balances at the end of the previous day.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The Plan participants pay most of the administrative expenses of the Plan. The major administrative expenses are professional fees.

Subsequent events

These financial statements have not been updated for subsequent events occurring after September 26, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

NOTE B -- Information certified by asset custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by AUL, the asset custodian of the Plan.

NOTE C -- Fair value measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Stable value collective trust fund. A stable value fund composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.
- Pooled separate accounts. The pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. AUL owns the underlying investments in the separate accounts. The underlying measurements for the separate key prices are for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value of the separate account is not publicly quoted.

NOTE D -- Party-in-interest transactions

AUL is the asset custodian of the Plan as of and for the year ended December 31, 2024, and is therefore designated as a party-in-interest. Gallagher Benefit Services, Inc., and Kestra Advisory Services, LLC provide consulting and advisory services to the Plan. In addition, SVA Certified Public Accountants, S.C. provides accounting services to the Plan and employer. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

AUL provides certain administrative and advisory services to the Plan pursuant to a Services Agreement between the employer and AUL, for which there is no explicit charge to the Plan. Instead, AUL receives revenue from mutual fund service providers for services provided to the funds.

NOTE E -- Tax status

The OneAmerica Financial Partners, Inc. 403(b) Volume Submitter Plan that the Plan has adopted effective June 1, 2019, obtained its latest opinion letter on November 22, 2017, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 403 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE F -- Plan termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Note H -- Plan Amendments

Effective January 1, 2024, the Plan was amended to incorporate certain temporary relief provisions under the CARES Act in response to the COVID-19 pandemic. These included expanded distribution and loan options for eligible participants, as well as the waiver of required minimum distributions for the year. The provisions were implemented in accordance with applicable IRS guidance and were intended to provide financial flexibility during the crisis.

NOTE I -- Subsequent event

Effective January 1, 2025, Voya Financial (Voya) acquired the full-service retirement plan business of OneAmerica Financial, including OneAmerica Retirement Services LLC and OneAmerica Investment Advisory Services. The retirement plan is expected to transition to Voya during the first half of 2026.
