Independent Auditor's Report

To the Plan Administrator

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of 401(k) Profit Sharing Plan of Elderly Housing Management, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

*Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

*Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1 - Description of Plan**

The following description of 401(k) Profit Sharing Plan of Elderly Housing Management, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution retirement plan covering all eligible employees of Elderly Housing Management, Inc. and New Samaritan Corporation d/b/a Mansfield Center for Nursing and Rehabilitation (collectively referred to as the "Company") who complete one month of service and are at least 21 years of age. Nonresident aliens, residents of Puerto Rico and part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On August 1, 2024, New Samaritan Corporation d/b/a Mansfield Center for Nursing and Rehabilitation ("MCNR") was sold to National Health Care Associates, Inc. Following this transaction, the Company suspended all contributions from MCNR and all employees who were acquired in the transaction became eligible to participate in the NHCA and Affiliates Retirement and Savings Plan ("NHCA Plan"). Company employees who were acquired by National Health Care Associates, Inc. had their account balance rolled over into the NHCA Plan, all other employees were eligible to take a distribution from the Plan or roll over their account balance into an individual retirement account. In conjunction with the sale of MCNR, the Plan was amended to provide an employer contribution equal to 4.5% of eligible compensation for employees of MCNR that were still employed as of July 31, 2024, provided they had completed at least 580 hours of service. The MCNR contribution totaled approximately \$80,000, but due to the timing of the funding of the contribution, it was subsequently deposited to the NHCA Plan.

**Contributions**

Participants may make salary deferral contributions to the Plan based on a percentage of their pre-tax annual compensation, as defined by the Plan. Participants may begin to make salary deferral contributions immediately following the satisfaction of the Plan's eligibility requirements. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. The Plan contains an Eligible Automatic Contribution Arrangement whereby all newly eligible employees will automatically have 3% of their pre-tax compensation withheld, unless another percentage is elected. This automatic deferral will increase by 1% on the first day of the second Plan year following the Plan year in which the automatic deferral election first becomes effective and every year thereafter until a maximum deferral of 6% of compensation is reached. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover).

Each year, the Company contributes an amount to the Plan equal to 6% of eligible compensation for employees of Elderly Housing Management, Inc. All employees who are considered "highly compensated employees", as defined in the Internal Revenue Code (the "IRC"), will be limited to a Company contribution of 3% of eligible compensation. In order to receive an allocation of the Company contribution, a participant must complete a year of service, be employed on the last day

of the Plan year and have completed at least 1,000 hours of service during the Plan year. For the year ended December 31, 2024, the Company made contributions to the Plan totaling \$441,923. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds, a money market fund, a common collective trust fund and a fully benefit-responsive fixed annuity contract as investment options for participants. All contributions are subject to certain IRC limitations.

**Participant accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participant accounts are also charged with an allocation of certain administrative and investment management expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their elective deferrals and any rollover contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the Company contribution portion of their account. For all other participants, vesting in the Company contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

Effective July 31, 2024, all MCNR employees who were acquired in the transaction by National Health Care Associates, Inc. became fully vested in their employer contributions.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account. The loan interest rate, determined at the time of the loan, is currently set at the Prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

On termination of service for any reason, participants with an account balance of \$7,000 or less will receive a lump-sum distribution equal to the vested interest in their account. For a participant or beneficiary with a vested account balance less than \$7,000, who elect not to receive a lump-sum distribution, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with vested account balances greater than \$7,000 may elect to receive a single lump-sum amount, installments, or one

of the various forms of annuities offered by the Plan. Participants with vested account balances greater than \$7,000 may also elect to defer receipt of their benefit until a later time.

Withdrawals from the participant's salary deferral contribution portion of their account may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. In-service withdrawals are also allowed from the accounts of participants who have attained age 59½ or become disabled in accordance with the provisions specified in the Plan.

**Forfeited accounts**

When a participant is terminated, nonvested employer contributions are forfeited by the participant. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,837 and \$3,545, respectively. Forfeitures may be used to reduce future employer contributions to pay Plan expenses. For the year ended December 31, 2024, forfeited nonvested accounts of \$7,606 were utilized to reduce employer contributions and \$7 were utilized to pay Plan expenses.

**Note 2 - Summary of accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment valuation and income recognition**

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The nonelective contributions from the Company are recorded in the year in which the contributions are earned.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Account maintenance fees, distribution fees, fees related to notes receivable from participants and certain investment management fees are charged directly to the respective participant's account

and are included in administrative expenses. Other indirect investment related expenses are included in the net appreciation in fair value of investments.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events**

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

**Note 3 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC the trustee, and Massachusetts Mutual Life Insurance Company ("MassMutual"), the custodian.

**Note 4 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under the Financial Accounting Standards Board issued Accounting Standards Codification Topic 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the funds. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

*Common collective trust fund:* Valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 5 - Fully benefit-responsive investment contract**

The Plan has entered into a fully benefit-responsive fixed annuity contract with MassMutual totaling \$3,290,665 and \$4,049,624 as of December 31, 2024 and 2023, respectively. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semi-annually for resetting. The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate

permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The contract with MassMutual is reinsured by Empower Annuity Insurance Company of America. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7 - Tax status**

The Plan has been designed using a pre-approved defined contribution plan document sponsored by Empower Retirement LLC. Empower Retirement, LLC received an opinion letter dated November 14, 2022 in which the IRS stated that the pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is deemed to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - Related party transactions and party-in-interest transactions**

Plan investments include mutual funds, a money market fund and a common collective trust fund held by Empower Trust Company, LLC and a fixed annuity contract held by Empower Annuity Insurance Company of America. Empower Trust Company, LLC is the trustee and Empower Annuity Insurance Company of America is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Fees paid directly by the Plan to these parties-in-interest for administrative expenses amounted to \$43,270 for the year ended December 31, 2024. Fee paid directly by the Plan to the investment advisor, also a party-in-interest, for certain investment advisory services amounted to \$15,550 for the year ended December 31, 2024. The Company pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

**Note 9 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The supplemental schedule includes delinquent participant contributions of \$8,624 pertaining to the year ended December 31, 2021 for which the Company made a corrective contribution of lost earnings that was deposited into the Plan and allocated to the affected participants in March 2025. The Company is currently working with its third-party administrator to correct the remaining \$52,836 of delinquent participant contributions relating to payroll for the year ended December 31, 2024. The Company believes that these transactions should not affect the tax-qualified status of the Plan.

**Note 11 - Subsequent events**

Effective February 1, 2025, the Plan was amended to allow part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours to become eligible to make salary deferral contributions. These participants are still excluded from receiving any Company contributions.

In March 2025, the Plan began making distributions of approximately \$5.9 million related to the account balances of former MCNR employees. These account balances were either distributed at the direction of the MCNR employees or rolled over into the NHCA Plan.

In May 2025, the Company received a notice from the DOL regarding a general audit of the Plan for the years ended December 31, 2023 and 2022. The Company has provided the DOL with all requested information and has not received any further notices or requests regarding this matter.
