## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed an audit of the financial statements of Savannah Distributing Co., Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Savannah Distributing Co., Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Savannah Distributing Co., Inc. 401(k) Plan is a defined contribution plan covering substantially all employees of Savannah Distributing Co., Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on July 1, 2001 and is administered by Savannah Distributing Co., Inc. for the benefit of its eligible employees. Reliance Trust Company serves as custodian for the Plan and The Standard Insurance Company serves as the Plan's third-party administrator, recordkeeper and co-fiduciary. FinTrust Capital Advisors, LLC serves as the Plan's investment advisor and investment co-fiduciary.

Eligibility

All active employees of the Company, excluding employees covered by a collective bargaining agreement or nonresident aliens, who have completed three months of service, as defined by the Plan are eligible to participate in the Plan. Participants become eligible to participate on the first day of the month following completion of the eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their eligible annual compensation as defined by the Plan on a pre-tax and/or after-tax basis, not to exceed statutory limitations established annually by the Internal Revenue Service (IRS). The limits prescribed by the IRS for December 31, 2024 and 2023 were \$23,000 and \$7,500 (catch-up), and \$22,500 and \$7,500 (catch-up), respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, a collective trust fund and a traditional insurance contract as investment options for participants. The Company also may make discretionary matches based on Company profitability, and for the last two years has contributed 50% of a participant's deferral up to 6% of the participant's compensation.

Vesting

Participants are immediately 100% vested in their contributions. Vesting in the Company's discretionary matching contributions is based on years of service in accordance with the following schedule:

Participant Accounts

Each participant's account is credited with participant's contributions, Company's contributions, participant's earnings, and charged with an allocation of administrative expenses and investment fees. Allocations are based on investment fund expense ratios and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions made to these accounts are directed by the participant into a particular investment offered by the Plan, and the allocations between investments can be changed.

**NOTE 1. DESCRIPTION OF THE PLAN, continued**

Benefit Payments

A participant becomes eligible for benefits at the normal retirement date (age 65). Participants are also eligible for benefits upon termination from the Company, or at the date the participant dies or becomes totally disabled. Participants are required to receive all benefit payments as lump-sum distributions or installment payments including those receiving requirement minimum distributions. Certain in-service distributions are also available including certain qualifying hardship withdrawals.

Forfeited Accounts

Forfeitures are used to reduce employer contributions in the Plan. At December 31, 2024 and 2023, there were forfeitures held in the amount of \$15,865 and \$4,330, respectively. The forfeiture account balance was \$1,766 and \$5,017 at December 31, 2024 and 2023, respectively. The forfeited accounts will be allocated or used to pay administrative expenses or fund future employer contributions as soon as administratively feasible.

Notes Receivable from Participants

A participant may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may not have more than one loan outstanding at any point in time. Loans are secured by the participant's account balance and bear interest at a reasonable rate of interest as determined by the Trustee based on prevailing interest rates ranging from 3.25%-8.50% charged for similar loans in the loan market. Repayments of the loans are made by substantially equal payroll deductions amortized over the life of the loan. The loan must be repaid within five years unless the loan is used to purchase a primary residence, in which case longer repayment periods may be permitted. The principal amount of the loan, together with all accrued interest, shall immediately become due when the participant is no longer employed by the Company.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. These accounts, which are non-forfeitable, will continue to accrue investment earnings until benefits are paid to the participants in accordance with the terms of the Plan.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that could affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses and all investment management expenses and commissions are paid by the Plan, and these expenses are allocated pro rata across the participant's accounts. Other administrative expenses are paid directly by the Company.

Subsequent Events

Subsequent events have been evaluated for potential recognition and/or disclosure through September 24, 2025. This represents the date the financial statements were available to be issued.

**NOTE 3. CERTIFICATION OF ASSETS AND INCOME**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the custodian, for the years ended December 31, 2024 and 2023 as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule.

**NOTE 4. CONTRACT WITH INSURANCE COMPANY**

The Plan has a benefit-responsive investment contract with The Standard Insurance Company (the Standard). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is fully benefit-responsive, therefore contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The fair value of the investment contract approximates the contract value at December 31, 2024 and 2023. The crediting interest rate for the investment contract at December 31, 2024 and 2023 was 3.04% and 2.78%, respectively.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) partial or complete Plan termination; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

**NOTE 5. TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit sharing plan. The plan received a favorable letter of determination dated June 30, 2020, stating that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the trust is tax-exempt under Section 401(a) of the IRC as of the Plan's year-end.

FASB requires the Plan Administrator to annually evaluate the Plan's tax positions, including accounting and measurement of uncertain tax positions. For the year ending December 31, 2024, the Plan Administrator concluded that no uncertain tax positions had been taken that would require adjustment to or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the federal, state, or local tax authorities for years before 2021.

**NOTE 6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are certified, custodied or managed by Reliance Trust Company and the Standard Insurance Company. Therefore, some of these investments may qualify as party-in-interest transactions.

Administrative expenses paid directly from Plan assets to the parties-in-interest stated above or their related entities totaled \$71,830 and \$60,190 for the years ended December 31, 2024 and 2023, respectively.

Notes receivable from participants totaled \$183,653 and \$228,136 at December 31, 2024 and 2023, respectively, and qualify as party-in-interest transactions.

**NOTE 7. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual fund accounts:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Funds that are valued at the NAV of units of the collective trust as provided to the plan administrator by the trustee of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities' liquidations will be carried out in an orderly business matter. The investment strategy of the collective trust fund is to use a small-cap equity value strategy. The collective trust fund has no unfunded commitments, redemption frequency is daily, and there is no redemption notice period.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 8. PLAN TERMINATION**

The Plan Administrator anticipates and believes that the Plan will continue without interruption but has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances and the Plan assets would be distributed to participants on the basis of their prorated values at the termination date.
