NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Document, which is available from the Plan Administrator, for a more complete description of the Plan's provisions.

General

The Isagenix International LLC 401(k) Profit Sharing Plan and Trust (the "Plan") is a defined contribution plan covering substantially all employees of Isagenix Worldwide, LLC (the "Company" or "Plan Sponsor"). Fidelity Management Trust Company ("Fidelity") is the trustee of the Plan. Fidelity Workforce Services LLC is the recordkeeper and third-party administrator. The Board of Managers is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was established effective September 10, 2004, in accordance with the provisions of Section 401(a) of the Internal Revenue Code (the "Code"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the Code, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

All employees of the Company who have attained age 18 (who are not covered by a collective bargaining agreement, and who are not a leased employee or a nonresident alien) are immediately eligible to participate in the Plan through deferred contributions.

Employees of the Company who do not voluntarily elect to enroll in the employee deferred contributions portion of the Plan are automatically enrolled in the employee deferred contributions portion of the Plan with a deferred amount equal to 4% of the employee's compensation. If an employee does not want to be automatically enrolled in the employee deferred contributions portion of the Plan, the employee must affirmatively elect not to participate. If the employee is contributing less than 10% of their annual compensation, the contribution will automatically increase each year on January 2 until a contribution of 10% of annual compensation is reached.

Contributions

Each year, participants may contribute up to 90% of pretax and Roth annual compensation, as defined in the Plan, not to exceed the maximum allowed under the Code. The maximum contribution allowed for 2024 and 2023 was \$23,000 and \$22,500, respectively. The employer matches 100% of participant contributions up to 4% of an employee's compensation after three months of eligible service. The Company may also make additional matching employer contributions. There were no additional matching employer contributions for the 2024 plan year. All employees who are eligible to make elective deferrals under this Plan and who have attained age 50 before the close of the calendar year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of the Code. The maximum catch-up contribution for 2024 and 2023 was \$7,500.

Rollover Contributions

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. An aggregate of approximately \$69,000 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contributions and Plan earnings, and (b) charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant compensation or account balance as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the balance in their account into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles.

Vesting

Participants are immediately 100% vested in their participant account, including employer matching contributions, and actual earnings thereon.

Benefits and Withdrawals

Benefits are available to Plan participants upon reaching retirement age (65), death or after termination of service for any other reason. The participant's account shall be available to be distributed in a single lump-sum payment or in installments, as defined by the Plan.

Participant contributions to the Plan may be withdrawn upon approval by the Plan Administrator in cases in which a participant has suffered a financial hardship. The Plan also permits in-service withdrawals beginning at age 59½. In general, participants must begin taking required minimum distributions once they turn age 73.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed a maximum of one loan outstanding at any given time. The loan terms require that repayment of principal and interest be amortized in equal payments, not less frequently than quarterly, over a period not to extend beyond five years unless it is for the purchase of a principal residence. The loans are secured by the balance in the participant's account. The loans bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans at December 31, 2024, range from 4.25% to 9.50% with various maturity dates through October 2033.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited amounts totaled \$1,267 and \$6,427, respectively. Forfeitures can be used to reduce future employer contributions. During 2024, forfeitures of \$5,460 were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at

the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments and therefore, reported in net depreciation in fair value of investments on the accompanying Statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties

Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. Certain investments held by the Plan invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain management, legal, and administrative expenses of the Plan, including management fees incurred in administering the Plan, are paid by the Company. Other management fees and administrative expenses are charged to participants that elect to obtain a loan from the Plan and are included in administrative expenses. Expenses are deducted from the participant's account balance at the loan date.

- Investment income and interest income on notes receivable from participants, as reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants, as reflected in the supplemental schedule, Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are shares of funds managed by Fidelity or an affiliate thereof. Fidelity is the Plan's Trustee; therefore, these transactions qualify as party-in-interest transactions. In addition, administrative expenses paid by the Plan and participant loans qualify as party-in-interest transactions.

Fees have been paid to Fidelity by the Plan for recordkeeping and investment management services for the year ended December 31, 2024.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 - TAX STATUS

The Plan is a non-standardized pre-approved defined contribution plan (Pre-Approved Plan) sponsored by FMR LLC and adopted by the Company. The Pre-Approved Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The determination of what constitutes observable requires judgment by the Plan's management. Plan management considers observable data to be that market data, which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by multiple independent sources that are actively involved in the relevant market. The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund

The stable value collective trust fund is valued at the net asset value ("NAV") of units held by the Plan at year end, as determined by the fair value of the underlying assets, which includes investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. The NAV is used as a practical expedient for fair value. The stable value fund generally permits redemptions daily. There are no unfunded commitments or plan level restrictions for transacting with the fund.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Document, which is available from the Plan Administrator, for a more complete description of the Plan's provisions.

General

The Isagenix International LLC 401(k) Profit Sharing Plan and Trust (the "Plan") is a defined contribution plan covering substantially all employees of Isagenix Worldwide, LLC (the "Company" or "Plan Sponsor"). Fidelity Management Trust Company ("Fidelity") is the trustee of the Plan. Fidelity Workforce Services LLC is the recordkeeper and third-party administrator. The Board of Managers is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was established effective September 10, 2004, in accordance with the provisions of Section 401(a) of the Internal Revenue Code (the "Code"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the Code, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

All employees of the Company who have attained age 18 (who are not covered by a collective bargaining agreement, and who are not a leased employee or a nonresident alien) are immediately eligible to participate in the Plan through deferred contributions.

Employees of the Company who do not voluntarily elect to enroll in the employee deferred contributions portion of the Plan are automatically enrolled in the employee deferred contributions portion of the Plan with a deferred amount equal to 4% of the employee's compensation. If an employee does not want to be automatically enrolled in the employee deferred contributions portion of the Plan, the employee must affirmatively elect not to participate. If the employee is contributing less than 10% of their annual compensation, the contribution will automatically increase each year on January 2 until a contribution of 10% of annual compensation is reached.

Contributions

Each year, participants may contribute up to 90% of pretax and Roth annual compensation, as defined in the Plan, not to exceed the maximum allowed under the Code. The maximum contribution allowed for 2024 and 2023 was \$23,000 and \$22,500, respectively. The employer matches 100% of participant contributions up to 4% of an employee's compensation after three months of eligible service. The Company may also make additional matching employer contributions. There were no additional matching employer contributions for the 2024 plan year. All employees who are eligible to make elective deferrals under this Plan and who have attained age 50 before the close of the calendar year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of the Code. The maximum catch-up contribution for 2024 and 2023 was \$7,500.

Rollover Contributions

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. An aggregate of approximately \$69,000 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contributions and Plan earnings, and (b) charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant compensation or account balance as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the balance in their account into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles.

Vesting

Participants are immediately 100% vested in their participant account, including employer matching contributions, and actual earnings thereon.

Benefits and Withdrawals

Benefits are available to Plan participants upon reaching retirement age (65), death or after termination of service for any other reason. The participant's account shall be available to be distributed in a single lump-sum payment or in installments, as defined by the Plan.

Participant contributions to the Plan may be withdrawn upon approval by the Plan Administrator in cases in which a participant has suffered a financial hardship. The Plan also permits in-service withdrawals beginning at age 59½. In general, participants must begin taking required minimum distributions once they turn age 73.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed a maximum of one loan outstanding at any given time. The loan terms require that repayment of principal and interest be amortized in equal payments, not less frequently than quarterly, over a period not to extend beyond five years unless it is for the purchase of a principal residence. The loans are secured by the balance in the participant's account. The loans bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans at December 31, 2024, range from 4.25% to 9.50% with various maturity dates through October 2033.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited amounts totaled \$1,267 and \$6,427, respectively. Forfeitures can be used to reduce future employer contributions. During 2024, forfeitures of \$5,460 were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at

the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments and therefore, reported in net depreciation in fair value of investments on the accompanying Statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties

Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. Certain investments held by the Plan invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain management, legal, and administrative expenses of the Plan, including management fees incurred in administering the Plan, are paid by the Company. Other management fees and administrative expenses are charged to participants that elect to obtain a loan from the Plan and are included in administrative expenses. Expenses are deducted from the participant's account balance at the loan date.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants, as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants, as reflected in the supplemental schedule, Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are shares of funds managed by Fidelity or an affiliate thereof. Fidelity is the Plan's Trustee; therefore, these transactions qualify as party-in-interest transactions. In addition, administrative expenses paid by the Plan and participant loans qualify as party-in-interest transactions.

Fees have been paid to Fidelity by the Plan for recordkeeping and investment management services for the year ended December 31, 2024.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 - TAX STATUS

The Plan is a non-standardized pre-approved defined contribution plan (Pre-Approved Plan) sponsored by FMR LLC and adopted by the Company. The Pre-Approved Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The determination of what constitutes observable requires judgment by the Plan's management. Plan management considers observable data to be that market data, which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by multiple independent sources that are actively involved in the relevant market. The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund

The stable value collective trust fund is valued at the net asset value ("NAV") of units held by the Plan at year end, as determined by the fair value of the underlying assets, which includes investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. The NAV is used as a practical expedient for fair value. The stable value fund generally permits redemptions daily. There are no unfunded commitments or plan level restrictions for transacting with the fund.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.
