- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Robert A.M. Stern Architects 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - PLAN DESCRIPTION**

The following description of the Robert A.M. Stern Architects 401 (k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established effective January 1, 1987. The Plan is a defined contribution profit-sharing plan formed under Internal Revenue Code (IRC) Section 401(k) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers substantially all employees, excluding certain employees as defined in the Plan document, of Robert A.M. Stern Architects, LLP (the “Company”). The Company’s Compensation Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Company’s Management Committee.

**Contributions**

There is no service requirement for employees to be eligible as participants are entered into the plan immediately after meeting the age requirement. Upon becoming eligible, a participant may make pretax and post-tax Roth elective contributions (both subject to statutory limits). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Any participant, upon first becoming eligible to participate in the Plan, who fails to affirmatively make any deferral election within the time prescribed by the Company shall be deemed to have elected to defer four percent (4%) of their compensation. The deferral percentage is automatically increased by two percent (2%) each year up to a maximum of 100%.

Employees become eligible for discretionary profit-sharing contributions immediately following the completion of one year of service and attainment of age 21, if later. In addition, the participant must be employed on the last day of such plan year and must have completed at least 1,000 hours of service. There was no profit-sharing contribution in 2024.

Participants direct the investment of contributions credited to their accounts into various investment options offered by the Plan.

**NOTE 1 - PLAN DESCRIPTION (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contributions, as well as an allocation of the Company's profit-sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contribution and Company matching contributions plus actual earnings thereon. Vesting in discretionary profit-sharing contributions is based on years of service. A participant is 100% vested after six years of service. If a participant reaches the age of 65, becomes totally and permanently disabled, or in the event of death, the participant becomes fully vested.

**Notes Receivable from Participants**

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance except for loans under the Coronavirus Aid, Relief and Economic Security Act ("CARES Act"). Loans under the CARES Act allowed for the loan limits to be increased to \$100,000 and 100% of the participant's vested balance. Loan terms may not exceed five years unless the loan is for the purpose of acquiring a personal residence in which case the term of the loan may not exceed 30 years. The loans are secured by the balance in the participant's account.

Loans bear interest at the prime rate plus 1%. Loans outstanding during the year had interest rates ranging from 1.00% to 9.50%. Principal and interest are paid ratably through semi-monthly or bi-weekly payroll deductions or directly from the borrower and credited to the borrower's account balance.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, participants or beneficiaries may elect to receive either a lump sum or rollover into a qualified plan, or combination thereof, or annual installments, in the amount of the participant's vested interest in his or her account. For termination of service, if the participant's account is less than \$5,000 and the participant does not submit a distribution election form, then the participant's distribution automatically shall be made in the form of a lump sum payment as soon as practical. Under certain circumstances (hardship), and with approval of the Plan administrator, an employee can elect at any time to receive a portion of his or her vested account balance subject to the provisions of the Plan. In-service withdrawals are permitted once a participant has attained age 59 1/2.

**Forfeited Accounts**

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$453,776 and \$428,719, respectively. These accounts will be used to reduce future employer contributions and pay certain fees. In 2024, forfeited accounts were used to pay advisory fees of \$32,225.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Compensation Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 - CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (“Vanguard”), a qualified institution.

**NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value (“NAV”) per share. Accordingly, the Plan estimates the fair value of an investment in an investment fund using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2    Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at NAV at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Common collective trust:*** Valued based on the NAV of the collective trust's underlying investments. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The common collective trust was formed for the purpose of investing in the MetLife Group Annuity Contract No. 25554 issued by Metropolitan Life Insurance Company to the trustee, to establish a stable value fund. The investment objective of the fund is to provide safety of principal, adequate liquidity and competitive yield with low return volatility. Generally, there are no restrictions on a participant's ability to redeem their investment in the common collective trust or collective investment fund. However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws or regulations) may restrict a participant's ability to redeem the investment. The Plan Administrator does not believe that the occurrence of any such event is probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Vanguard, the Plan's trustee and recordkeepers. These transactions, therefore, qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. Certain administrative and recordkeeping fees of \$62,236 were paid to the trustee for the year ended December 31, 2024.

In addition, the Plan paid fees for certain investment advisory services and administrative services. The fees for the year ended December 31, 2024 were \$99,864.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, or partial termination of the Plan, participants' accounts shall be fully vested as of the date of such termination. The Company determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

**NOTE 7 - TAX STATUS**

The IRS has determined and informed the Plan administrator by a letter dated June 30, 2020, that the form of the pre-approved plan is acceptable under the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the prototype plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 23, 2025, which is the date the financial statements were available to be issued.
