INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lindy Property Management Co. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lindy Property Management Co. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

1. Description of Plan

The following description of Lindy Property Management Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all full-time employees of Lindy Property Management Co. (the "Company") not covered by a collective bargaining unit. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employees shall be eligible to become participants after having obtained age 18 and be auto-enrolled after completing 3 months of service as defined by the Plan. Under the terms of the Plan document, service with certain previous employers will be counted toward eligibility in the Plan.

Contributions – Each year participants may contribute up to 100% of pre-tax annual compensation as defined in the Plan and, may elect to make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company will make a safe harbor matching contribution equal to 100% of participant contributions up to 3% of eligible compensation, plus 50% of the participant contributions exceeding 3% but not exceeding 5% of eligible compensation. For the years ended December 31, 2024 and 2023, the Company's safe harbor matching contributions totaled \$317,889 and \$298,462, respectively. The Company may make discretionary non-elective (profit sharing) contributions. Participants are generally eligible to receive an allocation of the profit sharing contribution after having completed 1,000 hours of service during the Plan year and are employed by the Company at the end of the Plan year as defined in the Plan. No such contributions were made for the years ended December 31, 2024 and 2023. The Company may also make Qualified Non-elective Contributions ("QNEC's"). QNEC's made to the Plan for the years ended December 31, 2024 and 2023 were \$-0- and \$8, respectively.

Participant Accounts – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions, and (b) Plan earnings, and is charged with (c) certain administrative expenses and (d) allocation of Plan losses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions, rollover contributions, QNEC's and employer safe harbor matching contributions, plus actual earnings thereon. The Company's non-elective (profit sharing) contributions and earnings thereon will generally vest as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Participants will become 100% vested upon death or disability or reaching normal retirement age.

Investment Options – Upon enrollment in the Plan, a participant may direct participant contributions to any of the Plan's investment options. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their fund accounts except for Roth elective deferrals or investments with trading restrictions, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not take out more than one (1) loan at one time. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and generally bear interest at prime plus 1% as defined in the Plan. Principal and interest are paid ratably through payroll deductions.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits – The payment of benefits under this Plan to the participant shall begin as soon as administratively feasible. Distributions are allowed in the event of termination of employment, disability, death, and retirement. Also, in-service distributions are allowed in the event of financial hardship or upon attainment of age 59-1/2, and only from fully vested accounts. Distributions from a rollover account are allowed at any time.

A mandatory single lump-sum distribution is paid to an individual retirement account if the participant's vested account balance is greater than \$1,000 but less than \$5,000 and the participant does not otherwise consent to a rollover or direct distribution in cash. If the participant's vested account balance exceeds \$5,000, the participant must consent to any distribution from their account. A mandatory single lump-sum direct distribution is paid in cash to the participant if the vested account balance is \$1,000 or less.

Forfeited Accounts – Forfeited non-vested accounts may be used to reduce any employer contribution. No forfeitures were used to reduce the Company's matching contribution for the years ended December 31, 2024 and 2023. The Plan's forfeited non-vested accounts totaled \$1,574 and \$1,494 as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information Prepared and Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the custodian of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

The following fair value hierarchy classifies the inputs to valuation techniques used to measure fair value into one of three levels:

Level 1: unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2: inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets;

Level 3: unobservable inputs that reflect the reporting entity's own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

Certain administrative fees paid to the custodian and service providers and loans to participants are considered party in interest transactions. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions.

7. Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code ("IRC") Section 401(a). The Plan has not received a determination letter specific to the Plan itself, however, the plan administrator and the plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Plan management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.
