Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Lyrasis PA 403(b) DC Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note 1 – Description of Plan

The following description of the Lyrasis PA (the “Plan Sponsor”) 403(b) DC Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution 403(b) plan established to provide benefits to eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility: Employees are eligible to make elective deferrals immediately and eligible to receive matching contributions and nonelective contributions upon completion of six months of continuous service. If the employee does not complete six months of continuous service following commencement of employment, the employee becomes eligible upon one year of service, defined as 1,000 hours of service within the Plan year. Employees covered by a collective bargaining agreement and employees who normally work less than 20 hours per week are excluded.

Contributions: Each year, participants elect to contribute a percentage of their pretax compensation, subject to limits as determined by the Internal Revenue Service (IRS) (\$23,000 and \$22,500 for 2024 and 2023, respectively), to the investment funds. These contributions may be made on a pretax or after-tax (Roth) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to specified limits (up to \$7,500 in both 2024 and 2023). In addition, participants with 15 or more years of service may be entitled to a special section 403(b) catch-up contribution. The Plan Sponsor funds an Enhanced Safe Harbor contribution of 160% of each participant’s elective deferrals not to exceed 5% of eligible compensation, as defined. The Plan Sponsor may also contribute additional discretionary matching contributions.

The Plan, at its discretion, will accept into participants’ rollover accounts cash received by participants from a qualified plan within the time prescribed by applicable law (rollover contributions).

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocations of (a) the Plan Sponsor’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Description of Plan (continued)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000 (reduced by the Participant’s highest outstanding loan balance during the prior 12 months). The loans are secured by the balance in the participant’s account and bear interest at the prime rate then in effect plus one percentage point. The maximum number of loans a participant may have outstanding at any given time is one.

Vesting: Participants are immediately vested in their elective deferrals, in Enhanced Safe Harbor contribution and nonelective contributions plus actual earnings thereon.

Withdrawals: Participants who have attained age 59 ½ may elect to withdraw the interests in their account. In addition, hardship withdrawals and loans are permitted in accordance with the Plan.

Payment of Benefits: On termination of service due to death, disability, or retirement, participants or their beneficiaries may elect to receive a distribution in a single lump sum. Payment of benefits in installment payments is permitted only when required minimum distributions are required.

SECURE Act and CARES Act: On December 20, 2023, the IRS released Notice 2024-2, which extends the deadline for adopting any SECURE Act plan amendments until December 31, 2026, to provide relief for plan sponsors waiting for final IRS guidance on many of the SECURE Act’s provisions. The Notice also extends the deadline for the 2020 waiver in the CARES Act of required minimum distributions until December 31, 2025. These amendments can be retroactively adopted; therefore, the Plan can implement the amendments prior to amending the plan instrument. Similarly, plans may have voluntarily adopted provisions under the CARES Act by placing them in operation without amending the plan as long as the plan management makes the required amendments to plan documents by December 31, 2026.

SECURE 2.0 Act of 2022: The SECURE 2.0 Act of 2022 (“SECURE 2.0 Act”) was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the SECURE 2.0 Act generally need not be made until the end of the first plan year beginning on or after January 1, 2026; however, plans must be operated in accordance with the effective date of each new provision. There is no current impact to the Plan and these provisions did not have an impact on the financial statements. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

Note 2 – Summary of Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates: The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Except for certain contracts held by the contract holders described in Note 6, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance companies. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

Note 4 – Tax Status

The Plan uses a Pre-Approved 403(b) Plan plan document sponsored by FIS Business Systems LLC. FIS Business Systems LLC obtained an opinion letter on March 31, 2017, in which the IRS stated that the Pre-Approved 403(b) Plan plan document, as then designed, qualifies under the Internal Revenue Code (“IRC”) Section 403(b). The Plan may be amended periodically; the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in accordance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and related trust is tax-exempt.

Note 5 – Investments and Information Certified by the Plan’s Qualified Institutions

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, plan management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Matrix Trust Company, TIAA and CREF, Equitable Financial Life Insurance Company, and The Variable Annuity Life Insurance Company, the custodian and contract holders of the Plan, as complete and accurate, except for comparing such information certified by the custodian and contract holders with information included in the Plan’s financial statements and supplemental schedule:

Note 6 – Fully Benefit-Responsive Investment Contracts

The Plan has fixed annuity investment contracts with TIAA, CREF, AXA, and VALIC (the “contract holders”). The contract holders maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by the contract holders. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract holders indicated that contract value approximates fair value for these investments at December 31, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with participants are probable of occurring. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Registered investments: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuities – Registered investments: Variable Annuity product that holds registered investments that invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments and fund holdings are primarily valued using market quotations or prices obtained from independent pricing sources that employ various pricing methods to value the investments including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in these investments are revalued to reflect performance of the underlying investments minus any fees and charges, and are valued using NAV as readily determinable fair value.

Variable Annuities – Pooled separate accounts: Investment in the TIAA pooled separate account is stated at fair value as determined in accordance with the policies and procedures reviewed by the Investment Committee of TIAA. The value of the units held in the pooled separate account is calculated using the net asset value per share of the underlying investments as a practical expedient. The underlying real estate holdings are valued principally utilizing external appraisals and involve significant judgment. Appraisals can be subjective in certain respects and rely on a variety of assumptions and conditions at the respective property or in the market in which the property is located, which may change materially after the appraisal is conducted. The TIAA pooled separate account provides participants with a liquidity guarantee enabling the account to have funds available to meet participant redemption, transfers, or cash withdrawals. TIAA guarantees that participants can redeem their accumulated unit value determined after their transfer or cash withdrawal request is received in good order.

Fixed Annuity Contract: Participants who have elected the traditional annuity contract have entered into contracts with TIAA and CREF, including those in the format of Retirement Annuities ("RA"), Supplemental Retirement Annuity ("SRA"), and Group Supplemental Retirement Annuities ("GSRA"). TIAA and CREF maintains contributions in general accounts and participant accounts are credited with a guaranteed minimum rate of interest on the underlying investments and charged with participant withdrawals and any administrative expenses. Contracts buy a contractual or guaranteed amount of future benefits. RA contract account balances may only be withdrawn in 10 annual installments and therefore are not considered to be fully benefit responsive while SRA and GSRA's are fully benefit responsive investment contracts because they are fully liquid and cashable upon a participant's termination from the Company. All traditional non-benefit responsive annuity contracts are included in the financial statements at fair value as reported by TIAA and CREF, which is consistent with management's determination of fair value using the income approach. Fully benefit responsive contracts are reported at contract value, and therefore not included within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All transfers between fair value hierarchy levels are recognized by the Plan at the end of each reporting period. There were no significant transfers between Levels 1, 2, and 3 during the years.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include risks related to pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Related-Party Transactions and Party-in-Interest Transactions

Management believes that fees paid during the year for administrative, recordkeeping, and managerial services rendered by Matrix Trust Company, TIAA, CREF, AXA, and VALIC, the custodian and contract holders as defined by the Plan, and Creative Planning TPA, LLC, the Plan's recordkeeper and Third-Party Administrator, were based on customary and reasonable rates for such services. These transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.
