### **Basis for Opinion**

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Cardiology Center of Amarillo, LLP 401(k) Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the most current Plan agreements.

#### **General**

The Plan is a defined contribution retirement plan which provides for the participation of the employees of Cardiology Center of Amarillo, LLP (the Company) who have attained the age of 21 and completed one year of service (1,000 hours in a 12-month eligibility computation period). Once eligibility requirements have been met, employees are automatically enrolled. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC). Under the Plan, each participant has an account for his/her salary deferral contributions, any rollover contributions and for Company contributions.

**Empower Trust Company, LLC** serves as the Plan's investment custodian and is responsible for executing all investment transactions. Amarillo National Bank serves as the Plan's trustee.

#### **Contributions**

Participants may make salary deferral contributions through payroll deductions of not less than 1% up to 100% of their compensation (limited to certain amounts allowed under the IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employees who are eligible to make elective deferrals under the Plan and who have attained the age of fifty before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC. The Plan has elected Safe Harbor and the Company provides a nonelective contribution equal to 3% of each employee's eligible compensation. The discretionary Profit Sharing contribution is subject to change each year at management's discretion. Participant and Company contributions are subject to the provisions of the IRC and related regulations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contributions, any discretionary contributions, an allocation of plan earnings and charged with an allocation of plan expenses. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Investment Management**

Upon enrollment in the Plan, a participant may direct his/her contributions in any of the investment options currently available as determined and selected by the Plan's management. Participants may change their investment allocations daily, via phone or internet access to the Plan's investment custodian.

### NOTE 1 - DESCRIPTION OF PLAN (continued)

#### Notes Receivable from Participants

The Plan allows participants to obtain loans from their vested accounts, which may not exceed the lesser of one half of the participant's vested interest in their account balances or \$50,000. The Plan allows one loan outstanding at one time and no loan issued in an amount less than \$1,000 will be made. Participant loans are maintained and serviced by the Plan's custodian as assets of the Plan. Participants should refer to the separate loan policy of the Plan for further information. Principal and interest is paid ratably through payroll deductions. Interest rates are based on prime rate plus 1.00%. Interest rates on outstanding participant loans at December 31, 2024 ranged from 4.25% to 9.50%.

#### Forfeited Accounts

Forfeitures represent the portion of non-vested account balances of terminated participants which are retained by the Plan and added to any employer discretionary contribution and allocated to participants or used to pay Plan expenses. Forfeitures of \$36,607 were used to reduce employer contributions during 2024. Plan assets include an unallocated forfeiture balance \$20,222 and \$15,037 as of December 31, 2024 and 2023, respectively.

#### Vesting

Participants are immediately vested in their salary deferral contributions and Company non-elective safe-harbor contributions, plus actual earnings thereon. Participants vest in Company discretionary contributions, if any, gradually from their 2<sup>nd</sup> year of service (20%) through their 6<sup>th</sup> year of service (100%).

#### Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum distribution, periodic installments, or a combination of these two options. If a participant's vested balance is \$5,000 or less (excluding amounts rolled over from another qualified plan), the participant will receive a single lump sum distribution of their entire vested account balance. Also, the Plan will provide for automatic rollover distributions of terminated participant's vested accounts between \$1,000 and \$5,000 to a qualified individual retirement account.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

##### **Payment of Benefits**

Benefit payments are recorded when paid.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

##### **Contributions**

Participant contributions and employer matching contributions are recognized during the period in which the respective payroll deductions are made.

##### **Subsequent Events**

The Plan Administrator has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - INCOME TAX STATUS

The Plan has not received a determination letter on their adoption of the Pre-approved plan. In accordance with Revenue Procedure 2003-6, the Plan administrator has chosen to rely on the opinion letter, dated November 14, 2022 that has been issued to the Pre-approved plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

### NOTE 4 - INFORMATION CERTIFIED BY EMPOWER TRUST COMPANY, LLC

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following assets:

### NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100% vested in their accounts and the Plan assets will be distributed in a manner approved by the Internal Revenue Service.

### NOTE 7 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investment advisory and record keeping services are performed by Empower Trust Company and Amarillo National Bank. The Plan pays for these services out of Plan assets which qualifies as party in interest transactions. Plan admin expenses were \$54,471 for 2024.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
