Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the O'Connor Hospital Defined Contribution Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion on the Financial Statements

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Basis for Disclaimer of Opinion, Continued

Further, as described in note 2(a) to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

(1) Description of Plan

The following description of the O’Connor Hospital Defined Contribution Plan (Plan) provides only general information. Participants should refer to the Plan document for more complete information.

(a) General

The Plan is an employer-sponsored defined contribution plan established under Internal Revenue Code (IRC) Section 403(b) designed to provide retirement benefits to eligible employees of O’Connor Hospital (Hospital). The Plan was established in 1998 and is administered by the Employee Benefits Oversight Committee of the Hospital, which consists of certain officers and employees of the Hospital, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Eligibility

All eligible employees of the Hospital are able to make elective deferrals (amounts deducted directly from their salary and contributed to the Plan) beginning on their date of hire. Eligibility to receive Hospital nonelective contributions under the Plan are allowed on the first day of the month after completing two years of service.

(c) Contributions

Contributions to the Plan consist of employer contributions and participant pre-tax contributions, which are subject to certain statutory limits. The IRC limits pre-tax contributions. The limit for participants under age 50 was \$20,500 and \$19,500 during 2022 and 2021, respectively. Participants age 50 or older may make additional deferrals, subject to a limit of \$6,500 during 2022 and 2021.

Employer contributions to the Plan are based on employees’ years of service with the Hospital and are determined as follows:

<u>Years of service</u>	<u>Employer contribution as a percentage of employee compensation</u>
2 - 5 years	4% of compensation
6 - 10 years	5% of compensation
11 - 15 years	6% of compensation
16 years+	7% of compensation

(c) Contributions, Continued

Total aggregate employee and employer contributions to the Plan are limited to \$61,000 and \$58,000 during 2022 and 2021, respectively, or 100% of compensation, as defined in the Plan document.

(d) Participant Accounts

Contributions made by the participants and the employer are reported to the Plan's record keeper and are allocated to the respective participant's account. Each participant's account is credited with the participant's contributions, the employer's contribution, and the monthly allocation of investment earnings. Investment earnings allocations are based on participant account balances.

Participants select the investments in which their contributions will be allocated by the Plan's record keeper. If a participant does not direct the contributions, they are invested in a target date retirement fund where the allocation strategy is consistent with the participant's anticipated date of retirement.

(e) Vesting

Participants are vested immediately in employee and employer contributions, and actual earnings on the contributions.

(f) Payment of Benefits and Withdrawals

Upon termination of service (retirement, death or disability), participants may elect to leave their account balance in the Plan or receive a distribution. The following options are available to those electing a distribution: 1) a lump-sum; 2) deferral of the receipt of distribution until age 70; and 3) rollover of a lump-sum distribution into an IRA if done so within 60 days of the distribution.

Participants may not withdraw any of their pretax contributions or any of Hospital's contributions while actively employed or prior to attaining age 59½, except in the event of serious financial hardship and subject to penalties, as defined in the Plan document.

(g) Notes Receivable from Participants

Participants may borrow against their own accounts. No more than two loans may be outstanding at one time. In no event may a participant's total outstanding loan balance exceed the lesser of one-half of the participant's account balance or \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months).

Participants who borrowed against their accounts repay principal and interest through arrangements coordinated directly with the record keeper. Participants are also allowed to repay principal and interest through payroll deductions. The Hospital remits information regarding withholdings and payments to the Plan's record keeper upon receipt. Interest is charged on loans at an annual rate equivalent to the prime rate as published on the last business day of the month proceeding the month in which the loan application is submitted and approved plus 2%. The rate charged may not exceed the maximum rate allowed by state law. All general loans must be repaid in full by the fifth anniversary date of the loan. Home purchase loans may be repaid over an extended term not to exceed 15 years.

During the repayment period of a loan, the Plan's record keeper reallocates the repayment amounts among the investment funds in the same proportion as current investment allocations.

(h) Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees paid by the Plan for the investment management services are netted against investment returns.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting and Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Prior to January 1, 2009, the Plan was historically viewed as an amalgamation of individual annuity contracts and custodial accounts and the Plan administrator and its service providers did not maintain financial information at a Plan level. Because historical records were not maintained or are not available at a Plan level prior to January 1, 2009, the Plan may have excluded from the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009. In recognition of these record keeping matters, the Department of Labor (DOL) released Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02), to address situations where a plan's management is not able to obtain historical records. The DOL has indicated that they will not reject Form 5500 where contracts are excluded as long as certain conditions in FAB 2009-02 were met. Further, FAB 2009-02 suggests that plan administrators make good faith efforts to include known contracts. While the Plan administrator has, in good faith, included all known contracts, because of certain incomplete records, there is uncertainty that all contracts in existence prior to January 1, 2009 have been included. However, the Plan administrator believes that excluded annuity contracts or custodial accounts, if any, would meet the conditions of FAB 2009-02. As discussed in note 3, the Plan has received certified statements of completeness and accuracy from the Plan's service providers for years subsequent to 2009, including as of and for the years ended December 31, 2022 and 2021.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

(3) Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, and dividends and interest from investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company and Teachers Insurance and Annuity Association of America (TIAA) (the custodians of the Plan).

(4) Tax Exempt Status

The Plan has been established using a volume submitter plan designed and maintained by the Plan's third-party administrator. The Internal Revenue Service (IRS) has determined and informed the volume submitter sponsor by a letter dated March 31, 2017, that the volume submitter plan is designed in accordance with applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

(5) Plan Termination

The Hospital intends to continue the Plan indefinitely; however, the Plan is voluntary on the part of the Hospital, and the Hospital reserves the right to modify or terminate the Plan at any time. In the event of Plan termination, participants will remain 100% vested in their account balances.

(6) Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares or units of investment funds managed by Mid Atlantic Trust Company and TIAA, the custodians, as defined by the Plan. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions under ERISA.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(8) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: The mutual funds invest principally in equity securities, fixed income instruments, and short-term instruments in accordance with each fund's investment objectives. Mutual funds are registered mutual funds whose fair values are based on quoted prices.

Exchange-traded funds: The exchange-traded funds invest principally in equity securities and fixed income instruments in accordance with each fund's investment objectives. Exchange-traded funds are registered exchange-traded funds whose fair values are based on quoted prices.

CREF Accounts: These are registered investment company accounts that invest principally in equity securities, fixed income instruments and short term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing.

TIAA Real Estate Account: TIAA real estate generally invests in real estate properties and real estate related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate related investments. Underlying real estate holdings are valued principally using external appraisals. Underlying securities are generally priced using values obtained from independent pricing sources.

TIAA Traditional Annuity Non-Fully Benefit-Responsive: The TIAA Traditional Annuity RA is a non-fully benefit-responsive investment contract. Observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs. Liquidity restrictions apply to TIAA Traditional Annuity RA contracts that could impact the value realized upon exiting the contract. See note 9 for further discussion regarding the Traditional Annuity RA contracts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The valuation technique and significant unobservable inputs related to the Plan's investment in assets categorized as Level 3 in the fair value hierarchy at December 31, 2022 and 2021 include the use of a discounted cash flow model which applies risk-adjusted discount rates based on TIAA's historical crediting rates, which ranged from 3.70% to 6.25% and from 3.00% to 3.80% as of December 31, 2022 and 2021, respectively.

(9) TIAA Traditional Annuity

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuity (RA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

(9) TIAA Traditional Annuity, Continued

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, are guaranteed by TIAA-CREF's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA-CREF's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA contracts, the crediting interest rate ranged from 3.70% to 6.25% during the year ended December 31, 2022 as compared to a range from 3.00% to 3.80% during the year ended December 31, 2021.

The RA contract does not allow lump-sum cash withdrawals and transfers. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). Accordingly, the RA contracts are not fully benefit-responsive contracts, and are reported at fair value (see note 8).
