For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of the Hato Rey Pathology Associates, Inc. (the Company) 1165(e) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan, commonly known as an 1165(e) Plan, covering all employees of the Company who have completed one year of service, completed 1,000 hours of service, and are age 21 or older. The entry dates for eligible employees are the 1<sup>st</sup>, 4<sup>th</sup>, 7<sup>th</sup>, or 10<sup>th</sup> month of the Plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Administrative Committee.

**Plan administration**

Empower Retirement, Inc. provides recordkeeping to the Plan. Oriental Bank serves as the Plan's trustee (the "Trustee"), responsible for the custody and management of the Plan's assets.

**Contributions**

Once the participants become eligible, they can make elective deferrals from 0% of their compensation up to 10% of their compensation. However, elective deferrals for any calendar year made shall not exceed the annual permissible dollar limit in effect for the year, reduced by contributions to a Puerto Rico IRA. Additional "catch-up" elective deferral contributions can be made beginning in the calendar year in which the participant attains at least 50 years of age by the end of such calendar year. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers seventeen investment options for participants. The Company's contributions are allocated to each employee based on a 100% matching contribution for each Participant's pre-tax contribution up to 50% of the first three percent (3%) contributed from his salary by the participant with years of service less than eleven years and 75% of the first three percent (3%) contributed from his salary by the participant with years of service equal or greater than 11 years, up to a maximum of three percent (3%) of the Participant's salary. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors and invested in a portfolio of investments as directed by the Company. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan's earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service, as follows:

Withdrawals and payment of benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or transfer the vested interest to another qualified plan that agrees to receive the distribution or to an individual retirement account.

Forfeited accounts

Under the provisions of the Plan, unvested Plan Sponsors' contributions are subject to forfeitures at the time the participant has separation of employment. Unallocated forfeitures and related earnings, if any, can reduce future Plan Sponsors' contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts held totaled \$6,411 and \$5,316, respectively. During the year ended December 31, 2024, forfeitures were used to offset Plan Sponsor contributions of \$850.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Investments held by a defined contribution plan are required to be reported at fair value.

Administrative expenses

Administrator fees are paid by the Plan and charged directly to each participant's account. The Sponsor directly pays other administrative costs of the Plan.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Shares of the mutual funds' accounts are valued at quoted market prices which represent the net assets value of shares held by the Plan at year-end. Both realized and unrealized appreciation and depreciation are reflected for the year in the statement of changes in net assets available for benefits. Gains or losses on security transactions are recorded as the difference between proceeds received and the carrying value of the investments. Interest income is recognized on the accrual method and dividend income is recorded on the ex-dividend date. See note 4 for discussion of fair value measurements.

Payment of benefits

Benefits are recorded when paid.

Investment related expenses

Investment-related expenses are included in net appreciation in fair value of investments.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

*Level 2 Fair Value Measurements*

The fair value of annuities is valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

*Collective Trust Funds*

Collective Trust Funds are valued at the Net Asset Value ("NAV") based on the last reported sales price of the underlying investments held. The Plan's interest in the collective trusts is based on information reported by the investment advisor using the audited financial statements of the collective trusts. The investment income is allocated to participants based on their proportionate share of the net assets of the fund.

**4. FAIR VALUE MEASUREMENTS (CONTINUED)**

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2, and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan utilizes a third-party administrator. Administrator fees are paid by the Plan, and other administrative fees are paid by the Sponsor during the year. The Plan's investments are held by a trust which is the custodian as defined by the Plan; therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services amounted to \$40,814 and \$32,692 for the years ended December 31, 2024 and 2023, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

**7. TAX STATUS**

The Department of the Treasury of the Commonwealth of Puerto Rico (PRDT) has determined and informed the Company on a letter dated July 9, 2009, that the Plan and related trust are designed in accordance with applicable sections of the Puerto Rico Internal Revenue Code (PRIRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the PRIRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the PRDT. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

**8. CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as significant world events, interest rate, market, credit risks, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**9. INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan's management elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from Oriental Bank, the trustee of the Plan (a qualified institution), stating that as of December 31, 2024 and 2023, and for the years then ended, the certified investments, as described in Notes 3 and 4, and all information included in the supplemental schedule H, line 4i-schedule of assets (held at end of year), is complete and accurate.

**10. NONEXEMPT (PROHIBITED) TRANSACTIONS**

During the year ended December 31, 2023, one participant contribution withheld was deposited after the earliest date on which such contribution was reasonably segregated from the employer's general assets.

**11. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued. Management has determined that there are no events in this period that require disclosure in or any adjustments to the accompanying financial statements.
