## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees  
AMSCO (Air Mechanical and Service Corp.) 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of AMSCO (Air Mechanical and Service Corp.) 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AMSCO (Air Mechanical and Service Corp.) 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of AMSCO (Air Mechanical and Service Corp.) 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AMSCO (Air Mechanical and Service Corp.) 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A - DESCRIPTION OF PLAN

The following description of the AMSCO (Air Mechanical and Service Corp.) (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement and related Plan amendments for a more complete description of the Plan’s provisions and applicable legislation and regulations for additional information.

1. General

The Plan established and effective December 1, 1996, and subsequently amended, is a defined contribution plan (profit sharing). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 401(a) of the Internal Revenue Code of 1986 (IRC). The Company is the Plan “Sponsor” and “Plan Administrator”.

The Plan provides for various investment options through its participation in various pooled separate accounts. The Plan is an ERISA 404(c) plan, with participants having the opportunity to direct the investment of all the assets allocated to their individual accounts. Investment securities are exposed to various risks, such as interest rate, market and credit risks.

All non-excluded employees of the Company who have attained age 21 and completed 6 months of service are eligible to participate in this Plan. Hours of service are determined based upon actual hours for which an employee is paid or entitled to payment.

2. Participant Contributions

Eligible participants can contribute up to \$23,000 of pre-tax annual compensation (salary reduction), subject to certain IRS limitations, and could contribute up to \$7,500 of pretax annual compensation (salary reduction) as a catch-up additional deferral, subject to certain IRS limitations.

There are no plan-imposed limits on the amount that eligible Participants may defer, subject to the maximum allowable limits.

3. Employer Contributions

The Employer’s match may be a discretionary percentage allocated proportionately to the participant’s salary deferrals, flat dollar amount, or tiered formula, as the employer selects each year.

The Company provided matching contributions of 50% of the employees contributions up to the first 6% of the participants compensation for the year ended December 31, 2024.

NOTE A - DESCRIPTION OF PLAN - Continued

4. Participant Accounts

Each participant's account is maintained separately within the Plan and is credited with the participants elective deferrals, allocations of employer matching contributions and Plan earnings or losses. Allocations of Plan earnings or losses are allocated based on specific identification to the participant's account, and any allocation of Plan earnings or losses not specifically identified would be allocated based on the participant's account balances, as defined in the Plan.

All participant accounts are participant directed.

5. Vesting

Participants are immediately 100% vested in their deferral contributions plus earnings thereon. Vesting in the Employer matching contributions are incrementally vested over six years of credited service. There is zero vesting for less than 2 years of credited service, then 20% for each year thereafter. Participants are immediately 100% vested upon reaching normal retirement age, death, total disability or termination of the Plan.

6. Payment of Benefits

Upon attainment of normal retirement age, death, disability, or termination of service, a participant or his/her beneficiary may elect to receive a lump-sum distribution amount, subject to IRS limitations and requirements.

7. Forfeited Accounts

The Plan began the year with \$455 in forfeitures, and had \$7,199 in new forfeitures, and utilized approximately \$5,900 during the year ended December 31, 2024. At the end of the year, there was \$1,754 in the Plan's forfeited non-vested accounts of matching contributions. Forfeited balances, if any, of terminated participant's non-vested matching contribution accounts may be used to reduce current or subsequent years employer contributions or may be used to offset Plan administration fees.

8. Investment Options

Participants direct their contributions to a variety of pooled separate accounts offered by the plan. John Hancock Life Insurance Company (U.S.A.) is the Plan's trustee and is responsible for safekeeping the assets of the plan. Employer contributions are directed to the participant's elective deferrals.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting. Benefit payments are recorded when paid.

2. Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded in the ex-dividend date and are reinvested into the same financial security. Net investment appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

3. Expenses

Certain administrative expenses of the Plan are paid by the Plan and are reflected in the Plan's financial statements. However, certain legal and other expenses of the Plan are paid by the Company and, therefore, are not included in the accompanying financial statements. The Plan Sponsor (employer) absorbs the significant costs of plan administration.

4. Payment of Benefits

Benefits are recorded when processed and paid by the Plan. There were no participants who had elected to withdraw from the Plan as of December 31, 2024, that had not yet been paid.

5. Use of Estimates

The preparation of the accompanying financial statements in conformity with generally accepted accounting principles ("GAAP") in the U.S. requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE (Unaudited)

The investments of the Plan were held and administered by John Hancock Life Insurance Company (U.S.A.) during the years as of and ended December 31, 2024 and 2023. In accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA, the Plan administrator has elected not to have this information audited by the Plan’s independent certified public accountants.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The standard describes three levels of inputs that may be used to measure fair value:

- Level 1      Inputs to valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;
- Level 2      Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and
- Level 3      Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

NOTE D - FAIR VALUE MEASUREMENTS - Continued

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

*Pooled separate accounts:* Valued at the net asset value (“NAV”) of units held by the Plan at year end. Investments in these accounts are valued at quoted market prices of the issuer.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INCOME TAX STATUS

The Company has adopted a prototype plan. The Internal Revenue Service has determined and informed the Company that the Plan is designed in accordance with the Internal Revenue Code. The Plan has been amended since receiving the original favorable determination and has received favorable determination of the amendments. In the opinion of the Plan Administrator, the Plan has been operated in accordance with the Internal Revenue Code and ERISA and will be considered exempt from federal income taxes. The Plan Administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements and that the Plan is currently being operated in accordance with the Plan agreement. Accordingly, income taxes have not been provided for in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - SUBSEQUENT EVENTS

The Plan's management has evaluated events and transactions occurring subsequent to December 31, 2024, as of October 2, 2025, which is the date the financial statements were available to be issued.
