Independent Auditors' Report

To the Participants and Plan Administrator of the
Emeriti Retiree Health Plan for Kenyon College
Gambier, Ohio

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Emeriti Retiree Health Plan for Kenyon College (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statement section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Emeriti Retiree Health Plan for Kenyon College (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Participation

The Plan is a defined contribution health and welfare plan sponsored by Kenyon College (the "College") covering all eligible employees and certain retirees of the College, as defined in the Plan agreement, who are at least 21 years of age and have completed at least one year of service. The Plan was established July 1, 2007. The Plan pays a portion of the retirees' selected health insurance premiums and reimburses participants for the cost of eligible medical expenses, as set forth in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Eligible employees may voluntarily contribute a portion of their after-tax annual compensation, as defined by the Plan. There are no set limits on the amounts of employee after-tax contributions. The College begins making employer contributions to the Plan on behalf of each eligible employee as soon as administratively possible after the employee attains the age of 35 and completes one year of service. The College's contribution is based on an annual fixed dollar amount for each eligible participant, adjusted annually as determined at the discretion of Plan management. The College will cease making employer contributions to a participant's account as of the earliest of the date when the College has made contributions for 25 years, the participant ceases to be employed by the College, or the participant dies.

Employee and employer contributions are held in two separate trusts under a Voluntary Employees' Beneficiary Association.

Participants' Accounts

Alta Trust Company ("Alta"), from December 17, 2024 through December 31, 2024 and Teachers Insurance & Annuity Association of America and College Retirement Equities Fund, together, ("TIAA-CREF") from January 1, 2023 through December 16, 2024, the Custodians, maintain an individual account for each participant within each trust, one trust for employer contributions and the other for employee contributions. These accounts are credited with the College's contributions, any voluntary employee contributions, and an allocation of earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. Participants directed the investment of the contributions to their accounts into various investment options offered by the Plan.

Retirement Eligibility and Payment of Benefits

A participant who is employed by the College meets the requirements for payment of benefits under the Plan upon a) attaining age 59 1/2, having performed at least ten years of continuous service, b) attaining age 65, having performed at least five years of continuous service, or c) if you become permanently disabled while employed by the Employer, you will be deemed to have met the requirements for eligibility.

Note 1. Description of Plan (Continued)

Retirement Eligibility and Payment of Benefits (Continued)

Upon meeting the requirements for payment of benefits under the Plan, participants select a coverage option, for which the Plan pays up to 30% of premium costs from the participant's accumulative employer contribution trust. In addition, participants are reimbursed for allowable medical expenses for themselves, spouses, domestic partners, and those individuals appropriately designated as dependents from the participant's accumulative employee and employer contribution trusts. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Employer and employee contributions and earnings are available for reimbursement of future medical expenses and insurance premiums. The Plan is not liable for expenses beyond the assets in a participant's account.

Vesting and Forfeitures

Participants are immediately vested in their after-tax contributions and earnings thereon. Participants who have satisfied retirement eligibility as defined in the Plan document will not forfeit their accumulative employer contribution account balance upon termination of employment except as noted below. Participants who have completed ten years of continuous service become vested in employer contributions.

The residual balance (if any) remaining after a participant and any eligible dependents are deceased is forfeited to the Plan. Forfeited employer contributions are used to reduce the College's future contributions to the Plan. Forfeited employee contributions are allocated among participants with a positive balance in their employee contribution account.

At December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$-0- and \$60,607, respectively. During the years ended December 31, 2024 and 2023, \$58,579 and \$73,960, respectively, of forfeited non-vested employer contributions were used to reduce employer contributions.

Termination Provision

Although it has not expressed any intent to do so, the College has the right to amend, modify, suspend, or terminate the Plan subject to the provisions of ERISA. No amendment, modification, suspension, or termination of the Plan shall have the effect of providing that any amounts then held under the Plan may be used or diverted to any purpose other than for the exclusive benefit of participants or their beneficiaries. In the event of Plan termination, participants will become 100% vested in their accounts and the assets then remaining in the funds will be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan holds various investment options in combinations of investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Oversight Committee determines the Plan's valuation policy utilizing information provided by the investment advisors and the Custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Administrative Expenses

Administrative costs are paid by the College or the Plan at the option of the College. Under the terms of the Plan and related agreements, from December 17, 2024 through December 31, 2024, OneBridge Benefits (TIAA-CREF from January 1, 2023 through December 16, 2024) has authority to execute investment transactions pursuant to participants' elections. From December 17, 2024 through December 31, 2024, OneBridge Benefits (TIAA-CREF from January 1, 2023 through December 16, 2024) provides administrative services to the Plan and maintains Plan-related records. From January 1, 2024 through December 16, 2024, Emeriti Retirement Health Solutions ("Emeriti") and CBIZ Benefits & Insurance Services ("CBIZ") also provided certain administrative services to the Plan. The administrative expenses on the statements of changes in net assets available for benefits primarily represent fees deducted from participants' accounts for services performed by OneBridge Benefits, TIAA-CREF, Emeriti, and CBIZ for the years ended December 31, 2024 and 2023.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through the date of the accompanying Independent Auditor's Report, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The money market fund consists of a short-term investment fund that maintains daily liquidity and has a constant unit value of \$1.00 and is classified as Level 2.

From December 17, 2024 through December 31, 2024, registered investment companies are Vanguard and Schwab funds (TIAA-CREF funds from January 1, 2024 through December 16, 2024) which are based on market quotations or prices from independent pricing services and are classified as Level 1.

Note 3. Fair Value Measurements (Continued)

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Unaudited Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management has received a certification from Alta from December 17, 2024 through December 31, 2024, and TIAA-CREF from January 1, 2023 through December 16, 2024, acknowledging the completeness and accuracy of all investments reflected on the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at December 31, 2024, the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 5. Tax Status

The trusts established under the Plan to hold the Plan's assets are intended to qualify as tax-exempt, pursuant to Internal Revenue Code ("IRC") Section 501(c)(9). The trusts have obtained a favorable determination letter from the Internal Revenue Service, and the College believes that the trusts, as amended, continue to qualify and operate in accordance with the applicable provisions of the IRC.

Note 5. Tax Status (Continued)

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 6. Party-in-Interest Transactions

From December 17, 2024 through December 31, 2024, Alta is the Plan Custodian and fiduciary, and qualifies as a party-in-interest. From December 17, 2024 through December 31, 2024, Schwab is the sub-custodian, therefore, the transactions involving these investments and administrative expenses paid from them qualify as party-in-interest transactions. Schwab offers certain investments held at Vanguard, therefore, transactions involving these investments qualify as party-in-interest transactions. From December 17, 2024 through December 31, 2024, OneBridge Benefits is the recordkeeper and TPA of the Plan, and qualifies as a party-in-interest. From January 1, 2024 through December 16, 2024, CBIZ, formerly Savitz, was the co-fiduciary and TPA of the Plan, and qualifies as a party-in-interest.
