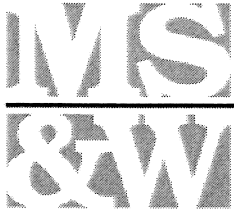

INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the
Century Plastics, LLC 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Century Plastics, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Century Plastics, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the John Hancock Life Insurance Company (U.S.A.), a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Century Plastics, LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Century Plastics, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1. DESCRIPTION OF PLAN

The following description of Century Plastics, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, sponsored and administrated by Century Plastics, LLC (the "Plan Sponsor" or "Company"). The Plan is offered to all eligible non-union employees, who have completed six months of service and attained the age of 18, as defined by the Plan document. Eligible employees are enrolled into the Plan on the first day of the Plan year quarter coinciding with or next following date after eligibility requirements are met. Eligibility for the matching contributions requires the employee to complete six consecutive months of service.

The effective date of the Plan is January 2007, as amended on January 1, 2016. Furthermore, the Plan was amended and restated effective January 1, 2022, to include new provisions and changes to the Internal Revenue Code ("IRC"). There were no significant changes to the provisions of the Plan as a result of this restatement. The assets of the Plan are maintained, and the transactions therein are executed, by John Hancock Life Insurance Company (U.S.A.) (the "Custodian"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may elect to defer an amount of their annual compensation, as defined in the Plan, which cannot exceed the limits permitted under Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 or older may elect to make a "catch-up" contribution, not to exceed IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers) and Roth elective deferrals.

The Company contributes safe harbor matching contributions in an amount equal to 100% of the first 3% of a participant's eligible compensation, and 50% of the next 2% of a participant's eligible compensation contributed to the Plan. Employer safe harbor matching contributions are subject to certain limitations under the IRC. The Company made safe harbor matching contributions of \$409,371 and \$417,041 for the years ended December 31, 2024 and 2023, respectively.

In addition, the Company may make profit sharing contributions to the Plan as determined by resolution of its board of directors. The Company elected not to make such contributions for the years ended December 31, 2024 and 2023.

Participants' Accounts

Participants direct the investment of both their contributions and employer safe-harbor matching contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's safe harbor matching contribution, (b) Plan earnings, and (c) the Plan Sponsor's profit-sharing contributions, if any, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions, rollover contributions and the Company's safe harbor matching contributions plus actual earnings. Vesting in the Company's discretionary profit-sharing contributions is based on years of continuous service. A participant is vested 20% per year of service and attains 100% vesting after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of a note for general purpose may not exceed five years; however, if the loan is used for the purchase of a primary residence, the maximum term may not exceed ten years. The notes are secured by the balance in the participant's account and bear interest at rates that ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. A participant may have one loan outstanding at any point in time.

If a participant fails to make a payment when a loan is due under the terms of the loan, that participant will be in default. In the event of default, the loan shall become due and payable immediately, and interest will continue to accrue until the entire loan balance is repaid. The Plan will take all reasonable actions to collect the balance owed on the loan. Under certain circumstances, the loan in default could be considered a distribution from the Plan and could be considered income to the participant. In any event, failure to repay a loan will reduce the benefit a participant would otherwise be entitled to from the Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, or upon reaching the age of 59-1/2, a participant may elect to receive the value of their vested account balance in a lump sum, substantially equal periodic installments or partial withdrawals, as described in the Plan document. The Plan also allows withdrawals in the event of certain financial hardship; however, there are associated account restrictions, as defined in the IRC. For vested account balances of former employees of more than \$1,000, participants may elect to receive a single lump-sum payment at any time after the participant's date of termination. If a participant's account balance does not exceed \$1,000, then a distribution will be made, regardless of whether the participant provides consent to receive it.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts, if any, are used to reduce future Plan Sponsor contributions or are applied to pay administration fees. As of December 31, 2024 and 2023, the amount of forfeited non-vested accounts was \$0 for both years,

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The investment in pooled separate accounts is valued at the net asset value (the "NAV") per share, as determined by the Custodian at year end. The NAV is used as the practical expedient to estimate fair value and is based on the fair value of the underlying investment held by the fund, less its liabilities and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in the net appreciation or depreciation in the fair market value of such investments.

Investment Alternatives

The Plan has an investment contract with the Custodian. Under the terms of the contract, the Custodian maintains the contributions in pooled separate accounts. Each participant establishes his or her own separate investment account within the pooled separate accounts. Investment accounts are sub-accounts within the pooled separate accounts, which primarily consists of mutual funds. The pooled accounts are entirely segregated from the general funds of the Custodian and are subject to the investment direction of the participants. Contributions into a participant's investment account purchase units of the sub-accounts. An investment in a fund will fluctuate in value to reflect the investment results of the fund's holding. The value of an account is determined by the value of the sub-account multiplied by the number of units in the account. Any income, gains or losses, whether realized or unrealized, will be credited to or charged against the account without regard to the other income, gains or losses of the Custodian. The sub-accounts are subject to an annual investment charge. The Plan allows inter-account transfers.

Payment of Benefits

Benefits are recorded when paid to the Plan participants.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Direct fees for custodian and record-keeping services are paid by the Plan and are also included in administrative expenses. Investment-related expenses are included in "Net appreciation in fair value of investments" in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

In accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 855, *Subsequent Events*, the Plan has evaluated subsequent events through September 15, 2025, the date on which these financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

Assets measured at fair value are based on the NAV used as the practical expedient for the pooled separate accounts.

The fair values of the investments have been estimated using the NAV of the investments:

To pursue this goal, the portfolio, which is a fund of funds, normally invests approximately 80% of its assets in underlying funds that invest primarily in equity securities, and approximately 20% in underlying funds that invest primarily in fixed-income securities. The portfolio offers instant and broad diversification with exposure to a wide range of asset classes and investment styles.

(c) The growth funds portfolio seeks long-term growth of capital. Current income is a consideration. To pursue this goal, the portfolio, which is a fund of funds, normally invests its assets in underlying funds that invest primarily in the common stocks of large and medium-sized companies (U.S. and foreign). The portfolio offers instant and broad diversification with exposure to a wide range of asset classes and investment styles.

(d) The fixed-income funds portfolio seeks a high level of current income by primarily investing in foreign debt securities of developed and emerging markets, U.S. government and agency securities, and U.S. high yield bonds. The funds may also invest in preferred stock and other types of debt securities.

(e) The aggressive growth funds portfolio seeks long-term growth of capital. Current income is not a consideration. To pursue this goal, the portfolio, which is a fund of funds, normally invests approximately 100% of its assets in underlying funds that invest primarily in equity securities. The portfolio offers instant and broad diversification with exposure to a wide range of asset classes and investment styles.

(f) The conservative funds portfolio seeks maximize total return through income and capital appreciation.

NOTE 5. INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary profit-sharing contributions.

NOTE 7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor.

The Plan currently holds units of pooled separate accounts managed by the Custodian or an affiliate of the Custodian. Accordingly, these transactions and the Plan's payment of fees to the Custodian qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 8. TAX STATUS

The Plan uses a non-standardized prototype plan document sponsored by The Benefit Advantage Inc. which received an opinion letter from the IRS, dated November 30, 2020, stating that the prototype document satisfies the applicable provisions of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
