Independent Auditor's Report

To the Plan Administrator

Opinion

We have audited the financial statements of CNA Health and Group Benefits Program (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and the related statement of changes in net assets available for benefits and changes in benefit obligations for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and the changes in net assets available for benefits for the year then ended and the benefit obligations as of December 31, 2024 and the changes in benefit obligations for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

CNA Health and Group Benefits Program Notes to Financial Statements

Note A. Description of Plan

The following brief description of the CNA Health and Group Benefits Program (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

CNA Financial Corporation (CNA), a majority-owned subsidiary of Loews Corporation, established the Plan on January 1, 1985. The Plan was established to provide health benefits for all eligible employees and retirees of certain subsidiaries of CNA and their eligible dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Continental Casualty Company (CCC), an indirect wholly-owned subsidiary of CNA, is the Plan Sponsor. The trustees of the Plan are senior executives of CCC.

Pursuant to Section 403(a) of ERISA, the CNA Employees' Health Plan Trust (the Master Trust) was established to invest and manage the assets of the Plan and distribute certain benefit payments to participants on behalf of participating plans. In the fourth quarter of 2024, in preparation for a restructuring of the Master Trust, certain benefit payments to participants began to be distributed on behalf of the Plan by the Plan Sponsor and the Plan assets in the Master Trust were liquidated. Further information on the Master Trust is provided in Note E to the Financial Statements.

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify benefits, discontinue its contributions at any time, or terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, any assets remaining after all liabilities of the Plan have been satisfied shall be applied to the cost of any successor health care program adopted by the Plan Sponsor for the benefit of its employees.

Benefits

The Plan provides health benefits including medical, dental and short-term disability coverage, a health care spending account plan, wellness benefits and an employee assistance plan to active employees. The Plan also provides certain postretirement health care benefits to eligible retired employees, their covered dependents and their beneficiaries. These postretirement benefits have largely been eliminated for active employees.

Contributions

The major sources of funds for the Plan are contributions from the Plan Sponsor and participants. Before the start of the plan year, the Plan Sponsor establishes rates for the various health benefit coverage levels from which employees and retirees select coverage. The amount employees and retirees contribute is determined by the number of dependents covered and the selected coverage levels. Employee contributions are made through payroll deductions. Retiree contributions are collected either on a direct-bill basis or deducted from monthly pension benefits. The Plan Sponsor pays a significant portion of the benefit cost of the Plan and the amount of its contributions are primarily based on benefit payment activity.

Certain participants may elect to extend coverage to eligible dependents and contribute specified amounts determined periodically by the Plan's actuary. The costs of the postretirement benefit plan are shared by the Plan Sponsor and the Plan's participating retirees. The retirees paid approximately 43% of the Plan's cost of providing postretirement benefits for themselves, their covered spouses and dependents during 2024. In 2024, increases in estimated annual postretirement benefit costs over 4% were included in determining contributions to be made by retirees.

The Plan Sponsor is liable for any deficits accumulated by the Plan and funds them through cash contributions.

Exempt Party-In-Interest

The Master Trust had an investment issued by JPMorgan Chase Bank, N.A. JPMorgan Chase Bank, N.A. is the custodian of the assets of the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions.

Note B. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP). The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the financial statements and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results may differ from those estimates.

Administrative Expenses

Administrative expenses of the Plan were paid by the Plan. Additionally, the Plan sponsor provides certain administrative services to the Plan at no charge.

Contributions Receivable

Employer contributions are recognized in the plan year in which claims are paid on behalf of participants.

Benefits Paid to Participants

Benefits paid to participants were made through the Master Trust. In the fourth quarter of 2024, in preparation for a restructuring of the Master Trust, benefits paid to participants began to instead be made through the Plan Sponsor. Benefits paid to participants are recorded when paid. The Plan utilizes a pharmacy benefit manager which periodically provides rebates contractually due to the Plan based upon the level of prescription drug utilization. Rebates are recorded as receivables when collection is probable and the amount is estimable; when those criteria are not met, rebates are recorded when received. Prescription drug rebates of \$8,822 thousand have been recorded as an offset to Benefits paid to participants on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Investment Valuation and Income Recognition

The Plan's interest in the Master Trust was carried at fair value, which was determined based on the fair value of the underlying investments in the Master Trust. Purchases and sales of securities were recorded on the trade date. Interest income from the Master Trust was recorded on an accrual basis. In the fourth quarter of 2024, in preparation for a restructuring of the Master Trust, the Plan assets in the Master Trust were liquidated.

Benefit Obligations

The Amounts payable portion of the Plan's benefit obligation represents reported claims payable and claims incurred but not reported as of December 31, 2024 and 2023. Health claims incurred but not reported are estimated by the Plan's actuary in accordance with generally accepted actuarial standards and are based primarily on historical data and expectations of future claims.

The Postretirement benefit obligations, net of amounts payable, represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered through December 31, 2024 and 2023, reduced by the actuarial present value of contributions to be received in the future from current participants. Postretirement benefits include future benefits expected to be paid to or for i) eligible currently retired employees and their dependents, and ii) eligible active employees and their dependents after retirement from service. The postretirement benefit obligation represents the amount that is to be funded from existing Plan assets and by contributions from the Plan Sponsor. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary. This is the amount that results from applying actuarial assumptions to historical claims cost data to estimate

future annual incurred claims costs per participant and to adjust such estimates for the time value of money and the probability of payment, and to reflect the portion of those costs expected to be borne by Medicare, retirees and other providers.

Note C. Benefit Obligations

The significant assumptions underlying the actuarial estimate of the postretirement benefit obligations were as follows.

The Plan Sponsor has limited its share of the health care trend rate to a cost-of-living adjustment of 4% per year (Employer cap). For all participants, the employer subsidy on health care costs will not increase by more than 4% per year. As a result, a one percentage point increase in the health care trend rate would not affect the postretirement benefit obligation as of December 31, 2024.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The postretirement benefit obligation represents the amount that is to be funded from existing plan assets and by contributions from the Plan Sponsor. Net assets available for benefits represents the point in time balance of the Plan's net assets, and will continually change, primarily due to additions in the form of employee, retiree and employer contributions and by deductions for claims paid.

Note D. Tax Status

The Plan's Master Trust obtained a letter from the Internal Revenue Service (IRS) dated March 31, 1988, in which the IRS recognized the Master Trust's exempt status under Sections 501(a) and 501(c)(9) of the Internal Revenue Code (IRC). Although the Master Trust document has been amended since receiving the IRS letter, the Plan's Sponsor believes that the Master Trust is currently designed, and both the Plan and the Master Trust are being operated, in accordance with applicable requirements of the IRC. Therefore, no provision for taxes has been included in the Plan's financial statements except to the extent the Plan recognized trust income in excess of the allowable limit. There are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The IRS is not currently examining the Plan.

Note E. Plan Interest in the Master Trust

The Plan's interest in the assets of the Master Trust was 100% as of December 31, 2024 and 2023. Net assets and investment income are allocated based on the Plan's interest in the Master Trust.

Note F. Fair Value

Fair value is the price that would be received upon sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The following fair value hierarchy is used in selecting inputs, with the highest priority given to Level 1, as these are the most transparent or reliable.

Level 1 - Quoted prices for identical instruments in active markets.

Level 2 - Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs are observable in active markets.

Level 3 - Valuations derived from valuation techniques in which one or more significant inputs are not observable.

The Plan attempts to establish fair value as an exit price in an orderly transaction consistent with normal settlement market conventions. The Plan is responsible for the valuation process and seeks to obtain quoted market prices for all securities. The Master Trust held no investments as of December 31, 2024. As of December 31, 2023 the Master Trust's short-term investments included U.S. Treasury Bills and JP Morgan U.S. Government Capital Shares. These securities were actively traded and had quoted market prices and, as such, were classified as Level 1.

Note G. Contingencies

The Plan is subject to ERISA regulations, which allow participants to appeal the level of benefits received under the Plan. If participants do not receive a favorable reply to their appeal, they have the right to escalate their appeal to legal action.

The Plan and the Plan Sponsor may be parties to litigation arising in the ordinary operation of the Plan. Based on the facts and circumstances currently known, such litigation will not, in the opinion of the Plan Sponsor, materially affect the Plan's financial statements.

Note H. Subsequent Events

Management has evaluated all subsequent events through September 8, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan no longer has an interest in the Master Trust and is no longer funded by the Master Trust, but instead is entirely funded by the Plan Sponsor. Effective December 31, 2025, the Plan will no longer provide postretirement health care benefits to any retired employees, their covered dependents or their beneficiaries.
