1. **Description of the Plan** The following description of the MAXIMUS GSA Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan covering substantially all employees of Maximus, Inc. (the "Company") and its affiliates, except for nonresident aliens, employees covered by a collective bargaining agreement, and all employees of Maximus, Inc. or its affiliates who are not (i) employed by Maximus Federal Services, LLC or any successor thereto, including Maximus Services LLC, (ii) provided fringe benefits in accordance with or by reference to the Service Contract Act and (iii) covered under the GSA National Administered Group. Participants enter the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: The Plan provides for Company prevailing wage contributions on behalf of eligible employees who perform services covered under the McNamara-O'Hara Service Contract Act or other prevailing wage laws, in the amount as the Company may determine is required to be contributed under such laws to meet the required benefit levels. An amount shall not be eligible for contribution to the Plan until the eligible employee's premium reserve account within the Fringe Benefit Plan for Service Contract Act Employees of Maximus, Inc., as defined by that plan, has in excess of six months of premiums for health and welfare coverage. The Company may also make discretionary nonelective contributions to the Plan. No such contributions were made for the year ended December 31, 2024. Participants may contribute amounts representing distributions from other qualified plans (rollovers). Participant direct the investment of rollover contributions and Company prevailing wage contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the Company's prevailing wage contributions, allocations of discretionary nonelective contributions, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in all contributions, plus actual earnings thereon. Different vesting schedules may apply to account balances of participants due to prior Plan provisions as described in the Plan document.

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 55, death, disability, or termination of employment. Hardship withdrawals and in-service withdrawals are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment, annuity or partial payments.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51,531 and \$60,953, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, \$14,839 of forfeited nonvested accounts were used to pay Plan expenses and no forfeited nonvested accounts were used to reduce Company contributions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as distribution administration fees, are charged directly to the participant's account and are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Company prevailing wage contributions are recognized in the period the hours are worked.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through September 25, 2025, which is the date the financial statements were available to be issued.

3. Certified information Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair value measurements The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the shares of publicly traded securities under the self-directed brokerage account option is based on the closing price reported on the active market on which the individual securities are traded.

- 5. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 6. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 7. Tax status** The Plan is a pre-approved plan of FMR, LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Fidelity Management Trust Company ("Fidelity"). Fidelity is the trustee and recordkeeper as defined by the Plan. During 2024, \$108,162 was paid for trustee, recordkeeping, and audit fees to Fidelity and the Plan's auditor. At December 31, 2024 and 2023, \$25,481 and \$29,268, respectively, was owed for these services and reported as accrued expenses in the Statements of Net Assets Available for Benefits. These transactions qualify as exempt party-in-interest transactions.

The Plan was a party to a plan expense agreement with Fidelity Management Trust Company which terminated in 2019. At December 31, 2024 and 2023, the Plan had unallocated funds of \$234,721 and \$245,947, respectively, which was available to pay future Plan expenses. During 2024, \$22,946 was used to pay Plan expenses.
