CNA Supplemental Unemployment Benefit Plan Notes to Financial Statements

Note A. Description of Plan

The following brief description of the CNA Supplemental Unemployment Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

Continental Casualty Company (CCC), an indirect wholly-owned subsidiary of CNA Financial Corporation (CNA), established the Plan effective April 1, 2013. CNA is a majority-owned subsidiary of Loews Corporation. The Plan was established to provide supplemental unemployment compensation, employment incentive payments and separation benefits to eligible employees of CCC and CNA National Warranty Corporation (CNAN) who have been involuntarily terminated due to job elimination or reduction in force. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. CCC is the Plan Sponsor.

Supplemental unemployment compensation payments to Plan participants are made through the CNA Employees' Health Plan Trust (the Master Trust). The Trustees of the Master Trust are senior executives of CCC. Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify benefits, discontinue its contributions at any time, or terminate the Plan subject to the provisions set forth in ERISA. Upon amendment to or termination of the Plan, an employee's right to participate in or receive Plan benefits may be changed provided any such amendment or termination does not adversely affect the employee's rights to any remaining unpaid benefits for which payment had commenced or was payable to the employee.

Benefits

The benefits provided under the Plan combined with unemployment compensation benefits received from the state in which the participant was employed by CCC or CNAN represent a participant's total unemployment benefits. The benefit period is dependent on full-time or part-time employment status, years of service, age at the time of termination and if and when a participant obtains new employment. The amount of benefits received from the Plan are dependent upon current base pay and the amount of state unemployment compensation benefits.

Contributions

The Plan is funded by contributions from the Plan Sponsor. Contributions for supplemental unemployment compensation payments to the Master Trust occurred monthly through the third quarter of 2024. In the fourth quarter of 2024, in preparation for a restructuring of the Master Trust, contributions to the Master Trust for supplemental unemployment compensation payments began to occur weekly. Contributions for employment incentive payments and separation benefits, which are made from general corporate assets of the Plan Sponsor at the time of payment to the participants, were \$1,372 thousand for the year ended December 31, 2024.

Note B. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP). The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the financial statements and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results may differ from those estimates.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan as provided in the Plan document. Additionally, the Plan sponsor provides certain administrative services to the Plan at no charge.

Note C. Benefit Obligations

The postemployment benefit obligation represents estimated amounts payable to eligible participants that have been terminated or notified of termination and for probable termination decisions made by management that are reasonably estimable. Amounts payable are reduced by the estimated amount of state unemployment benefits expected to be received by the participants and anticipated savings due to employment incentive payments. The Plan's estimates for state unemployment benefits and employment incentive payments are based on the Plan's historical benefit payment experience.

The postemployment benefit obligation was \$526 thousand and \$814 thousand as of December 31, 2024 and 2023. The decrease in the postemployment benefit obligation compared to the prior year relates to the number of terminated eligible participants who had outstanding accrued benefits as year-end as well as the relative size of the participant balances outstanding. The postemployment benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor as denoted in the Contributions section in Note A.

Note D. Tax Status

The Plan's Master Trust obtained a letter from the Internal Revenue Service (IRS) dated March 31, 1988, in which the IRS recognized the Master Trust's exempt status under Sections 501(a) and 501(c)(9) of the Internal Revenue Code (IRC). Although the Master Trust document has been amended since receiving the IRS letter, the Plan's Sponsor believes that the Master Trust is currently designed, and both the Plan and the Master Trust are being operated, in accordance with applicable requirements of the IRC. Therefore, no provision for taxes has been included in the Plan's financial statements, and there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The IRS is not currently examining the Plan.

Note E. Plan Interest in the Master Trust

The Plan's interest in the assets of the Master Trust was 0% as of December 31, 2024 and 2023. Net assets and investment income are allocated based on the Plan's interest in the Master Trust.

Note F. Fair Value

Fair value is the price that would be received upon sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The following fair value hierarchy is used in selecting inputs, with the highest priority given to Level 1, as these are the most transparent or reliable.

Level 1 - Quoted prices for identical instruments in active markets.

Level 2 - Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs are observable in active markets.

Level 3 - Valuations derived from valuation techniques in which one or more significant inputs are not observable.

The Plan attempts to establish fair value as an exit price in an orderly transaction consistent with normal settlement market conventions. The Plan is responsible for the valuation process and seeks to obtain quoted market prices for all securities. The Master Trust held no investments as of December 31, 2024. As of December 31, 2023 the Master Trust's short term investments included U.S. Treasury Bills and JP Morgan U.S.

Government Capital Shares. These securities were actively traded and had quoted market prices and, as such, were classified as Level 1.

Note G. Reconciliation to Form 5500

Certain amounts reported on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 differ from the amounts as reported on the Plan's Form 5500 for 2024. Reconciliations of Employer contributions and Benefits paid to participants for the year ended December 31, 2024 to the Form 5500 are presented in the tables below.

Employment incentive payments and separation benefits are sourced from general corporate assets of the Plan Sponsor at the time of payment to the participants and do not flow through the Master Trust. Employer contributions and Benefits paid to participants as reported on the Form 5500 only include payments that flow through the Master Trust. Therefore, employment incentive payments and separation benefits represent a reconciling item.

Note H. Contingencies

The Plan is subject to ERISA regulations, which allow participants to appeal the level of benefits received under the Plan. If participants do not receive a favorable reply to their appeal, they have the right to escalate their appeal to legal action.

The Plan and the Plan Sponsor may be parties to litigation arising in the ordinary operation of the Plan. Based on the facts and circumstances currently known, such litigation will not, in the opinion of the Plan Sponsor, materially affect the Plan's financial statements.

Note I. Subsequent Events

Management has evaluated all subsequent events through August 27, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan assumed 100% interest in the Master Trust.
