**NOTE A – DESCRIPTION OF PLAN**

The following description of the Electronic Contracting Company Profit Sharing Plan and Trust (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General and Eligibility**

The Plan was established on January 1, 1986 and is a defined contribution plan covering substantially all employees of Electronic Contracting Company (the Company). Employees who are 21 years of age are eligible to make salary deferral contributions to the Plan and enter the Plan on the first day of each calendar quarter coinciding with or following the eligibility date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to qualify under the applicable sections of the Internal Revenue Code of 1986, as amended. The Plan is a safe harbor 401(k) Plan.

**Contributions**

Each year, participants may contribute, in the form of pretax or after-tax (Roth) deferrals, up to 100% of compensation, as defined in the Plan, provided the contribution does not exceed limits established by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Employer contributions consist of a safe harbor matching contribution equal to 100% of the participant's contribution up to 4% of the employee's eligible annual compensation as defined by the Plan. Employees who are at least 21 years of age are eligible for matching contributions.

The Company may also provide a discretionary annual profit-sharing contribution. Participants are eligible for the profit-sharing contribution if the participant has completed 1,000 hours of service, had 1,000 hours of service in the Plan year and is employed on the last day of the year. Entrance dates are the first day of the Plan year or the first day of the seventh month coinciding with or following the eligibility date. The profit-sharing amount contributed to the Plan each year is determined by the management of the Company. The contribution is allocated to participants based on a combination of the participant's salary and their years of service with the Company. Profit sharing contributions were \$0 and \$242,022 for the years ended December 31, 2024 and 2023, respectively.

Participants direct the investment of participant and safe harbor matching contributions into various options offered by the Plan. Non-elective profit-sharing contributions are directed into a general investment account managed by Union Bank & Trust Company and ratably allocated to participants.

**Participants' Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, Plan earnings (losses), and an allocation of the Company's discretionary profit-sharing contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, Company safe harbor and prevailing wage matching contributions plus actual earnings (losses) thereon. Discretionary matching contributions (prior to January 2020) are fully vested after completion of three years of service. Discretionary profit-sharing contributions vest on a graduated scale from 20% vesting at the completion of two years of service to 100% after six years of service. Company contributions also vest 100% upon normal retirement, death, or disability.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period not to exceed assumed life expectancy. Withdrawals are also allowed a) at the attainment of age 59 ½ and b) for hardship distributions, which are subject to certain restrictions.

**Forfeited Accounts**

Forfeitures from nonvested accounts are retained in the Plan and used to pay Plan expenses or fund future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,130 and \$0, respectively.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported additions to and reductions from net assets. Actual results could vary from estimates used.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan Administrator has evaluated subsequent events through August 26, 2025 which is the date the financial statements were available to be issued.

**NOTE C – INFORMATION CERTIFIED BY UNION BANK & TRUST COMPANY**

The following is a summary of the investment information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedules that were prepared by or derived from information provided by Union Bank & Trust Company (Union Bank and Trust), the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following investments is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets as of:

**NOTE D – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust:* The common/collective trust fund is valued based on the fair value of underlying investments comprising the trust. It has a readily determinable fair value as the price is determined, published (to applicable parties), and is the basis for current transactions.

*Money Market:* The money market fund is a public investment vehicle valued using a net asset value of \$1 and is deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – TAX STATUS**

The Plan adopted a pre-approved plan sponsored by Union Bank & Trust Company. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision of liability for income taxes has been included in the financial statements. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods prior to December 31, 2021.

**NOTE F – PLAN TERMINATION**

Although the Company has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H – RELATED PARTY TRANSACTIONS**

The Plan incurred expenses in the amount of \$3,375 and \$2,065 for annual trustee, investment, and administrative services fees with Union Bank and Trust during the years ended December 31, 2024 and 2023, respectively. The Company also provides certain administrative services at no cost to the Plan. All transactions with related parties were conducted on terms equivalent to those prevailing in an arm's-length transaction.
