Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Schroder US Holdings Inc. and Subsidiaries Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and was established on January 1, 1989, to cover all full-time and part-time employees of Schroder US Holdings Inc. and Subsidiaries (the "Company"). Employees are immediately eligible to make deferrals into the Plan and are eligible for matching and discretionary contributions after completing two months of continuous service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan administrator is Schroder US Holdings Inc. The Company is responsible for the general administration of the Plan. Vanguard Fiduciary Trust Company is the trustee (the "Trustee"), and the Vanguard Group, Inc. is the recordkeeper for the Plan.

Contributions

Each year, participants may contribute a portion of their pretax annual base compensation, as defined in the Plan, but not more than the amount permitted by law. Current law limits participants' deferrals to \$23,000 for the year ended December 31, 2024. Participants who are over 50 years of age during the Plan year may make an additional contribution of up to \$7,500 during 2024. Additionally, participants can make elective deferrals as designated Roth contributions (which are included in gross income). The Company contributes to the Plan, subject to Internal Revenue Service ("IRS") limitations, for each plan year (or portion of a plan year) that an employee is a participant in the Plan including, (a) a Company matching contribution of 50% of up to 6% of the pretax annual base compensation or Roth contribution that a participant elects to contribute to the Plan and, (b) a fixed and discretionary profit sharing contribution, as defined in the Plan. For 2024, this contribution was 11% (10% Fixed Contribution and 1% Discretionary Contribution) of the participant's total annual compensation, as defined in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and the allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Distribution from a participant's account may be made upon termination of employment, In-service withdrawals, disability, death and hardship of the participant in accordance with written election made by the participant and/or other applicable provisions of the Plan.

Vesting

The Company's matching contribution and discretionary contributions vests 25% for each year of service, as defined by the Plan.

If a participant leaves the Company before vesting, no benefits will be received from the Plan attributable to non-vested Company matching contribution and discretionary contribution.

Until a participant has four years of continuous service, he/she will not be fully entitled to the additional 10% employer contribution. The percentage of vesting is as follows:

Years of continuous service upon termination	Vested portion of Account is
Less than 1	0 %
1, but less than 2	25 %
2, but less than 3	50 %
3, but less than 4	75 %
4 or more	100 %

The entire portion of a participant's account which is attributable to rollover contributions, as defined, is 100% vested at all times.

Investment Options

Under the terms of the Plan, the participant makes all investment decisions with respect to his/her account balance, subject to available investment alternatives.

Forfeited Accounts

If a participant terminates service, the unvested portion of the account balance becomes a forfeiture. Forfeiture balances may be used to reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$148,727 and \$453,147, respectively. The 2024 forfeitures credited were \$338,923. In 2024, Company contributions were reduced by \$100,000.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are collateralized by the balance in the participant's account and bear interest at the prime rate plus 1% as of the issuance date. Principal and interest is paid ratably through semi-monthly payroll deductions. Notes are repayable up to five years.

Payment of Benefits

Payment of vested benefits under the Plan will be made in the event of a participant's termination of employment, including death and certain defined disabilities and financial necessity, and may be paid in either a lump-sum distribution or installments as determined by participant election and IRS rules.

Income Tax Status

The underlying volume submitter pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the "Code") and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status.

The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States (“US GAAP”) require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with US GAAP.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments in Registered Investment Companies (Mutual Funds). Shares of Common/Collective Trusts (“CCT”) are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are valued at amortized cost, which represents fair value.

Payment of Benefits

Benefits are recorded when paid.

3. Risks and Uncertainties

The Plan invests in various investment instruments, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

4. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants

for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustee.

5. Fair Value Measurements

The Company utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(a) In accordance with FASB ASC Subtopic 820-10, certain investments that were measured at net asset value have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits. The fair value of the Plan's interest in CCT or pooled funds are based on the NAV after adjustments to reflect all fund underlying investments at fair value. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. There are no restrictions as to the redemption of these investments nor does the Plan have any contractual obligations to further invest in any of these funds.

6. Administrative Expenses

The Plan agreement requires all expenses incurred in the administration of the Plan to be paid by the Trustee from the Plan's assets except to the extent that the Company shall otherwise provide for such payments. Although not required by the Plan agreement, the Company paid all of the Plan expenses in 2024 with the exception of terminated deferred participants paying the annual recordkeeping fee.

7. Related Party and Parties-In-Interest Transactions

The Plan invests in shares of mutual funds managed by an affiliate of the Trustee, and the Plan invests in units of Common / Collective Trusts and / or funds for which an affiliate of the Company acts as an investment advisor and / or a sub-advisor. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. The total investment of the parties-in-interest was \$215,881,721 and \$188,709,338 as of December 31, 2024 and 2023, respectively.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

10. Subsequent Events

Effective September 1, 2025, the Plan changed trustees and recordkeepers from Vanguard Fiduciary Trust Company and the Vanguard Group, Inc. to Fidelity Management Trust Company and Fidelity Workplace Services LLC, respectively.

Management has evaluated the events and transactions that have occurred through September 30, 2025, the date the financial statements were available to be issued and noted no items requiring adjustment of the financial statements or additional disclosures.
