We have performed audits of the financial statements of The Cutter Team 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

(1) Description of Plan

The following description of The Cutter Team 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Cutter Management Co., as well as its wholly owned subsidiaries and affiliated companies (collectively, the Companies). The Plan is subject to the provisions of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of Plan Assets

Cutter Management Co. is the plan administrator and is responsible for the investment, administration, and disbursement of plan assets. The Retirement Plan Committee oversees the management and administration of the Plan. Empower Trust Company, LLC (the Plan Trustee) is the plan trustee through a trust agreement with the Companies.

Eligibility

All employees of the Companies, as stated in the plan agreement, are eligible to participate in the Plan following the later of attaining the age of 21 or on the date which the participant completes the earlier of six consecutive months of service commencing from the date of hire or rehire, or a year of service during a 12-month period during which the employee worked at least 1,000 hours. Participants become eligible for matching contributions once completing at least one hour of service during the plan year. Participants are eligible for profit-sharing contributions if regularly employed at the rate of at least 20 hours of service per week or credited with a year of service during the plan year. Additionally, to be eligible for profit-sharing contributions, the participant must be an employee on the last day of the plan year.

Contributions

Eligible employees of the Companies are entitled to make salary deferrals to the Plan up to the lesser of 100% of the participant's eligible compensation or the maximum amount allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified plans or individual retirement accounts. Additionally, participants who attain age 50 before the end of a calendar year may elect to make additional catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations, which was \$7,500 for the plan year ended December 31, 2024.

The Companies may make discretionary matching or profit-sharing contributions as determined by their respective board of directors. For the year ended December 31, 2024, the Companies elected to make a discretionary employer matching contribution of 50% of the participant's deferral contribution to the Plan up to a maximum of 2% of the participant's eligible compensation. The Companies did not elect to make any profit-sharing contributions for the year ended December 31, 2024. The aggregate of all matching and profit-sharing contributions cannot exceed statutory compensation limits as defined in the plan agreement.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' matching contributions and an allocation of (a) the Companies' profit-sharing contribution, if any, and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investment accounts are participant directed.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less the highest outstanding balance of any loans for the one year period preceding loan issuance or 50% of their vested account balance, provided that the loan is paid back with interest within five years. However, if the loan is for the purchase of a participant's principal residence, the plan administrator may permit a longer repayment term. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest as determined by the plan administrator based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Current interest rates range from 4.25% to 9.50%. Participants may only have one loan outstanding at a time. If a participant fails to make a payment required under the terms of the participant loan and the Plan, a deemed distribution shall occur on the last day of the calendar quarter following the calendar quarter in which the participant failed to make the payment.

Vesting

Participants are immediately vested at all times in account balances attributed to their salary deferrals and rollover contributions plus earnings or losses thereon.

Participants become 100% vested in employer discretionary matching and profit-sharing contributions after completing six years of eligible service in accordance with the following schedule:

Payment of Benefits

Upon a participant's death, permanent disability, retirement, or other termination of employment from the Companies, the participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a fixed period, selected by the participant, that does not extend beyond the life expectancy of the participant and that of a designated beneficiary. However, if a participant's vested interest in his or her account is \$5,000 or less, the participant's vested interest shall be distributed in a lump-sum as soon as practicable. Under certain circumstances, a participant may qualify for a hardship distribution and receive a lump-sum payment equal to all or a portion of the participant's account balance.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$23,322 and \$27,827, respectively, and were available to pay administrative expenses and/or reduce future employer contributions. In 2024 and 2023, \$1,370 and \$84 of forfeitures was used to pay plan administrative expenses, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Participants are allocated a portion of administrative and accounting fees as stated in the plan agreement. Fees related to notes receivable from participants, distributions, and annual asset charges are charged directly to the respective participant's account and are included in administrative expenses. Administrative expenses recorded in the Plan during the year ended December 31, 2024 totaled \$130,973.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, the Plan Trustee, and third party administrators. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Realized and unrealized appreciation in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation, or on the last day of the year for unrealized appreciation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

(4) Fair Value Measurements

The accounting guidance for fair value measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

The preceding measurement described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) General Account - Guaranteed Interest Account

The Plan has a fully benefit-responsive investment contract (the Contract) with Massachusetts Mutual Life Insurance Company (MassMutual). On December 31, 2020, Empower Retirement (Empower) acquired the retirement business of MassMutual and became the sole administrator of this business in 2021. Great-West Life & Annuity Insurance Company (GWLA), an affiliate of Empower, manages the Contract. GWLA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This guaranteed investment contract meets the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by GWLA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$5,265,667 and \$5,654,787, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the Contract Issuer. Such events include but may not be limited to the following: (1) partial or complete plan termination or (2) the establishment or activation of, or material change in, any plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

(6) Risks and Uncertainties

The Plan invests in various types of investment securities. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(7) Tax Status

The Internal Revenue Service (IRS) has determined and informed the plan administrator by a letter dated January 10, 2011 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and thus qualifies the Plan for tax exempt status.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

(9) Related Party Transactions

Certain plan investments represent units of mutual funds and a general account managed by Empower. Additionally, Empower receives revenue from investment providers for services Empower provides to the funds, amounting to \$50,245 for the year ended December 31, 2024, which is reported as other income in the accompanying statement of changes in net assets available for benefits. This revenue is placed into an expense budget account and used to offset certain administrative expenses to the Plan. These transactions, therefore, qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
