INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the Jottan, Inc. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Jottan, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Jottan, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that Plan management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jottan, Inc. Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Jottan, Inc. Retirement Savings Plan (the “Plan”) provides only general information. The Plan was originally effective January 1, 1988, and was most recently amended and restated effective January 1, 2024 (see Note 10). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution Plan covering eligible employees of Jottan, Inc. (the “Company”, “Plan Sponsor” or “Employer”), as described in the Plan document, who meet the eligibility requirements of the Plan. Employees are eligible to participate in the Plan, for deferral purposes, upon attaining age 21. Employees are eligible to begin receiving matching contributions upon attaining age 21 and completing one year of service. Participants are eligible to receive profit-sharing contributions, and prevailing wage contributions upon attaining age 18. Union employees and leased employees are not eligible to participate in the Plan. Transamerica Trust Company is the custodian of the Plan, and the recordkeeper is Transamerica Retirement Solutions, LLC (collectively “Transamerica”). Reliance Trust Company (“Reliance”) is the former custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan document. Contributions may also be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may elect to make matching Employer contributions to the Plan based on a discretionary percentage of base compensation that a participant contributes to the Plan. To qualify for the matching Employer contributions, a participant must be employed on the last day of the Plan year (with the exception of death, disability or attainment of normal retirement age). For the year ended December 31, 2024, the matching Employer contributions were 25 percent of the base compensation that participants contributed to the Plan.

The Company may also make discretionary profit-sharing contributions to the Plan. To qualify for the discretionary profit-sharing contributions, a participant must be employed on the last day of the Plan year (with the exception of death, disability or attainment of normal retirement age). No discretionary profit-sharing contributions were made for the Plan year ended December 31, 2024.

Employees who perform services subject to prevailing wage contracts are immediately eligible to participate in the Plan for the purposes of receiving a qualified nonelective contribution. Qualified nonelective contributions relating to prevailing wage contracts totaled \$769,595 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Code (“IRC”) limits. Participants direct the investment of their deferral contributions and Employer contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Participant Accounts

Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s contributions and the discretionary matching Employer contributions, if any, as well as allocations of the Company’s discretionary profit-sharing and qualified nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and qualified nonelective contributions, plus actual earnings thereon. Vesting in discretionary matching Employer and the Company's profit-sharing contributions portion of their accounts, plus related earnings thereon is based on years of vesting service in which the participants complete 1,000 hours of service, as follow:

Notwithstanding the above vesting for the discretionary matching Employer and the Company's profit-sharing contributions portions of their accounts, a participant will become 100% vested in these accounts upon their attainment of normal retirement age while an employee, attainment of early retirement age as defined by the Plan while an employee, death while an employee, or becoming disabled while an employee.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. Forfeitures may be applied to payment of administrative expenses and/or to reduce Employer contributions. During the year ended December 31, 2024, forfeitures of \$0 were used to reduce Employer contributions, and forfeitures of \$4,522 were used to pay administrative expenses of the Plan.

Payment of Benefits

Upon termination of service, death, disability, retirement or separation from service, participants or their beneficiaries will receive, in a lump-sum payment, an amount equal to the value of the participant's vested interest in his or her account. Participants may also elect to receive distributions in substantially equal installments or non-recurring partial payment. Distributions after termination for reason other than death, normal retirement (age 59.5), or early retirement (age 55 and completing 10 years of service), except as noted in the Plan document, are distributed on the date the participant requests a distribution, but no earlier than twelve months after the date of termination or severance from employment. If a distribution is not requested, the Plan will distribute balances of less than \$1,000 in lump-sum distributions. Balances over \$1,000 but less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), unless specified by the terminated participants, will be paid to the participants in a direct rollover to an individual retirement plan designated by the Plan administrator. Hardship and in-service distributions are also available in certain limited circumstances, as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of a primary residence. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024. No more than one loan from the Plan to a participant shall be permitted at any time.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by custodians, recordkeepers and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the discretionary matching Employer contributions are recorded in the year in which the employee contributions are withheld from compensation. Discretionary profit-sharing contributions, if any, and prevailing wage contributions are recorded in the year earned.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including recordkeeper and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by Qualified Institutions

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. 5. Fully Benefit-Responsive Investment Contract

The Plan holds the Transamerica Stable Value Core Option through a group annuity contract at Transamerica Life Insurance Company (“TLIC”). This traditional investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses. The contract values of the investment contract were \$297,129 and \$309,010 as of December 31, 2024 and 2023, respectively.

With a traditional investment contract, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers. Participants do not have contracts; instead, they have a beneficial interest in the group annuity contract of the Plan. There are not any specific securities in the general account that back the liabilities of this annuity contract. The Plan owns a promise to pay interest at crediting rates that are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. In addition, certain events (including but not limited to the Plan ceasing to meet the requirements of the IRC; the Plan is terminated; the fiduciaries fail to comply with the requirements of the contract; or the sum of the contract account value at any time equals \$20,000 or less) allow the issuer to terminate the contract with the Plan and/or settle at an amount different from contract value. If a plan sponsor wishes to remove the fully benefit-responsive investment contract as an option from the Plan, TLIC may impose a hold for up to a 270-day period on the fully benefit-responsive investment contract. Additionally, under limited circumstances that would materially adversely affect the financial condition of the fully benefit-responsive investment contract, TLIC may impose up to a 12-month delay period on all withdrawal requests from all plan sponsors at the Plan level.

The Transamerica Stable Value Core Option seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis and there is no set maturity. The effective credited interest rate for the Transamerica Stable Value Core Option is set semi-annually and was 1.65% and 1.25% as of December 31, 2024 and 2023, respectively. Contract charges may reduce this return. There are no reserves against the Transamerica Stable Value Core Option for credit risk of the contract issuer or otherwise.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events (including but not limited to a 90-day equity wash provision where transfers are not allowed to a competing fund for 90 days) might limit the ability of the Plan to transact at contract value with the contract issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in statements of net assets available for benefits.

7. Related-Party and Party-in-Interest Transactions

Reliance is the former custodian, and Transamerica and/or its affiliates is the custodian and recordkeeper, and Dunbar, Bender & Zapf, Inc. is the third-party administrator to the Plan. The Plan has a fully benefit-responsive investment contract with TLIC. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Direct fees paid by the Plan for services provided by Transamerica were \$15,308 and \$11,650 was paid to Dunbar, Bender & Zapf, Inc. for the year ended December 31, 2024. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

9. Tax Status

Effective January 1, 2024, through the adoption of a Dunbar, Bender & Zapf, Inc. Non-Standardized Defined Contribution Pre-Approved Plan, the Plan was amended and restated. The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, stating that the 401(k)/profit sharing non-standardized plan document as then designed was in accordance with applicable IRC requirements. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10. Amendments

Effective January 1, 2024, through the adoption of a Dunbar, Bender & Zapf, Inc. Non-Standardized Defined Contribution Pre-Approved Plan, the Plan was amended and restated in order to incorporate past amendments and make other general administrative changes to the Plan.

11. Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
