In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tanner Memorial Clinic 401k Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedules Required by ERISA**

The supplemental Schedule of Assets Held at End of Year, December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to the Financial Statements For the Years Ended December 31, 2024 and 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Tanner Memorial Clinic 401k Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of the Company who have one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees the governance of the Plan.

#### **Contributions**

Contributions to the Plan include: (i) salary reduction contributions authorized by participants, (ii) safe harbor matching contributions made by the Company, (iii) discretionary matching contributions made by the Company, (iv) discretionary nonelective contributions made by the Company including profit sharing contributions and (iv) participant rollovers from other plans.

Participants may elect to contribute a percentage of their eligible compensation, as defined by the Plan document, to the Plan each year, subject to the limitations of the Internal Revenue Code (IRC). Regular 401(k) contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Roth 401(k) contributions are not excluded from the participant's taxable income for federal income tax purposes, but withdrawals of contributions and earnings thereon at retirement are tax free. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution to each participant's account equal to 100% of the first 6% of each participant's eligible compensation contributed to the Plan. In addition, the Company, at its discretion, contributes annually to the Plan an amount determined by management. Allocations to participants are to the extent of 3.0% of each participant's compensation. Next, the committee will allocate the employer contribution proportionately to the accounts of those participants whose compensation for the Plan year exceeds the Plan's designated integration level. The committee then will allocate the balance of the employer contribution for the Plan year based on each participant's total proportionate compensation. Compensation in excess of the integration level bears to the sum of all participants' compensation in excess of the integration level but not in excess of the maximum profit-sharing disparity rate. Any remaining contributions or forfeitures will be allocated in the ratio that each participant's compensation for the year bears to all participants' compensation.

The Plan may accept a rollover contribution made on behalf of any eligible participant who has met the service requirements.

#### **Participant Accounts**

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and Company contributions, as well as Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balance into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### **Vesting**

Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant becomes vested based on years of credited service, as follows:

### **Payment of Benefits**

On termination of service due to death or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, lump sum and installments, or in annual installments over a period not to exceed the life expectancy of the participant or the beneficiary. Benefits are recorded when paid. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 1/2.

### **Hardship Distributions**

The Plan permits certain hardship distributions as defined by the plan. The distributions are distributed in the same manner as regular distributions.

### **Forfeitures**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future employer contributions or pay Plan administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,610 and \$41,575, respectively. During 2024, Employer contributions were reduced by \$59,466 and forfeitures of individual account balances totaled \$30,049.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

### **Estimates**

The preparation of financial statements, in conformity with generally accepted accounting principles, requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Employer contributions, dividends, and other revenue are on the accrual basis. A portion of the Plan's investments are in the Bank of America Retirement Preservation Trust. Bank of America holds the trust. The value is based on the beginning of year value of the Plan's interest in the trust, plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. Quoted market prices are used to value investment in the trust.

**Investment Options**

A participant has the right to direct the trustee with respect to the investment or reinvestment of the assets comprising the participant's individual account only if the trustee consents in writing to permit such direction. The trustee will maintain a segregated investment account to the extent a participant account is subject to participant self-direction.

**Insurance Benefit**

The employer may elect to provide incidental life insurance benefits for insurable participants who consent to life insurance benefits. The accumulation of cash value on these assets are included in Plan assets.

**Notes Receivable from Participants**

The Plan permits the advisory committee to adopt a policy under which the Plan may make loans to participants and beneficiaries. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The policy made by the board will allow loans up to a five-year buy-back period with interest of 1.0% over prime. Principal and interest are paid ratably through monthly payroll deductions.

**Plan Termination**

The Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Administrative Expenses**

The Company absorbs a significant amount of Plan expenses including the cost to audit the Plan.

**Terminated Employees**

The Plan had net assets of \$14,088,600 and \$15,086,702 at December 31, 2024 and 2023, respectively, allocated to participants who have terminated, but remain in the Plan.

**Date of Management's Review and Subsequent Events**

Management has evaluated subsequent events through September 25, 2025, the date which the financial statements were available to be issued.

**3. INVESTMENTS**

The Plan's investments are held in an investment Company-administered trust fund. Expenses are netted against investment gains.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

SFAS No. 157, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 has quoted market prices of the issuer, and level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available amounts to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and 3 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

### Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

### Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued using the NAV practical expedient.

*Pooled separate accounts:* Valued at the closing price on the market.

#### **4. INFORMATION PREPARED AND CERTIFIED BY INSTITUTION**

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by Bank of America, the Trustee, which included all investments except for the insurance cash surrender value as of December 31, 2024 and 2023, certain investment income (loss) for the year ended December 31, 2024 as noted in the following table, and all information included in the supplemental schedule H, line 4i— schedule of assets (held at end of year).

Bank of America is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$110,066 and \$72,819 for the years ended December 31, 2024, and 2023, respectively. The employer pays the investment and management fees to the Plan sponsor. The Plan sponsor and Plan administrator are parties in interest.

#### **5. TAX STATUS**

The Plan was amended and restated, effective January 1, 2022. The Plan uses a prototype plan document sponsored by Merrill Lynch, Pierce, Fenner & Smith, Inc. The prototype plan document received an opinion letter from the IRS which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the Internal Revenue Service. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan Administrator has analyzed the tax positions of the Plan and has concluded that as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits in tax jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

#### **6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

## **7. INSURANCE CONTRACTS**

The Plan maintains an insurance contract in a “stable value account”. These contracts are included in the financial statements at contract value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. The stable value account is credited with interest and charged for Plan withdrawals and administrative expenses.
