We recommend that plan management monitor outstanding loan balances with a last payment date in excess of 90 days, specifically for those belonging to participants who have terminated, to ensure these loans are defaulted and offset.

We have also determined that the investment information is prepared and certified by a qualified institution as described by 29 CFR 2520.103-8, that the certification meets the requirements in 29 CFR 2520.103-5 and, that the certified investment information is appropriately measured, presented, and disclosed in accordance with accounting principles generally accepted in the United States of America.

5. We have responded fully and truthfully to all your inquiries.

***Plan Design & Operations***

6. We acknowledge our responsibility for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the ERISA plan financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.
7. The Plan and the trust established under the plan are qualified under the appropriate section of the Internal Revenue Code, and we intend to continue them as a qualified Plan and trust. We do not have any intention at present to terminate the Plan. Required nondiscrimination testing under the appropriate Code Sections has been completed for the Plan, and any excess contributions have been disposed of in accordance with regulations.
8. The adoption date of the most recent plan amendment was January 1, 2025 as provided to you.
9. The Plan together with the investment vehicles, is intended to be a tax-sheltered plan under Section 403(b) of the Internal Revenue Code. We are aware the Plan has not requested nor obtained a determination letter. However, we believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, we believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.
10. The Plan has complied with the fidelity bonding requirements of ERISA.
11. The Plan has made no investments during the year that violate the terms of the Plan or Trust Agreement.
12. We have reviewed the reports of all transactions processed by third-party services, and, based on our review, we believe the transactions shown in the reports are valid and in accordance with our instructions to the third-party processor. We also have had no communications from any of the Plan's service organizations regarding any fraud, noncompliance with laws and regulations, or uncorrected misstatements.
13. We have complied with the DOL's regulations concerning the timely remittance of participant contributions and loan repayments.
14. As applicable, we have complied with the DOL's regulations concerning the services provider fee disclosures in accordance with Section 408(b)(2).
15. We understand the values of the assets and liabilities recorded in the financial statements could change rapidly, resulting in material future adjustments to investment values that could negatively impact the Plan. We acknowledge that you have no responsibility for future changes caused by the current economic environment and the resulting impact on the Plan's financial statements. Further, the Plan Sponsor is solely responsible for all aspects of managing the Plan, including questioning the quality and valuation of investments.
16. Rutland Regional Medical Center is an exempt organization under Section 501(c)(3) of the Internal Revenue Code. Any activities of the organization or any related entities of which we are aware that would jeopardize the organization's tax-exempt status have been disclosed to you.
17. To the best of our knowledge and belief, the net assets available for plan benefits as of December 31, 2024 and 2023 represent all assets relevant to the Plan and there are no assets that have been improperly excluded.

18. We have evaluated whether there are conditions or events known or reasonably knowable, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year of the date of this letter without consideration of potential mitigating effects of management's plans not yet fully implemented and concluded substantial doubt does not exist.

***Misappropriation, Misstatements, & Fraud***

19. We have informed you of all current risks of a material amount that are not adequately prevented or detected by our procedures with respect to:
- a. Misappropriation of assets.
  - b. Misrepresented or misstated assets or liabilities.
20. We have no knowledge of fraud or suspected fraud affecting the Plan involving:
- a. Management or employees who have significant roles in internal control over financial reporting, or

Also, we are not aware of any litigation or claims, pending or threatened, for which legal counsel should be sought.
26. We have no knowledge of communications, other than those specifically disclosed, from regulatory agencies, governmental representatives, employees, or others concerning investigations or allegations of noncompliance with laws and regulations, deficiencies in financial reporting practices, or other matters that could have a material adverse effect on the financial statements.

We understand that "near term" means the period within one year of the date of the financial statements. In addition, we have no knowledge of concentrations, which refer to volumes of loans, investments, or deposits, existing at the date of the financial statements that would make the Plan vulnerable to the risk of severe impact in the near term that have not been properly disclosed in the financial statements.

***Fair Value***

42. With respect to the fair value measurements of financial assets and liabilities, recognized in the financial statements or disclosed in the notes thereto:
- a. The underlying assumptions are reasonable and they appropriately reflect management's intent and ability to carry out its stated course of action.
  - b. The measurement methods and significant assumptions used in determining fair value are appropriate in the circumstances for financial statement measurement and disclosure purposes and have been consistently applied.
  - c. The significant assumptions appropriately reflect market participant assumptions.
  - d. The disclosures related to fair values are complete, adequate, and in conformity with accounting principles generally accepted in the United States of America.
  - e. There are no subsequent events that require adjustments to the fair value measurements and disclosures included in the financial statements.

**Investments**

43. Investments are properly measured at fair value, except for fully benefit responsive investment contracts which are reported at contract value. Investments measured at fair value include:
- a. Investments with a readily determinable fair value that are reported at net asset value (NAV) per share/unit.

**Off-Balance Sheet Risk**



## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Rutland Regional Health Services Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rutland Regional Health Services Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of Rutland Regional Health Services Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions, which is available from the plan administrator.

**General**

The Plan is a defined contribution plan sponsored by Rutland Regional Medical Center (Medical Center) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Medical Center. Participants are also immediately eligible to qualify for matching contributions. Participants must complete one year of service to qualify for nonelective contributions. Related employers who also participate in the Plan include Vermont Orthopedic Clinic (collectively the “Medical Center”).

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company serves as plan custodian.

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Medical Center make annual contributions of up to 80% of eligible compensation. Employee rollover contributions and Roth contributions are also permitted by the Plan. Participants who have attained age 50 before the end of a plan year are eligible to make catch-up contributions. The Medical Center makes matching contributions equal to 25% of participants’ deferrals to the Plan, including employee catch-up contributions, up to a maximum of 2% of compensation. The Medical Center also makes nonelective contributions that are at the sole discretion of the Medical Center as follows:

For employees hired before April 4, 2004, and all physicians, the Medical Center may contribute to the Plan, on the participants’ behalf, a nonelective employer contribution equal to a specified percentage of their compensation based upon the participants’ age and completed years of service:

<u>Combined Age and Years of Service</u>	<u>Percentage of Compensation</u>
< 40	4%
40 - 59	6%
60 - 79	8%
80 +	10%

For general employees hired on or after April 4, 2004, the Medical Center may contribute to the Plan on the participants’ behalf a nonelective employer contribution equal to 4% of their compensation.

To receive employer nonelective contributions, a participant must be an eligible employee and completed one year of service with the Medical Center.

#### ***Automatic Enrollment***

The plan document includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation, unless the participant made an affirmative election otherwise, upon completion of 30 days of service with the employer. Also, the Plan will auto-enroll rehired employees the first day of every February and August immediately following the applicable rehire date. In addition, each participant satisfying the eligibility requirements will be automatically enrolled in the Plan on the first day of every February and August unless the participant has otherwise made an election to decline the auto-enrollment within the preceding 180 days. For participants who have been automatically enrolled in the Plan, the automatic increase cap is 10% for all participants. If participants do not wish to participate in the Plan, they have the opportunity to opt-out of participation within the first 90 days of being automatically enrolled in the Plan. Any amounts automatically contributed to the Plan on the participant's behalf will be returned.

#### ***Participant Investment Account Options***

Investment account options available include various funds or a self-directed brokerage account. Each participant has the option of directing the contributions to his account into any of the separate investment accounts and may change the allocation daily.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Medical Center's contribution, and plan earnings. Participants are charged a flat annual administrative fee to offset administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions, the Medical Center's matching contributions, and the Medical Center's nonelective employer contributions plus earnings thereon.

#### ***Payment of Benefits***

If a participant ceases to be an employee of the Medical Center and his account balance is less than \$1,000, the entire vested account balance will be payable to the participant or his beneficiaries in a single lump-sum payment. Balances greater than \$1,000 but less than \$5,000 are to be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant.

Participant balances of \$5,000 or more can remain in the Plan until such time the participant elects to receive a distribution. A participant may elect to receive a lump-sum amount, systematic withdrawals (installments), or an annuity equal to the vested value of his account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

#### ***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Participants are allowed to have no more than two loans outstanding at any time. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 reduced by the greater of the outstanding balance on any loan from the Plan to the participant on the date the loan is made or the highest outstanding balance on loans from the Plan to the participant during the one-year period ending on the day before the date the loan is approved (not taking into account any payments made during such one-year period); or one-half of the value of the participant's vested account balance (as of the valuation date immediately preceding the date on which such loan is approved).

All loans are secured by the pledge of the participant's vested account balance, not to exceed the balance of the loans and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Effective January 1, 2019, any new loans are to be paid via ACH transfer from the participant's personal bank account. Interest on the loans is based on the USA Today published prime rate as of the date the loan is processed.

### **Note 2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds and money markets are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Principal Fixed Account, a fully benefit-responsive investment contract, is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals, and administrative expenses.

The Fidelity BrokerageLink account holds investments which are not standard options of the Plan as directed by participants. Mutual funds held in the BrokerageLink account are valued at the NAV of shares held at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant terminates employment, a participant may repay his loans by sending payment for the amount due to the plan administrator or continue monthly ACH payments to the custodian. A loan is considered to be in default if a participant fails to make all or any part of a required loan repayment by the end of the calendar quarter which follows the calendar quarter in which the repayment was due. Outstanding loan balances in default will be treated as outstanding for purposes of determining any future loan amounts. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Medical Center or the Plan, at the Medical Center's discretion.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are mutual funds managed by Fidelity Management Trust Company, which is the custodian to the Plan.

The Plan has a fee agreement with Fidelity Management Trust Company from which it receives revenue sharing funds which are recorded in the nonallocated revenue credit account invested in the Vanguard Institutional Target Retirement Income Fund and the Fidelity Government Money Fund. The purpose of this account is to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance or to be allocated to participant accounts. The ERISA spending account decreased by \$16,452 in 2024 and increased by \$24,486 in 2023, and is included in administrative expenses on the statements of changes in net assets available for benefits. ERISA spending account funds utilized to pay plan related expenses of \$44,447 and \$0 during 2024 and 2023, respectively. The ERISA spending account balance at December 31, 2024 and 2023, was \$36,333 and \$53,762, respectively.

Certain legal and accounting fees and other administrative expenses relating to the maintenance of employee eligibility records are paid by the Medical Center.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

#### ***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

#### **Note 6. Investment Contract with Insurance Company**

The Plan invests in the Principal Fixed Account, a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The Principal Fixed Account is fully benefit responsive, therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract value of the Principal Fixed Account at December 31, 2024 and 2023, is \$5,205,299 and \$5,105,371, respectively.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 9. Tax Status**

The Plan, together with the investment vehicles, is intended to be a tax-sheltered plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax.

**Note 10. Plan Termination**

Although it has not expressed an intention to do so, the Medical Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through August 28, 2025, which is the date the financial statements were available to be issued.

***Employer Contributions***

Effective January 1, 2025, the Plan was amended to increase the employer matching contribution percentage from 25% to 50% of participants' deferrals to the Plan up to a maximum of 2% of compensation.
