## NOTE A - DESCRIPTION OF PLAN

The following brief description of Star Extruded Shapes, Inc. 401(k) Profit Sharing Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan, which began January 1, 1995, is a defined contribution 401(k) profit sharing plan covering substantially all employees of Star Extruded Shapes, Inc., Star Fab, Inc., Leebaw Manufacturing Co. Inc., and Trailex, Inc. (collectively referred to as the Company). Employees of the Company are eligible to participate in the Plan after having completed one year of service, defined as 1,000 annual hours, and reaching a minimum age of 21 years old. The plan entry date is the first day of the plan year or the first day of the seventh month of the plan year following attainment of the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

The Plan permits eligible employees to voluntarily contribute up to 100% of annual compensation to the plan through pre-tax and Roth salary deferrals subject to annual limits set by law. Participants may contribute up to \$23,000 for 2024 and \$22,500 for 2023, with participants over age 50 eligible to contribute an additional \$7,500 in 2024 and 2023 of deferred compensation earned while a participant under the Plan. The Company contributes matching contributions at 50% of the employee deferral up to 4% of gross pay. In addition, the Company, at its discretion, may contribute a share of its net profits to the Plan as determined by the Company's board of directors.

Rollover contributions from other Plans are accepted, providing certain specified conditions are met.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contribution, discretionary contributions, the Plan earnings and losses and administrative expenses. Allocations of the Plan's earnings and losses are based on the proportion that each participant's account bears to the total of all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Company's discretionary contributions are allocated based on a percentage of wages to participants who were actively employed on the last day of the plan year and who have at least 1,000 hours of service during the Plan year. The Company did not make any discretionary contributions for the years ended December 31, 2024 and 2023.

### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Graduated vesting in the employer's discretionary contribution and employer match portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes vested in employer matching and discretionary contributions as follows:

#### Forfeitures

If a participant is not vested upon termination, the non-vested portion of their account balance contributed by the employer and the earnings thereon are forfeited. Forfeited amounts are first used to reduce administrative expenses with remaining amounts used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,680 and \$4,354. Employer contributions and plan expenses were reduced by \$3,390 and \$3,640 at December 31, 2024 and 2023, respectively.

#### Payment of Benefits

Upon termination of service, termination of the Plan, termination of employer's business, or upon attainment of age 65 by the participant, a participant may receive a lump sum, partial withdrawals or installments permitted for required minimum distributions under Code Section 401(a)(9). The participant may take an early retirement distribution of all or a portion of their entire vested account at age 59 ½ while they are still employed with the Company. A participant may withdraw all or a portion of any rollover contributions in their account without limit.

#### Plan Termination

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation

Investments are stated at fair value by Capital Bank & Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable totaled \$24,066 and \$22,626 at December 31, 2024 and 2023, respectively. The Plan distributed the 2023 excess contributions to the applicable participants in 2024 and the 2024 excess contributions to the applicable participants in 2025.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Substantially all expenses of maintaining the Plan are paid by the Company. Investment related expenses are included in the net appreciation of fair value of investments.

### NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information in the accompanying financial statements and ERISA-required supplemental schedules related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's trustee, Capital Bank and Trust Company.

### NOTE D - FAIR VALUE MEASUREMENTS

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 fair value inputs are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted market prices in active markets for similar assets, quoted prices in markets that are not active for identical or similar assets and other market observable inputs such as interest rate, credit spread and foreign currency exchange rates observable in the marketplace or derived from market transactions.

Level 3 fair values are based on at least one significant unobservable input for the asset. Level 3 securities contain unobservable market inputs and as a result considerable judgment may be used in determining the fair values.

Certain investments are measured at fair value using the net asset value (NAV) per share, or its equivalent, as a practical expedient. These investments include commingled funds which may include money market funds, common collective trusts and pooled separate accounts which are typically valued using the NAV provided by the administrator of the fund. The Plan assets include money market funds. In accordance with accounting guidance, these investments have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted markets prices on the last business day of the Plan year.

*Money market:* As a practical expedient, valued at the NAV of shares held by the Fund as year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE F - PARTY-IN-INTEREST TRANSACTIONS**

Certain parties provide services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. These services are parties-in-interest transactions. The Plan also invested in certain mutual funds and money market funds which are owned and managed by the Trustee. These transactions also qualify as party-in-interest transactions. The services rendered to the Plan by the auditor are paid for by the employer.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE H - SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued. In April 2025, Star Extruded Shapes, Inc. and Star Fab, Inc. were sold to a third-party. As of the date of the sale, Leebaw Manufacturing Co. Inc., and Trailex, Inc., entered into a spinoff agreement where the two Companies will no longer be participating employers of the Star Extruded Shapes, Inc. 401(k) Plan. As of the date of this report, Star Extruded Shapes, Inc. and Star Fab, Inc. are still operating under new ownership and management has no intentions to terminate the Plan.
