## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Procurement Advisors LLC 401(k) Profit Sharing Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Procurement Advisors LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **1. DESCRIPTION OF PLAN**

### **General**

The following description of Procurement Advisors LLC 401(k) Profit Sharing Plan and Trust (the Plan) is a defined contribution employee benefit plan that provides for tax-deferred savings contributions from participants as well as matching and discretionary contributions from Procurement Advisors LLC (the Company or Employer).

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

### **Eligibility**

The Company's employees will be eligible to participate in the Plan upon attaining the age of 21 with no minimum service requirement. The Company's employees who are covered by a collective bargaining agreement or are nonresident aliens with no income from a U.S. source are not eligible to participate in the Plan. Eligible employees can enter the Plan immediately upon meeting all requirements.

### **Administration**

The Plan is administered by the Retirement Committee. The members of the Retirement Committee are approved by the Board of Directors (the Board) of the Company. The duties of the Retirement Committee include interpretation of the Plan agreement, determination of benefits due to participants and authorization of disbursements from the net assets available for benefits.

### **Trustee**

Fidelity Management Trust Company (Fidelity) is the trustee for the Plan.

### **Contributions**

Each year, eligible participants may contribute pretax deferrals or Roth deferrals up to 92% of their eligible compensation, as defined in the Plan, not to exceed the amount allowed by the Internal Revenue Code (IRC). Participants may also make rollover contributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes safe harbor matching contributions on a payroll period basis equal to (a) 100% of the eligible participant's elective deferral contributions that do not exceed 3% of the participant's compensation for the Plan year, and (b) 50% of the participant's elective deferral contributions that exceed 3% but do not exceed 5% of the participant's compensation for the Plan year. The Company may also make additional discretionary matching contributions at the option of the Company. In order to participate in the allocation of the discretionary matching contributions, a participant is required to be employed by the Company on the last day of the Plan year. The Company did not make an additional matching contribution or a discretionary contribution during the year ended December 31, 2024. Contributions are subject to certain IRC limitations.

**Participant Accounts**

Individual accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan, which includes an individual brokerage account that allows participant-directed investments in individual stocks and mutual funds. Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Investment income is allocated to participants based upon relative balances of the individual accounts at the prior valuation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeitures**

Upon termination of employment, participants forfeit their nonvested balances. The Plan may use forfeitures to reduce Sponsor contributions or to pay Plan expenses. There was no forfeiture balance as of December 31, 2024 or 2023.

**Vesting**

Participants are 100% vested in employee and safe harbor matching contributions and earnings on their contributions. Effective March 24, 2023, participants vest immediately in discretionary matching and nonelective Company contributions. Prior to March 24, 2023, participants vested 100% after completion of one year of service, as defined by the Plan, in discretionary matching and nonelective Company contributions.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their vested account amounts not to exceed the lesser of 50% of the participant's balance or \$50,000. The maximum term of such loans is five years, except for a loan for the purchase of a primary residence, which has a ten-year maximum term. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time the funds are borrowed. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Generally, a participant's vested account balance is payable as a lump-sum distribution, between ages 59½ and 73, upon his or her retirement or disability. Upon termination of employment, the vested portion of the participant's account may be withdrawn in a lump sum or left in the Plan. If the vested amount is \$1,000 or less, a lump-sum distribution is required.

**Administrative Expenses**

The Company provides or pays for certain accounting, legal, administrative and management services without charge to the Plan. Expenses paid by the Company are not included in these financial statements. Fees related to the administration of notes receivable from participants and certain fees related to distributions are charged directly to participants' accounts and are included in administration expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates and Risks and Uncertainties**

The preparation of financial statements in conformity with GAAP, requires Plan management to make estimates and assumptions that may affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's retirement committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized gains and losses on investments.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

## **3. FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Common stock (held in self-directed brokerage accounts (SDBA)):* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust (CCT) fund:* Valued at NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Interest-bearing cash (held in SDBA):* Valued at cost, which approximates fair value.

*Government bonds (held in SDBA):* Valued by independent pricing services using models or other valuation methodologies. The models are primarily industry-standard models that consider various inputs, which are observable or derived from observable information in the marketplace.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

#### **5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of registered investment companies managed by an affiliate of the trustee and, therefore, these transactions qualify as party-in-interest transactions. In 2024, the Plan paid recordkeeping fees to the recordkeeper. This expense is reflected in administrative expenses within the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**6. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan. The Plan terminates if the Company is dissolved, adjudicated bankrupt or insolvent, or is merged with another company, except that any successor may elect to continue this Plan.

Upon termination of the Plan or permanent discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants will become fully vested. After payment of all properly chargeable expenses, the Plan's assets are distributable to the participants in accordance with the value of their accounts.

**7. TAX STATUS**

The Company adopted a Fidelity-sponsored prototype plan. The underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.
