## INDEPENDENT AUDITORS' REPORT

To the Participants and Trustees of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. DESCRIPTION OF THE PLAN

The following description of the ITility, LLC Safe Harbor 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, which was established by ITility, LLC (“the Company”) effective January 1, 2010. The Plan covers all eligible employees of the Company excluding leased employees, non-resident aliens, and employees whose employment is governed by a collective bargaining agreement under which retirement benefits are the subject of good faith bargaining, as defined by the Plan. Employees are allowed to enter the Plan on the first day of the month coinciding with or the next following the date all eligibility requirements have been attained. Employees are eligible to contribute to the Plan after attaining three consecutive months of service and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective January 1, 2021 through a retroactive amendment (Note 7).

#### **Participant Contributions**

Participants may contribute up to 100% of their eligible annual compensation, as defined by the Plan, on a pre-tax basis, not to exceed the maximum allowable contributions under the Internal Revenue Code (“the Code”), which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants are permitted to make rollover contributions to the Plan.

#### **Company Contributions**

The Company makes safe harbor matching contributions on a per payroll basis equal to 100% of salary deferrals not to exceed 4% of each participant’s eligible compensation. All employees who are eligible to participate and make elective deferrals to the Plan are eligible to receive Company contributions. Company matching contributions totaled \$449,946 for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant’s account is participant-directed and is credited with the participant’s contributions and Company contributions in accordance with the investment options selected by the participant. Plan earnings, losses, and administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Notes Receivable from Participants**

Participants may borrow up to 50% of their vested account balances, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000 and only one note may be outstanding at a given time. The notes are collateralized by a participant’s vested account balance. Note repayments are to be made through payroll deductions each pay period with interest based on the Prime Rate (as specified in the Wall Street Journal) offered by financial institutions as of the date of the loan plus two percent. The period of repayment may not exceed five years, except for notes used for the purpose of purchasing a principal residence. Notes for the purchase of a primary residence are to be repaid within thirty years.

**Vesting**

Participants are immediately 100% vested in their salary deferrals including catch-up contributions, Company safe harbor matching contributions, and rollover contributions, and earnings thereon.

**Payment of Benefits**

Upon termination of service, death, disability, normal retirement (age 65), or attainment of age 59 ½, a participant, or his or her beneficiary in the event of death, is entitled to a distribution of his or her account balance. Distributions from the Plan are payable in the form of lump sum payments or partial payments. Prior to retirement, distributions from the Plan are payable in the form of a lump sum payment. Upon termination, if a participant’s account balance is less than \$5,000, the Plan may elect to automatically distribute the participant’s account balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant on a pre-tax basis and rollover contributions may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½. There were no net assets of the Plan allocated to the accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023.

**Plan Expenses**

Expenses incurred in the administration of the Plan are required to be paid by the Custodian with assets of the Plan unless the Company, at its discretion, elects to pay them. During the year ended December 31, 2024, the Company paid a portion of direct expenses related to the Plan’s operations. The Plan paid direct expenses totaling \$41,137 during the year ended December 31, 2024. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared using the accrual method of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur in the near term that materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

#### **Fair Value Measurement**

Accounting Standards Codification 820, *Fair Value Measurement* (ASC 820), defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets’ or liabilities’ fair value measurement levels within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interest bearing cash:* Valued at amortized cost plus accrued interest, which approximates fair value.

*Interests in registered investment companies:* Valued at the closing price reported in the active markets in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

The Plan evaluated for disclosure any subsequent events through September 24, 2025, the date the financial statements were available to be issued and determined that there were no material events that warrant disclosure.

### 3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedules including assets held as of December 31, 2024 and 2023, interest and dividend income and net appreciation in the fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company, the Custodian of the Plan.

### 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions to the Plan would cease.

### 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus Trust Company, the Custodian of the Plan. The Plan allows participants to take loans from their accounts according to the applicable provisions of the Plan document. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 6. INCOME TAX STATUS

The pre-approved plan document, upon which the Plan was designed, received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan was amended subsequent to the opinion letter; however, the Plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business taxable income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open tax periods.

**7. OTHER MATTERS**

Subsequent to December 31, 2019, it was discovered that the Plan document used a definition of compensation for purposes of calculating employee deferrals and Company matching contributions that was not the same as how the Company was facilitating the payroll.

Management of the Company, as well as ERISA counsel, confirmed the definition of compensation in the Plan document was in error. Accordingly, the ERISA attorney filed a retroactive amendment to the Plan with the Internal Revenue Service (IRS) under the Voluntary Correction Program (VCP) on March 22, 2022 to correct the error pursuant to IRS guidance regarding the Employee Plans Compliance Resolution System (EPCRS). The IRS responded to the Voluntary correction program filed on March 22, 2022 on November 30, 2023 and determined more information was needed.

The IRS requested additional information in the form of documentation that will establish employer intent and employee expectation as well as participants' missed earnings and the methodology used for determining the earnings. The ERISA attorney responded to the IRS on January 11, 2024 with the requested information. The IRS responded back to the ERISA attorney on January 24, 2024 with a signed Model VCP Compliance Statement, noting they are in agreement with corrective actions and changes to administrative procedures described in the statements initially provided. Therefore, this matter has been concluded requiring no additional corrective action.

**8. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2024, the Company withheld participant deferrals totaling \$4,399, that were not remitted to the Trustee in a timely manner. The Company has made the necessary corrections for deferrals and lost earnings during 2025.
